Subject: Pendulum Record article – Annylog Estate

My worst fears that the problems at Annylog might turn into a public relations disaster were realised yesterday. Last night's Pendulum Record carried a full page article attacking PCH's record since taking control over the Annylog Estate. The tone of the article was extremely critical, and calls for dismissals. All aspects of the problems at Annylog are now attracting widespread hostile comment in the local media. I have had to agree to appear on local television at short notice this afternoon to respond to the allegations made in the Pendulum Record article (attached).

As I feel very much on the spot, I need a clear and succinct summary of the position, telling me what to say so that I can refute or defuse the allegations made in the Pendulum Record article. Clarity is at a premium, as I will need to be able to access information very quickly. The briefing note must be readily accessible, as the television broadcast will be transmitted live.

I feel that G. Emtee is the person with the most knowledge of all the aspects of what has been happening at Annylog, and so would be the best person to draft the briefing note at this short notice.

Blundering Housing Bosses Face Axe Over Annylog Estate Fiasco

Red-faced bosses at Pendulum Community Homes (PCH) who have presided over the Annylog Estate fiasco face the axe.

Angry Ministers intend to send in a **Government hit squad** to probe the **blundering mismanagement of Annylog Estate** since the hapless PCH took control in 2000. Mounting concern over a series of scandals that have rocked the high crime Annylog Estate since PCH took control triggered the Ministry probe in January 2002. Concerned local resident Jack Strap stormed "It's been downhill all the way since those comedians at PCH took over".

- □ The Estate suddenly needed £25 million of repairs that PCH will pass on to tenants in higher rents.
- □ The contractor PCH picked to do the repairs has gone **bust**, leaving **1,100 tenants living in uninhabitable halffinished properties**. "The work that PCH have done is rubbish – windows and doors that won't shut and plumbing that doesn't work" fumed Independent Tenants Group Chairman Jack Strap. "Sorting out this mess will cost a fortune and add a further £5 a week onto rents for long-suffering tenants".
- □ Annylog Estate's StreetScene Community Improvement Programme is run by PCH – and has achieved nothing for local residents. All the money given to PCH has been wasted. Jack Strap angrily complained "They are only interested in rewarding young tearaways for making our life a misery. What about the silent long-suffering majority of older people on this estate? We pay our

taxes and sky high rents, and what do they do for us? Nothing." The Minister is expected to pull the plug on StreetScene after the January 2002 inspection and spend its budget elsewhere. Worried tenants don't see why they should suffer because of PCH's blunders when there is so much that needs to be put right.

Police are investigating the bankrupt PCH-run tenants association after reports of illegal loans to managers, tax fiddles and the use of public money to pay for personal spending by association bosses.

The Minister has the power to sack the PCH board. **The Record says the sooner the better**. Long-suffering Annylog tenants deserve better. Now.
