Subject: Meeting with Mooring Holders Association representatives

I have received a letter from the Secretary of the Port Shanty Mooring Holders Association, which I attach for your information. I have agreed to meet a deputation of their members to discuss their concerns at the end of my ward surgery this lunchtime. This will be at about 1.10 p.m. today. Although I am nominally a member of the JMC, I have unfortunately never been able to attend any of the JMC meetings and I know very little about the JMC and what it does. At this short notice, the County Treasurer has indicated that you are the person in the best position to supply me with the information that I will need to respond to their complaints and allegations.

I need a concise briefing note providing me with an aide memoire in respect of the following matters:

- Brief background on the arrangements for the management of the River Shanty and the relationship between the County Council and the JMC;
- An analysis of the past charging policies of the JMC and the impact of the increase in the cost of the riverbed lease;
- An analysis of the profile of river users and an assessment of whether local users are being priced off the river by increases in charges;
- A discussion of the validity of the allegations of financial mismanagement and waste.

Please ensure that your briefing note gives me a clear indication of how I should respond to the issues raised by the letter. I must appear well prepared and be well prepared for what may well be a difficult encounter.

Dear Cllr. Admiral,

Enough is enough.

I am writing in my capacity as Secretary of the Port Shanty Mooring Holders Association. All the members of the Association are sick and tired of the scandalous mismanagement of Port Shanty by the County Council. We have had enough. As a Shantytown County Councillor (and as you are one of the County Council stooges on the sub-committee that presides over this shambles) we expect you to explain yourself and commit yourself to being part of the solution instead of being part of the problem.

For years the harbour dues and mooring rentals have risen well above the rate of inflation. We hear rumours that you intend to implement yet another round of huge increases in charges in 2004. Remember that boating ought not to be solely the preserve of the rich. It is no wonder that the number of void moorings increases year by year. The effect of your excessive increases has been to drive local river users — many of them pensioners who are on fixed incomes — off the river in droves. People of modest means from places like Shantytown simply cannot afford constantly rising mooring rentals and harbour dues. If this continues, the river will end up as a ghost river — with only rich city types able to keep boats. It will be too busy at weekends and dead during the week. You may be quite happy for the river to be the preserve of rich people from outside the area, as I suppose these are exactly the sort of high spenders that the powers-that-be want to attract to the area.

What do we get for our money? Very little. The physical condition of the river continues to deteriorate as you starve Port Shanty of investment to subsidise the County Council's school building programme. Most of the piles are rotting away and the sea channel becomes narrower and shallower by the month. Haven't you ever heard of dredging? It is obvious where your priorities lie. The Harbour Master clearly has a free rein to take on lots of unnecessary staff over the summer, which has led to horrendous overspending on the budget. So has suspending the Berthing Master on full pay for months as a prelude to dismissing him for no good reason. I suppose you people at County Hall are not bothered about all this waste as it costs you nothing - any overspend on the river just means you push up the charges to river users even more. These charges have risen way above inflation for the last four years — this is unacceptable and is solely down to utter incompetence and the County Council's policy of fleecing river users to disguise its own financial mismanagement. In this context, the Association also protests most strongly at the removal of the County Council's annual subsidy to the river that the County's Cabinet has arbitrarily axed. The River Shanty should be Tanka's premier yacht haven and deserves more funding, not less.
