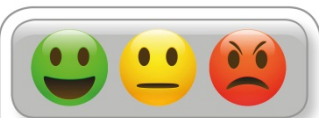

Unit 1 series overview

General comments on the paper

Learners taking the CBT assessment for this unit in January performed reasonably well. The mean was lower than in the two 2019 series, but higher than the two in 2018. As stated in previous reports, centres would be advised to focus not only on the knowledge requirements across the five learning outcomes for this unit but also ensure learners are familiar with the different assessment styles used in this summative assessment – i.e. linking boxes, true/false, diagram-related questions and select 'three'. Learning outcomes 2 and 4 had strong answers this series.

Learning outcome 1

This LO covers knowledge of hardware components and performance was generally strong. LO1 is one of the weightier LOs within the unit and as a result centres should spend more time with their learners developing knowledge around types of computer systems, networks, connectivity methods, topologies, network protocols, computer components, devices and fault diagnosis. Almost all candidates were able to identify a USB stick and identify input, output and storage devices. Candidates found it more difficult to match network components such as hubs, switches and routers to their definitions.

Learning outcome 2

Performance on this LO was very good overall; particularly given this is the heaviest weighted LO within the unit. Learners again seemed more prepared for software-based questions rather than questions that had more of a hardware focus. Candidates only found one question more challenging, which asked them to identify the relevant operating system which is commonly used for open source software.

Learning outcome 3

The focus of LO3 builds on LO1 and LO2 and requires learners to demonstrate knowledge of how to install and upgrade hardware and software. Performance was mixed this series. Hardly any candidates managed to put the steps of an installation plan into the correct order and found it difficult to identify organisational responsibilities regarding health and safety. On the positive side, almost all candidates identified the reason for having a backup plan when installing or upgrading software and also did well regarding the use of an anti-static mat.

Learning outcome 4

Performance on this LO was very strong as usual, with learners demonstrating a good level of knowledge of social media and security. Particularly strong performances were seen in questions about benefits of purchasing insurance online, examples of social media sites, functions of fitness trackers, applications used in emerging technology and uses of the Internet. The only slightly weaker responses were for activities that are enabled by cloud storage.

Learning outcome 5

This LO carries the lowest weighting in the unit and performance of candidates was strong. The LO is holistic in nature and draws together the learning from the unit to reflect on the practical uses of IT within business. Candidates did very well on identifying the type of software which would be most useful for a design student to help with their work. The lowest outcomes were for a question on which type of software application would be best suited for a sales manager to access stock levels.

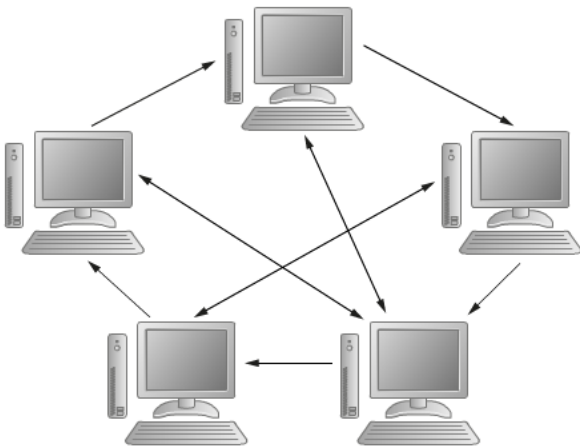

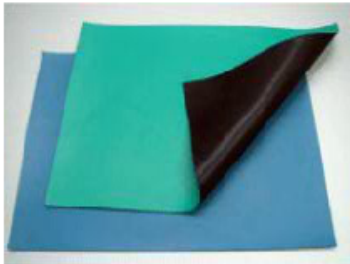

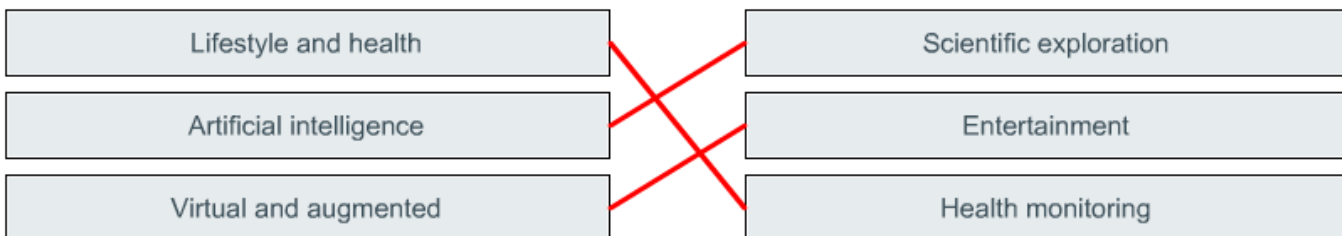

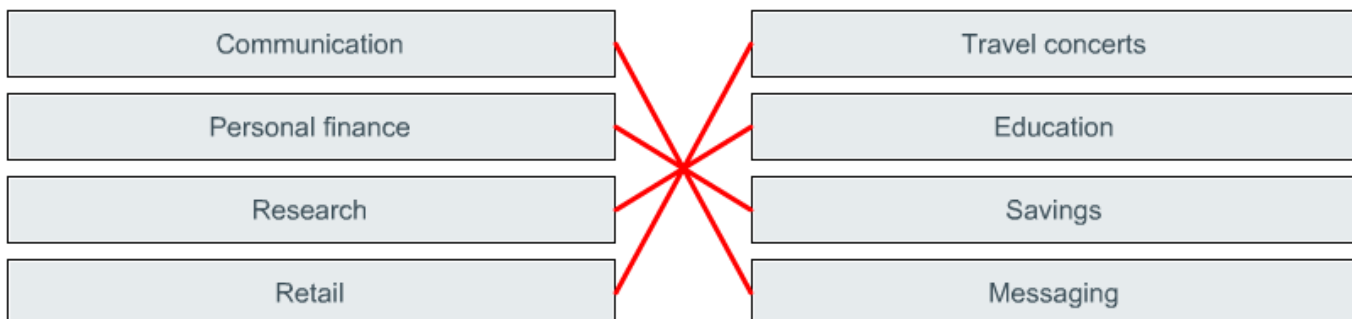

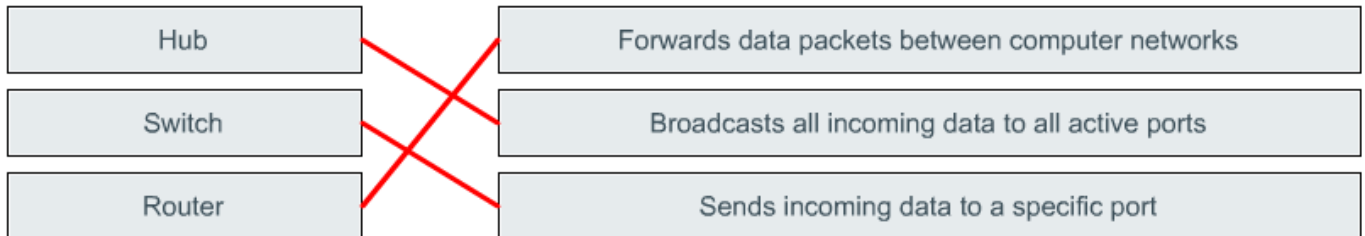
