Introduction

THE DANTES SUBJECT STANDARDIZED TESTS

Many adults have acquired the knowledge taught in college-level courses through reading, independent self-study, correspondence courses, on-the-job experience, or just through living. To earn college credit for knowledge acquired by nontraditional means, you can take one or more DANTES Subject Standardized Tests (DSSTs).

WHAT ARE THE DSSTs?

The DSSTs are examinations offered by The Chauncey Group International, a subsidiary of Educational Testing Service. DSSTs are used by colleges and universities and the U.S. Department of Defense. More than 1,400 colleges and universities nationwide use scores on the DSSTs to award credit for more than thirty-five courses in business, the humanities, social science, mathematics, physical science, and applied technology. A complete list of DSSTs appears on page 3.

The DSSTs are similar to the final exams given in many college courses. Most of the DSSTs consist entirely of questions in multiplechoice format. Some of the tests have other types of questions, such as yes/no questions or essays. To pass the public speaking exam, you have to give a speech as well as take a multiple-choice test.

THE BENEFITS OF TAKING DSSTS

Low-cost college credit is the main benefit of taking DSSTs. Passing a DSST exam is a convenient, relatively fast, and inexpensive way of earning college credit. Earning credit through DSSTs can help you

• gain admission to a college program,

- shorten the amount of time it takes to get a degree, or
- fill in any gaps in your course requirements.

Using the DSSTs to earn college credit is particularly attractive for people who don't want to take time off the job to take college courses. The money you save on tuition for lower-level courses can be spent on enrollment in upper-level courses.

THE COST OF TAKING DSSTS

The fee to take a DSST is \$35 per exam plus any administrative costs incurred by the administering institution. The DSSTs are administered year-round by colleges and universities throughout the United States and overseas.

FURTHER INFORMATION

OVERVIEW OF TESTS COVERED IN THIS BOOK

BUSINESS COURSES

Principles of Financial Accounting

This exam tests knowledge of accounting principles, the accounting equation, transaction analysis, and financial statements. It contains 73 multiple-choice items, and the American Council on Education recommends that credit be awarded for a minimum scaled score of 49. Since about 40 percent of the questions require that you solve specific accounting problems, your knowledge of accounting needs to be fairly detailed.

Human Resource Management

This exam covers the basic management, employment, and legal issues relating to human resource management (personnel management). It consists of 99–100 multiple-choice items, depending on the form taken; credit is recommended for students who achieve a scaled score of 46. The emphasis is on basic terms, facts, and concepts.

Organizational Behavior

This exam covers the field of organizational behavior, including its history and research approaches; the role that individuals and groups play in organizations; and organizations as a whole. Its multiple-choice questions focus on basic facts, terms, principles, and concepts. Credit is recommended for a scaled score of 48.

Principles of Supervision

This exam tests knowledge of the supervisor's role in an organization, including the supervisor's responsibility to carry out the five basic management functions. It contains 85–86 multiple-choice items, depending on the form taken, and credit is recommended for those who achieve a scaled score of 46. More than half of the questions test knowledge of concepts and principles.

Introduction to Business

This test covers the introductory business course, which includes types of economic systems, types of business ownership, and basic business functions like production and marketing. It contains 100 multiple-choice items, and credit is recommended for a scaled score of 46. Most of the questions focus on basic facts, terms, principles, and concepts.

Personal Finance

This exam tests knowledge of basic financial matters relevant to individuals and households: financial goals and budgets, credit, consumer information, housing, taxes, insurance, investments, and retirement. It contains 98 items, and credit is recommended for a scaled score of 46. About one fifth of the items involve specific personal finance problems; the remainder focus on terms, facts, concepts, and principles.

Business Mathematics

This exam covers basic algebra, statistics, and business applications of mathematics. It contains 54–59 multiple-choice items, depending on the form taken, and credit is recommended for a scaled score of 48. Many of the items involve solving math problems.

HUMANITIES Ethics in America

This exam tests knowledge of the Western ethical tradition and the ability to apply moral reasoning to specific situations. Unlike the other exams covered in this book, the Ethics in America exam includes yes/no questions and an essay question in addition to multiple-choice items. It contains 110–111 multiple-choice items, depending on the form taken, and an optional essay. The essay question requires you to analyze a moral problem, propose alternate solutions backed up by moral reasoning, and come to a conclusion about the right course of action. Credit is recommended for a scaled score of 46 on the multiple-choice section. The essay is not scored by the Chauncey Group but is forwarded to your college or university for grading.

PREPARING FOR A DSST

There are a number of things you can do to ensure success in taking a DSST and receiving credit.

CHECKING WITH YOUR SCHOOL

Before you register for an exam or start any other preparations, you should check with your college or university to make sure that it recognizes the DSST program and awards credit for passing scores.

If you have already enrolled, your academic adviser can help you find out any relevant information. If you are applying, or just thinking of applying, check with the admissions office for help.

GETTING THE EXAM FACT SHEET

The Chauncey Group International publishes a Fact Sheet for each exam. The Fact Sheet describes the exam and its scoring, outlines the course content that will be tested, provides a list of references for studying, and gives a sample of test items and answers for practice.

Fact Sheets for the eight courses covered here are included in the book. Assessing Your Readiness

If you are taking one of the eight exams covered in this book, take the pretest to assess your readiness for taking an exam in the subject. Then use the course summary to refresh your memory about the course contents, and take the remaining practice test and the posttest to thoroughly familiarize yourself with the types of items that will be on the exam.

If you are taking one of the exams that is not covered in this book, use the Fact Sheet as your resource. Review the course outline and take the sample test in the Fact Sheet.

If, after assessing how well you did, you feel you can pass the exam without further preparation, good luck! However, most people will need to do at least some studying.

OBTAINING STUDY MATERIALS

Each Fact Sheet contains a list of textbooks or other resource materials
that can be used to study for an exam. For most courses, any standard
college-level text in the subject is appropriate. Just check that the text's
table of contents covers most of the course content as outlined on the
Fact Sheet. You can check with your school to see which text it uses
for a particular course and buy a copy at the school bookstore or pick
up texts on the subject at the library.

You can also use trade books (books published for the general reader, not specifically for students) to prepare for your exam. However, if the course is one that does have texts written for it, you should use a text rather than a trade book to prepare. Texts are written specifically to teach, and their presentation is generally very clear: important concepts and terms are highlighted, and all the appropriate topics are covered in a logical and methodical way.

STUDYING

It hardly needs to be said that you can improve your score on a DSST exam by studying. These are tests of knowledge, so the more you know the better you will do.

Studying Over a Period of Time

Since the DSSTs are primarily objective tests of recall, it is best to set up a study schedule that allows you to read or skim the course material over several weeks, in one- or two-hour sessions. This will give you time to absorb a lot of information gradually and fix it in your long-term memory.

Doing Practice Problems

If you are taking an exam, such as mathematics or accounting, that will require you to solve problems, you should do practice problems. Most texts have answers in the back so you can check your work. Finally, if there are important formulas, memorize them.

Cramming

Cramming is not an effective way to learn or remember the content of an entire course, so avoid it if you can. However, if you must cram, you should be realistic about how much you can absorb in such a short amount of time. It is impossible to read an entire text in an evening, so you will have to be selective; read the chapter outlines and the end-of-chapter summaries. Study the key terms, which are usually boldfaced and often displayed in the margins of a chapter or collected at the end of the chapter. Then, if you have more time, you can go back and skim the entire text.

TEST-TAKING SKILLS

PREPARING YOURSELF MENTALLY

Thorough preparation is the best antidote for test anxiety. If you have done the practice test(s) and studied the text or other resource material, you will have an excellent idea of what will be covered on the test. In addition, you will be familiar with the types of questions, the directions, and so on. This knowledge should do a lot to alleviate test-related stress.

PREPARING YOURSELF PHYSICALLY

There's a lot you can do to prepare for taking the exam:

- Get a good night's sleep the night before the test.
- Don't drink too many caffeinated beverages that morning. They will only leave you feeling jumpy.
- Dress in layers so you will be prepared for a range of room temperatures.
- Check that you have everything you will need to take the exam: pencils, pens, scratch paper, watch, admission ticket, and proper identification.
- Leave yourself extra time to get to the testing site. It's better to get there 15 to 20 minutes early than just in time or even late.

TAKING THE EXAM General Strategies

Here are some general test-taking strategies that may help improve your score.

- Skim the test first. Before you start answering any questions, quickly look over the entire exam. Note the types and number of items.
- **Read the directions carefully.** Be sure you know exactly what you are expected to do. Must you answer all the questions, or do you have a choice (as in responding to one essay question out of several)? If the test has more than one section, note the relative weight of each section in terms of the score. Be sure you understand how you are expected to mark the answer sheet.

TEST-TAKING SKILLS

- Pace yourself. Figure out how fast you'll have to work. For example, if the exam has 50 items and you have 90 minutes to complete it, you can spend almost 2 minutes per item. Remember to allocate your time according to the value of the questions. So, for example, if an essay is worth one third of the score, don't leave it for the last 5 minutes. If you finish early, don't leave—use the extra time to look over the exam.
- **Don't get bogged down.** If you find you are stuck on a particular item, don't dwell on it. Instead, put a mark beside it and move on. After you have answered all the "easy" questions, you can go back to the ones you have marked and try them again. Just make sure you skip that item on the answer sheet, too, otherwise your answer sheet will be wrong from that item on.
- **Guess.** You are not penalized for wrong answers to multiple choice and other nonessay items on the DSSTs. So guess—don't leave the answer blank.
- **Relax.** If you start to get nervous, stop for a moment. Take a few deep breaths and relax.
- Check the exam. If you have time, go over the exam, making sure the answers are clearly marked. Redo any calculations you made to check their accuracy. However, don't be too quick to change your answers. Often the first answer you choose is the correct one.

Strategies for Multiple-Choice Items

Here are some suggestions for answering multiple-choice questions.

- **Read the question carefully.** Don't make the mistake of concluding that you know what a question is asking after reading just a few words. Read the entire question carefully, making sure you understand it.
- Answer the question before reading the options. After reading the question, does an answer pop into your head even before you read the choices? If so, that answer is probably correct. Look for it when you read the options.
- Eliminate any wrong answers. You have a one in four chance of picking the correct answer to multiple-choice items. Sometimes you can immediately eliminate one or more of the choices as wrong, increasing the odds of picking the right answer to one out of three or one out of two.
- Guess when you draw a blank. If you haven't a single clue about the answer to a question, you can use some "insider" tips on guessing the answer:
 - If one option is longer than the others, it is often correct.
 - If the words *always* or *never* are in an option, it is probably incorrect.
 - If the options consist of a range of numbers, a number in the middle is often the right answer.
 - If two quantities are very close, one of them is probably right.

Strategies for Essay Questions

Essay questions test not only your recall of facts and concepts, but also your ability to select, interpret, and/or apply them. Because essays are fairly complex, there is no one right answer to an essay question. Here are some suggestions for improving your ability to write an essay:

• **Read the directions.** Make sure you know how many essay questions you will need to respond to. You are usually given a choice. Also be sure to allocate your time properly; if an essay question is worth one quarter of the test score, you should plan on spending about one quarter of your time on it.

TEST-TAKING SKILLS

- **Read the essay questions carefully.** Before you choose the question you will answer, read them all carefully. Once you've chosen your question, make sure you thoroughly understand it. Sometimes a question is presented in several parts, each of which you must address.
- Think before you write. Your essay will make more sense if you think about what you want to say before you begin writing. You may find it easier to organize your thoughts if you jot down a list of key points or outline your response. Be sure you have covered all the points asked for in the question.
- Write your answer. Write your response in well-developed paragraphs. Each paragraph should have a topic sentence that states the main idea and explanations, examples, or descriptions that support the topic sentence. Don't wander off the topic, and don't pad your answer with irrelevant material.
- Check your grammar and spelling. Make every effort to use correct grammar and spelling. Mistakes in grammar and spelling create a poor impression on the person scoring the essay, even if you have written an otherwise excellent answer.
- Check that you have answered the question. After you are done, reread the question to make sure you have addressed all the issues you are asked to cover.



GENERAL OVERVIEW

NUMBER SENSE

PLACE VALUE

The **decimal system** of numbers uses ten digits—0, 1, 2, 3, 4, 5, 6, 7, 8, and 9—to represent all numbers. The value assigned to a digit in a particular number depends on its position in the number, called its **place value**. Numbers to the left of the decimal point are whole numbers, and numbers to the right of the decimal point represent parts of a whole (amounts less than 1).



PERCENTS

A percent represents a part of a whole, just like fractions and decimals. Percents are hundredths, or parts of a hundred. One percent means "1 of 100 equal parts," or 1/100, or .01. It is written 1%.

Problems using percents have three main quantities:

- **Base**—The whole or total amount, the amount to which something is being compared
- Rate—The percent
- Portion—The result of multiplying the base and the rate

THE PERCENT FORMULA

The basic percent formula is

Portion (P) = Base $(B) \times \text{Rate} (R)$

So, for example, to find the amount of sales tax (portion) owed on a \$5,000 used car (base) if the sales tax was 5% (rate), the formula would be used as follows:

Portion = $$5,000 \times 5\%$ or Portion = $$5,000 \times .05$ Portion = \$250, the amount of sales tax

BUSINESS MATHEMATICS

Is the Answer Reasonable?

It is easy to make errors when math problems are solved or arithmetic is performed, even when using a calculator.

One type of error is to misinterpret a word problem, and thus come up with the wrong answer. When a word problem is solved, the answer should be checked against the problem to see if it makes sense. If it does not, one possible source of error is that the wrong **operation** was used: division instead of multiplication or addition instead of subtraction. The problem can be redone using the opposite operation to see if the resulting answer makes more sense.

Another type of error is arithmetic—making a calculation mistake when adding, subtracting, multiplying, dividing, or making a data entry mistake when using a calculator. To check an answer when doing a calculation, the approximate answer can be estimated, or guessed, by rounding the numbers and performing the operation on them. If the estimate is close to the answer, the answer is probably correct. Another way to check an answer when using a calculator is to perform the calculation twice.

ALGEBRA

An **equation** is a mathematical statement indicating that two expressions are equal. For example, in the equation

x + 7 = 10

the expressions x + 7 and 10 are equal. The letter x is called a **variable**, a letter that represents a number.

Solving an Equation

Since the two expressions of an equation are equal, as long as both sides of an equation are changed in the same way, the resulting expressions will still be equal. There are two basic rules for solving an equation:

- Addition rule—The same number may be added or subtracted on both sides of the equation.
- **Multiplication rule**—The same number, other than zero, may be multiplied or divided on both sides of the equation.

Thus, to solve the equation x + 7 = 10, the number 7 can be subtracted from each side:


x + 7 = 10x + 7 - 7 = 10 - 7x = 3

Linear Equations

A **linear equation,** like the one shown above, is one in which the variables are raised to the first power (x^1) , even though that is not stated. The basic form is

ax + by = c

where *a*, *b*, and *c* are real numbers and *a* and *b* cannot both equal zero. Equations are *not* linear if they contain a term with exponents other than one (x^2) or a term involving the product of two variables (xy). A linear equation with two variables, when graphed, is a straight line. To graph a linear equation, two pairs of values for *x* and *y* that satisfy the equation must first be found. These points are plotted on a graph, and a line is drawn connecting them. All points on the line represent solutions to the equation. Thus, a single linear equation has an infinite number of solutions.



A set of two or more linear equations that are to be considered together is called a system of **simultaneous linear equations**. To solve a system of linear equations, the solution that satisfies all the equations is found. In a system of two linear equations with two variables, the solution is a number pair. One way to find the solution is to graph each equation on the same graph. The point where the two lines intersect is the solution.

Inequalities

An **inequality** expresses the condition that two quantities are not equal. The symbols > (greater than) and < (less than) are used:


- 19 > 7 "9 is greater than 7"
- x < 31 "the value of x is less than 31"
- 1 < y < 5 "the value of y is greater than 1 and less than 5"

Quadratic Equations

A **quadratic equation** is an equation that, when written in its simplest form, contains a variable to the second power (x^2) . It may also contain the variable to the first power (x) and/or a constant (a real number). The basic form is

$$ax^2 + bx + c = 0$$

where *a*, *b*, and *c* represent real numbers, and *a* cannot equal 0. When a quadratic equation is graphed, the solution is a parabola, a smooth cup-shaped curve.



Functions

A **function** is a rule that assigns to each input value one output value. For example, in the equation $y = x^2 - 2x + 1$, if selected values of *x* are input, the equation yields corresponding values of *y* as outputs:

If
$$x = 1$$
 $y = (1)^2 - 2(1) + 1 = 0$ If $x = -4$ $y = (-4)^2 - 2(-4) + 1 = 25$ If $x = 10$ $y = (10)^2 - 2(10) + 1 = 81$

The **domain** of a function is the set of all possible input values, and the **range** is the set of all possible output values. A functional relationship is shown by the equation

$$y = (x)$$

which means that y is a function of x. In other words, the value of y depends upon the value of x.

STATISTICS

Statistics are numeric data that describe events in government, business, economics, and any other field in which data can be quantified.

Measures of Central Tendency

When a set of raw data must be analyzed, one way to make sense of the data is to find a **measure of central tendency**. There are three basic measures of central tendency: the mean, the median, and the mode; and another measure, the weighted mean.

Mean

The **mean** is the sum of the values divided by the number of values; it is also commonly known as the average. For example, suppose Marge Byers, a consultant, worked on seven client projects last year, valued at \$4,500, \$10,000, \$2,700, \$17,725, \$1,300, \$12,000, and \$5,150. The mean value of one of Byers's projects is

 $\frac{\$4,500 + \$10,000 + \$2,700 + \$17,725 + \$1,300 + \$12,000 + \$5,150}{7}$

or \$53,375 (the sum of all the projects) divided by 7 (the number of projects). The mean value is \$7,625.

Weighted Mean

The **weighted mean**, or **weighted average**, is used when some of the items in a data set occur more than once. Each value is then calculated by multiplying it by the number of times it occurs. A student's grade point average is a weighted mean.

	No. of		Grade × No.

In this case, the weighted sum is 37, which is divided by the number of credits, 14. The student's grade point average, to the nearest tenth, is 2.6. Note that if the mean had been calculated, the student's average would have been 2.8 (the sum of the grades divided by 4).

Median	
	The median divides a group of numbers in half. Half the numbers are at or above the median, and half are at or below the median. The first step in finding the median is to arrange the group of numbers in numeric order, smallest first. For example, the list of numbers 12, 14, 17, 8, 7, 5, and 9 would be written as
	5, 7, 8, 9, 12, 14, 17
	If there is an odd number of numbers, the number of numbers is divided by 2. The next higher whole number is the median. So in the example above, 7 numbers is divided by 2, giving 3.5. Rounding up to the next whole number gives 4. Therefore the fourth number, 9, is the median.
	If there is an even number of numbers, divide by 2. The mean of that number and the next higher number is the median.
Mode	
	The mode is the number that occurs most often in a data set. For example, in one calendar year ten employees retire. Their ages are
	65, 62, 61, 70, 66, 65, 67, 67, 69, 67
	The mode of the retirees' ages is 67, the age that appears most often.
Percentiles	
	A percentile is an indication of the relative position of a single score in a group of scores. For example, suppose a student took the Scholastic Aptitude Test (SAT) and scored 1100. If 88 percent of her peers scored 1100 or lower, her percentile rank would be 88. That also means that 12 percent of her peers did better than she did, scoring above 1100. The percentile scale, based on percents, has 100 units. Some points on the scale have special names. The first quartile is the 25 th percentile, the second quartile (also equal to the median) is the 50 th percentile, and the third quartile is the 75 th percentile.


Frequency Distributions and Graphs

Numeric data is often displayed visually for ease of comprehension and greater impact. There are several types of visual displays:

• A **frequency distribution table** shows how many times various numbers occur; for example, the number of weeks that a particular number of widgets was produced during the course of a year.


• A **bar graph** shows frequency data by means of the heights of the bars.



• A **line graph** shows trends over time; for example, widget sales over the last five years.



• A circle graph shows parts of a whole; for example, the portion of total sales that widget sales represent.



Visual displays of information can sometimes misrepresent data. This may occur through omission of data, by focusing only on a portion of the data, or by emphasizing unimportant data at the expense of important data.

BUSINESS APPLICATIONS

SIMPLE INTEREST

Interest is money paid for the use of money. **Simple interest** is calculated only on the **principal**, or original amount borrowed or loaned. The principal plus interest is the **maturity value**. The simple interest formula is

Interest (I) = Principal (P) \times Rate (R) \times Time (T)

Note that in this formula, time is assumed to be in years. Thus, if a time period is given in months or days, it must be converted to a fraction of a year before being used in the formula as *T*. Suppose, for example, Jim Medeiros borrows \$40,000 to buy equipment. He pays 8% annual interest for 6 months, when he must repay the principal plus interest (the maturity value).

 $I = 40,000 (P) \times .08 (R) \times \frac{6}{12} (T)$ I = \$1,600MV = \$40,000 (P) + \$1,600 (I) = \$41,600

Compound interest is discussed on page 000.

PROMISSORY NOTES

A lender usually requires a borrower to sign a **promissory note**, which states that the borrower will repay a certain sum at a fixed time in the future. The note may also state the interest rate.

GENERAL OVERVIEW

The total amount due at the end of the loan is the maturity value—the sum of the face value and interest. When the issuer deducts the loan interest in advance, the note is a **simple discount note**, also called a **noninterest-bearing note**.

DISCOUNTING A NOTE

When the issuer of a promissory note needs cash, it can sell the note in advance of its maturity to a bank. The bank charges for this service, taking a **bank discount**. The amount the issuer actually receives is the **proceeds** of the note.

INSTALLMENT PURCHASES

In an **installment purchase**, the buyer makes a down payment and pays off the balance plus a **finance charge**, which includes interest, in regular periodic payments.

Finance charge = Total of all monthly payments - Amount financed

The finance charge is often expressed as an **annual percentage rate** (**APR**), the true effective annual interest charge. The APR can be calculated by formulas or by using APR tables.

The **U.S. rule** states that any partial loan payment covers any interest that has accrued. The remainder of the payment reduces the loan principal. A variation of the U.S. Rule is the **Rule of 78**, which charges a larger portion of the finance charges to the earlier payments. These rules are applied in calculating the rebate amount of the finance charge and the payoff when the loan is repaid before it is due. (See page 240 for more on installment loans.)

DISCOUNTS AND CREDIT TERMS

Trade Discount	
	A trade discount is the amount a retailer receives off the list price when buying from a manufacturer or wholesaler:
	Trade discount amount = List price x Trade discount rate
Cash Discount	
	Sellers may also offer a cash discount , a reduction from the invoice price if buyers pay the invoice within a specified amount of time, called the discount period , usually 30, 60, or 90 days. For example, the cash discount may be 2/10, n/30, which means that the buyer can take 2% off the invoice if it is paid within 10 days; otherwise the net amount is due between day 11 and day 30.

Cash discounts are not taken on freight, returned goods, sales tax, etc. The most common freight terms are **FOB shipping point** (the buyer pays the freight) and **FOB destination** (the seller pays the freight).

MARKUPS AND MARKDOWNS

A seller arrives at the selling price of his goods by adding a markup to the cost of the goods. The **markup** represents the amount needed to cover operating expenses and make a profit. Manufacturers and wholesalers generally calculate markup based on the cost. Retailers usually compute markup based on selling price. Whether cost or selling price is the basis, the same markup formula is used:

Selling price = Cost + Markup

Markdowns are reductions from the original selling price. They may be caused by the perishability of goods, style changes, seasonal changes, and so on.

Markdown percent = $\frac{\text{Markdown amount}}{\text{Original selling price}}$

BREAK-EVEN ANALYSIS

Goods that are marked down may result in a reduced net profit, breaking even, an operating loss, or a gross or absolute loss. The **breakeven point** is the point at which the reduced price just covers cost plus operating expenses.

Breakeven point = Cost + Operating expenses Operating loss = Breakeven point - Reduced selling price Absolute loss = Cost - Reduced selling price

INVENTORY Valuation Methods

At the end of each accounting period, a company's inventory of raw materials and/or goods must be valued. To do this, a company must know the cost of its ending inventory and the cost of goods sold. There are four common methods.

In the specific identification method, (1) the cost of goods available for sale is calculated, (2) the cost of ending inventory is calculated, and (3) the cost of good sold is calculated (Step 1 - Step 2).

GENERAL OVERVIEW

	 In the weighted-average method, (1) the average unit cost is calculated, (2) the cost of ending inventory is calculated, and (3) the cost of goods sold is calculated. In the first-in, first-out (FIFO) method, the first goods that are made or bought are assumed to be the first goods sold. In FIFO, (1) units and their costs to be included in ending inventory are listed; (2) the cost of ending inventory is calculated. The last-in, first-out (LIFO) method is similar to FIFO, except the last goods made or bought are assumed to be the first goods sold. 	
Stock Turnover		
	Stock turnover can be calculated using retail or cost values:	
	Turnover at retail = $\frac{\text{Retail sales}}{\text{Average inventory at retail}}$	
	Turnover at $cost = \frac{Cost of goods sold}{Average inventory at cost}$	
Taxes		
Sales Tax		
	Many cities, counties, and states charge sales tax on the purchase of certain goods and services. When computing sales tax, sellers first subtract trade discounts and cash discounts from the original selling price. The tax is calculated on that amount. Costs of shipping and handling are not taxed.	
PROPERTY TAX		
	All property owners pay property tax on the assessed value of their property. The tax is calculated according to the following formula:	
	Total property tax due = Tax rate \times Total assessed value due	

Depreciation

In accounting, **depreciation** is the amount of an asset's value that is considered an expense of doing business each year. There are three key factors: the original **cost** of the asset, the **estimated useful life** in years, and the **residual value** (salvage or trade-in value). There are several methods for calculating depreciation.

In the straight-line method,

Annual depreciation expense =	Cost – Residual value
Annual depreciation expense -	Estimated useful life in years

In the units of activity method,

Depreciation per unit = $\frac{\text{Cost} - \text{Residual value}}{\text{Estimated units of useful life production}}$

Annual depreciation expense = Unit depreciation \times Units produced

In the **sum-of-the-years'-digits method**, the depreciation rate is based on a fraction in which the numerator is the years of remaining life and the denominator is the sum of the individual years of total life.

Annual depreciation expense = $(Cost - Residual value) \times \frac{Remaining life}{Sum of the Year's digits}$

In the **declining balance method**, the annual depreciation expense declines over the life of the asset because book value, rather than cost, is used.

Payroll

Employees are usually paid weekly, biweekly, semimonthly, or monthly. The calculation of **gross pay** for an employee paid an hourly wage is

Gross pay = Hours of work \times Rate per hour

When an hourly employee works more than 40 hours a week, the hours over 40 are paid at $1\frac{1}{2}$ times the regular rate. For employees paid on a piecework basis, the formula is

Gross pay = Number of units produced \times Rate per unit

The gross pay of employees paid on a commission basis is calculated by multiplying the gross sales by the commission rate, which may vary at different sales levels. Some salespeople are paid a salary plus commission.

GENERAL OVERVIEW

Companies deduct amounts from gross pay to arrive at **net pay**. Examples of deductions include Federal Insurance Contribution Act (FICA) payments (social security and Medicare); federal, state, and local income taxes; insurance; union dues; and pension contributions.

FINANCIAL STATEMENTS

Companies prepare financial statements at the end of each accounting period. There are three main financial statements.

- An **income statement** shows revenues, expenses, and resulting net income or net loss for the period of time.
- The **owner's equity statement** shows changes in the owner's equity for the period of time.
- The **balance sheet** shows the assets, liabilities, and owner's equity of the business on a specific date.

Financial Analysis	
·	The financial statements of a company are used by the company's managers to assess performance and plan for the future. They are also used by investors to judge the company's performance as an invest- ment. There are several basic tools of financial statement analysis.
Horizontal Analysis	
	Horizontal analysis, also called trend analysis, is the comparison of data over a period of time to see what the amount and percentage of increase or decrease has been. For example, horizontal analysis can be used to determine whether sales increased, decreased, or re- mained stagnant over a five-year period.
Vertical Analysis	
	Vertical analysis, also called common size analysis, expresses items in a financial statement in terms of percentages of a base amount. For example, cost of goods sold can be expressed as a percentage of net sales. This makes possible the comparison of companies of differing sizes.

Ratio Analysis

Ratios express mathematical relationships between two amounts as a percentage, a rate, or a proportion. Liquidity ratios measure the short-term ability of a company to pay its current liabilities. Profitability ratios measure the income or operating success of a company over a period of time. Solvency ratios measure a company's ability to survive. There are many of these ratios, the best known of which are the **current ratio**, which is current assets divided by current liabilities; the **profitability ratio**, which is net income divided by net sales; **earnings per share**, which is net income divided by the weighted average of common shares outstanding; and the **price-earnings ratio**, the market price per share of stock divided by earnings per share.

FINANCIAL MATHEMATICS

COMPOUND INTEREST (FUTURE VALUE)

As you recall, simple interest is calculated only on the principal. In **compound interest**, the interest is calculated periodically and added to the principal. For each period, the interest is calculated on the adjusted principal—the principal plus the interest of the previous period. For example, if \$1 is deposited in a savings account with 8% interest compounded annually, at the end of the first year it is worth \$1.08; at the end of the second year, \$1.17; at the end of the third year, \$1.26; and at the end of the fourth year, \$1.36. (If that same \$1 had been deposited in an account paying 8% simple interest, at the end of the fourth year the account balance would have been \$1.32.) With compounding, an amount held today, the **present value**, will yield a greater amount in the future, or its **future value**.

Compound interest can be calculated by using the formulas

$$M = P(1 + i)^n$$
$$I = M - P$$

where M is the compound amount (future value), P is the principal (present value), i is the interest rate per period, n is the number of periods, and I is the total interest amount. A compound interest table can be used instead of formulas. Note that interest may be compounded annually, semiannually, quarterly, monthly, or daily. The more frequently it is compounded, the higher the effective interest rate.

PRESENT VALUE

Sometimes it is necessary to know what an amount in the future is worth today. For example, if a grandfather wanted to have \$60,000 saved for his granddaughter to attend State University in sixteen years, how much would he need to put away now, given 8% interest compounded annually? The answer is the present value, or \$17,513.

To calculate the present value P of the future amount M at compound interest rate of i per period for n periods, use the formula

$$P = \frac{M}{\left(1 + i\right)^n}$$

A present value table can be used instead of the formula.

A series of equal payments made at regular time periods is called an **annuity**. The **value of an annuity** is the value of a series of payments plus interest. Pension installment payments, social security payments, and home mortgages are all annuities. There are two basic types of annuities:

- **Contingent annuities** have no fixed number of payments; for example, paying a monthly pension until death.
- Annuities certain have a specific stated number of payments.

These two types of annuities can be further broken down into:

- Ordinary annuities in which regular payments are made at the end of each period. Therefore no interest is calculated on the amount deposited at the end of a period, only on the balance carried forward from previous periods.
- Annuities due in which regular payments are made at the beginning of each period. Interest is calculated on the current payment as well as the accumulated balance. If all else is equal, an annuity due has a higher final value than an ordinary annuity.

Present Value of an Annuity

The amount of money that must be invested today to generate a stream of payments for a given number of years in the future is the **present value of an annuity**. To find present value, the interest rate, number of periods, and the payment amount must be known; then a present value of an annuity table is needed to look up the table factor. The formula is

Present Value =

Payment \times Factor from Present Value of an Annuity Table

	Note that saving for a college education could be done using a sinking fund rather than investing a lump sum as discussed above. So to accumulate \$60,000 for a granddaughter's education in sixteen years, given an 8 percent interest rate, \$1,980 would have to be invested per year for sixteen years, a total investment of \$31,680.	
Amortization		
	A loan is amortized if both principal and interest are paid off in a series of equal periodic payments. This type of loan is called an installment loan (see page 240). Installment loans are typically used to finance the purchase of cars, boats, and home improvements. The periodic payment that will pay off, or amortize, a loan can be found using the formula	
	Payment = Loan Amount \times Factor from Amortization Table

The correct answer is (B). The solution to a system of equations is the solution that satisfies each equation in the system. A system of two linear equations with two variables has only *one* solution—the point at which the lines intersect. A linear equation, when graphed, is a straight line, so choice (D) can be eliminated right away.

- **3**. Mark Towney is paid a weekly base salary of \$150 plus a piecework rate of \$1 per unit for each unit over 450 that he produces each week. Last week he made 950 units. What was Towney's gross pay?

The correct answer is (D). Each week Towney earns \$150 regardless of his output. To earn more, he must produce more than 450 units in a week. PRACTICE SET ANSWERS

- The correct answer is (D). To find the discount, multiply \$800 by .4 to yield a \$320 discount. Subtract the discount from the list price (\$800 \$320) to get the price that Benson's pays, \$480. Benson's does not pay freight charges because FOB destination is paid by the seller.
- 2. The correct answer is (C). The median is the best measure of central tendency to use when a data set contains one or two extreme numbers because it indicates the midpoint of the data set. Both the mean and the weighted mean would be skewed by the presence of a very large or very small number. A percentile is not a measure of central tendency; it measures relative performance.
- **3.** The correct answer is (B). Because money is invested at the beginning of a period in an annuity due, interest is calculated on the period. In an ordinary annuity, money is invested at the end of the period, so no interest on that amount accrues for the period.
- 4. The correct answer is (B). To convert a fraction to a decimal, the numerator must be divided by the denominator. For example, 1

 $\frac{1}{2}$ equals 1.0 divided by 2, or .5.

5. The correct answer is (B). Annual interest on \$12,000 is \$900

GENERAL OVERVIEW

Philosophy is an activity in which the larger issues, such as the nature of reality, God, and art, are addressed and sound, rational reasons for holding particular views are developed. **Ethics**, also called moral philosophy, is the branch of philosophy that deals with good and evil, right and wrong, and the principles of morality. It seeks to answer two basic questions: How should we live? Why?

ETHICAL TRADITIONS

All cultures have views on ethics. This course focuses on the Western philosophical tradition, which underlies modern approaches to ethics in the United States.

THE ANCIENT GREEKS

Thucydides

Thucydides (460–400 B.C.) was the foremost historian of the ancient world. In his history of the Pelopennesian War between Athens and Sparta, he describes how Athenians dismissed all notions of right and justice in their plan to slaughter or enslave the people of the island of Melos, giving the rulers of Melos the choice of their fate. Although the Melians claim that justice is on their side, the Athenians declare that the strong prevail, the weak submit, and morality is irrelevant. This statement of **"might makes right**" is in contrast with the Greek ideal of the life of virtue, set forth by Socrates, Plato, Aristotle, and other Greek philosophers.

Socrates

According to Socrates (470–399 B.C.), a contemporary of Thucydides, people behave as they do because they are seeking happiness, the ultimate human good. To be happy, however, you must have a healthy, virtuous soul. If you know that a healthy soul is necessary for happiness, then you will understand how to choose virtuous actions that will make you happy.

Acting viciously makes the soul vicious, according to Socrates. Thus, it is far better to suffer an injustice than to inflict one. When you suffer an injustice, only your body is harmed, but when you inflict injustice, your soul is harmed. For example, when Socrates considered whether he should escape from jail, he did not focus on the question of whether or not he had been unjustly imprisoned. That question, in his view, concerned the well being of his body. Instead, he focused on the question of whether escaping, and thus violating the law, would be just, a question that concerns the well being of his soul.

Socrates also believed that people only desire what is good for them or what they *believe* is good. According to Socrates, no one acts contrary to what he or she perceives as good.

Thus, Socrates claimed that **virtue is knowledge**. If no one behaves contrary to what he or she believes is good, then it follows that no one acts viciously except out of ignorance. People who understand that happiness arises from a healthy soul, which results from acting virtuously, want to act ethically because they know it is good for them. Without knowledge, people are not in a position to recognize what is good for their soul and what is not. Thus, wrongdoers need to be taught what is virtuous; they do not need to be punished.

Socrates also believed in the **unity of virtues**. A person who knows that acting virtuously will be to his or her own good will act virtuously in all areas of life—personal, social, military, and religious.

A student of Socrates, Plato (ca. 428-347 B.C.) left a body of work, called dialogues, in which the main speaker is often Socrates. In the *Republic*, Plato goes beyond Socrates' idea that happiness requires a virtuous soul and asks why people should be virtuous. In the course of answering the question "Why be just?", Plato accepts that people often know what is good for them and yet fail to do it.

The *Republic* begins with Socrates asking, "What is justice?" Thrasymachus answers that justice is bad for the person doing the just act but good for someone else—the stronger, who would punish the person if he or she failed to act to benefit the stronger. People simply want to avoid the consequences imposed upon them by the stronger. Thus, people want the appearance of justice, not justice itself. To rebut this view, Socrates must show that justice is desired not simply for its appearance but for its own sake.

Plato

GENERAL OVERVIEW

Socrates first describes the **ideal city**, composed of three classes of citizens: workers who provide goods and services, soldiers who protect the city from attack, and guardians who rule the city. According to Socrates, wisdom is the province of the guardians, courage belongs to the soldiers, and temperance applies to all classes. What is left that makes the city good is justice, the fact that each class of citizens performs its own task. Socrates then moves on to consider justice in the individual. An individual's soul, like the city, has three aspects: the appetite (pure desire), the reason (based on knowledge and logic), and the spirit (naturally allied to reason). Justice in the individual is each part of the soul performing its own task.

The ideal city degenerates in a series of stages until it is ruled by a tyrannical individual, one in whom appetites rule. The tyrannical city is the most unhappy city, just as the individual ruled by appetite is the most unhappy individual. In contrast, the individual in whom each part of the soul performs its own task is the happiest, most just individual. Thus, happiness is not the result of the appearance of justice but of the very nature of justice. Those who are just in this sense will reap numerous rewards and avoid punishment in the afterlife. Justice is therefore desirable for its own sake and for its consequences.

Aristotle

Aristotle (384–322 B.C.) left a large body of work, including views on moral theory, that has been enormously influential in many fields. Aristotle believed that to lead a good life, people have to fulfill their natural goals. In order to do this, they must develop a good character that is manifest in good actions. They must possess a set of virtues— inner dispositions to have the right emotions and to perform the right actions.

Humans share many capacities with animals—perception as well as the need for nutrition, for example—but what distinguishes humans from animals is the ability to reason. Our capacity to reason can be exercised in the pursuit of knowledge and in practical living (ethics). Humans should develop the virtues that lead to rational, practical action. These virtues enable us to respond with the right emotions and the right actions. To fail to respond is a defect, to over-respond is an excess. According to Aristotle, **virtue is a mean** between under- and over-responding. For example, courage is a virtue that is the mean between cowardice, or failure to respond, and recklessness, or over-responding. To determine the appropriate middle course in a given set of circumstances is the task of practical reason.

ETHICS IN AMERICA

According to Aristotle, the **best human life** is the one devoted to actively using reason to understand the principles of science and philosophy without regard to applying them. This life is impossible unless one has first attained moral virtue. Aristotle also believed that moral virtue required early training and the support of good **laws**. Thus, the proper setting for the moral life is the good community, and those who are concerned with making people good should take an active part in the legislative life of the community.

THE BIBLICAL TRADITION

The Bible is not a work of philosophy as defined at the beginning of this chapter. However, it is the oldest and most familiar collection of ethical directives in the Western world. The Ten Commandments, the rest of the Jewish law, and the Christian way of life are deeply ingrained models of ethical behavior, even though the Bible gives little or no rational justification for them.

The Hebrew Bible

In the beginning of the first book of the Hebrew Bible, *Genesis*, Adam and Eve exist in a premoral state of innocence. When they disobey God's command not to eat off of the tree of knowledge of good and evil, Adam immediately understands his guilt and the justice of their punishment.

After Adam and Eve are expelled from the Garden of Eden, sin proliferates and people are powerless to behave properly until God offers a group of them a **covenant**, or contract. He selects Abraham to be the founder of a great and blessed nation, the Israelites; in return, Abraham and his descendants are to obey God. The story of the Israelites continues until Moses leads them out of slavery in Egypt and God renews the covenant on Mount Sinai, giving Moses laws for his people—the **Ten Commandments**. The Ten Commandments are general and abstract rules for good behavior, so God immediately supplements them with detailed, concrete, and fair **laws applying to specific situations**.

As soon as the Israelites cross the Jordan River into the Promised Land, they begin to break the laws. God punishes them with war, exile, and famine and rewards them from time to time with a good king who restores the nation. God also sends them **prophets**, men and women whose role is to remind the Israelites that they are the chosen people of God and therefore they must behave justly and care for one another. If they do not, God will punish them.

GENERAL OVERVIEW

The Christian Bible

The books of the Christian Bible begin with the four **gospels**, which tell the story of Jesus's life, death, and resurrection. Jesus, a Jew brought up in the tradition of the law, emphasizes the internal spiritual aspect of keeping the laws and tells his followers to go beyond just keeping the law by leaving material concerns behind. He takes the ancient law of loving your neighbor as you love yourself and extends it to loving strangers and anyone in need. This idea is a foundation of the modern notion of respecting the rights and autonomy of all individuals.

Although Jesus performed his ministry primarily as a prophet among Jews, after his death his followers decided that their mission was to take his teachings to all nations. The most influential of the early followers of Jesus was Saul of Tarsus, a Jew who took the name Paul after his conversion. Paul founded Christian communities all over the Roman Empire and kept in touch with them through letters, many of which contain ethical instruction.

The Divine Command Theory

According to the Biblical tradition, God gives people laws that they must obey. People are free agents, so they can choose to obey or not to obey. According to the divine command theory of ethics, *morally right* means commanded by God, and *morally wrong* means forbidden by God. There are two interpretations of this theory, both of which lead to problems. (1) Conduct is right simply because God commands it; therefore nothing is inherently good or bad. (2) God commands right conduct because it is right; therefore there is a standard of good and evil independent of God's will. Both interpretations suggest that right and wrong cannot be interpreted in terms of God's will. Although this may seem to be an irreligious conclusion, many theologians agree with it. The dominant theory of ethics in the Christian tradition has not been the divine command theory; rather it has been natural law, which is discussed in the next section.

MORAL LAW

With the decline of the Greek city-states, the ideal city, or *polis*, that had been a central element of Plato and Aristotle's views on ethics no longer existed. Instead, philosophers were left with its underlying moral structure—the law. This development of moral philosophy started with the Greek Stoics.

Epictetus

Compared to the Athenian polis, the world of Epictetus (ca. 55 A.D.-135 A.D.) was disorderly, incorporating war, slavery, and oppression. Epictetus, one of the Stoics, sought to discover how to lead a virtuous, happy life in the midst of uncertainty. He decided that the key was "to do what was in accordance with nature." If people conform to whatever nature sends them, they make the best of things to their ability and take the rest as it comes.

Aquinas

In the *Summa Theologica* of Thomas Aquinas (1225-1274), the natural law tradition, the Biblical tradition, and the philosophical thinking of Aristotle are united. Aquinas, a Dominican monk born in Italy, believed that all things subject to God are ruled to some extent by God's eternal law. Humans, as rational beings, are subject to God's eternal law and have a share of God's eternal reason. The rational human participation in eternal reason is the **natural law**. Through our natural reason, we can discern good and evil. Thus, knowing the difference between right and wrong is not the province of religious people but a faculty of all people. It is our duty to think through the reasons for and against various courses of conduct and to choose the action that seems most reasonable. According to Aquinas, "Conscience is the dictate of reason . . . he who acts against his conscience always sins."

Aquinas indicated that several precepts arise from the foundation of natural law. First, humans have an inclination to good in accordance with the preservation of human life. Second, humans have in common with other animals certain specific inclinations, such as sexual intercourse and education of offspring. Third, humans have an inclination to good, according to the nature of reason, and want to know the truth about God and live in society with others.

Although people have a natural aptitude for virtue, it must be perfected by training. For some people, the training they receive from their families is sufficient. But others, who are more prone to vice, must be restrained from doing evil through force and fear, in the hope that eventually they may be trained to become virtuous. The means by which this force, fear, and retraining is accomplished is **human law**. Human law, if it is just, is derived from natural law, either as a conclusion from natural law premises (the natural law premise, "do harm to no man," leads to the human law conclusion, "one must not kill"); or by determination (the law of nature is that evil-doers should be punished, but the human law may determine many different ways to punish).

Hobbes

Thomas Hobbes (1588–1679) published a major work of political philosophy, *Leviathan*, about ten years after Puritan revolutionaries had overthrown and beheaded King Charles I of England. Until Hobbes, theories of the moral foundation of government had focused on the divine right of kings or on natural law, allowing a few to exercise the right to govern the many.

According to Hobbes, the laws of nature are rules of reason that indicate the best way to further our self-preservation. Thus, people avoid war and seek peace as a means to self-preservation. However, people are also led to war by their reason—also as a means for self-preservation. To resolve this contradiction, Hobbes proposes that all people should agree to lay down their right to do anything necessary to preserve themselves. To back up such an agreement, Hobbes proposes the establishment of a **sovereign power** to whom people cede their right to all things in return for enforcing the agreement—at best, an absolute monarch. The citizens' survival depends on accepting the authority of the monarch because revolution cannot be justified on the grounds of individual liberty.

John Locke (1632–1704), another Englishman, carries on from Hobbes, but he has a much more positive view of human nature. According to Locke, natural law obliges people to preserve not only themselves but others as well, as long as their own preservation is not threatened. People also can expect assistance from others in preserving themselves. Each rational being legislates the law of nature and executes it in practice, so each person must judge when the law has been broken and what reparation or punishment is needed. For Locke, the state of nature is a virtual natural government in which all take part in the legislative, executive, and judicial branches.

According to Locke, each person has a property in him- or herself, and nobody else has a right to that property. The idea of property extends to the fruits of a person's labor. Locke's notion of the **social contract** is that it exists to protect property—a person's body, freedom, and fruits of labor. And since under natural law physical property is most at risk, **civil law** is needed primarily to protect lands and industry. Thus, the fundamental rights of citizens are life, liberty, and property, and the role of the law is to protect those rights. Locke's writings profoundly influenced the development of democracy in the United States and throughout the world.

Locke

Jefferson	
	Thomas Jefferson (1743-1826), the author of the American Declara- tion of Independence, was greatly influenced by Locke's description of a society that protects the rights of individuals to live their own lives. Since liberties and the laws that protect them are equally extended to all citizens, the idea of justice is embedded in the political framework of the society—a society ruled by laws, not men. And since laws are to be made for the common good, concern for the welfare or happiness of citizens is institutionalized in the political system. The intermingling of the ethical and the legal in the political theory that underlies Locke's writings as well as the Declaration of Independence makes ethical and legal issues intertwined in the American mind. The Declaration of Independence summarized the consequences of Locke's ideas for the political future of America: revolution is justified when a government becomes destructive of its citizens' rights to life, liberty, and the pursuit of happiness.
Kant	
	 With German philosopher Immanuel Kant (1724–1804), the focus shifts from the ethical underpinnings of the state to the nature of morality. He is one of the few philosophers who believe that morality is a matter of following absolute rules. Kant believed that much of human conduct is governed by the notion of "ought." For example, if you decide you want something, you recognize that a certain course of action will help you get what you want; therefore, you ought to follow that course of action. Kant called this type of situation a hypothetical imperative—what you ought to do depends on what you desire. If you renounce the desire, you can renounce the course of action. In contrast, moral obligations do not depend on an individual's desires. Moral requirements are categorical imperatives: you should do something regardless of your personal wishes and desires. Kant believed that hypothetical imperatives are possible because people

do something regardless of your personal wishes and desires. Kant believed that hypothetical imperatives are possible because people have desires, but categorical imperatives exist because people have reason. This is because categorical imperatives are derived from a principle that every rational being must accept, "Act only according to that maxim by which you can at the same time will that it should become a universal law." For example, you must give charity whether you desire to or not, because if you do not, others may not give charity to you when you need it.

GENERAL OVERVIEW

Thus, acting as a moral agent means guiding your behavior by universal laws, moral rules that hold without exception in all circumstances. Moral agency also involves honoring the fundamental worth and **dignity** of people and treating them with respect. Thus, you cannot treat another human being as a **means** to an end, as you might treat an animal; human beings are **ends** in themselves. Moral agency also presupposes that people are rational, autonomous beings—that they can make or follow laws as necessary and recognize others as autonomous.

American Josiah Royce (1855–1916) approached ethical principles from the deontological perspective. He selects a principle that represents the highest duty and from which other duties originate and judges behavior on whether or not it is in accord with that highest duty. According to Royce, that highest duty is **loyalty**, or commitment in general to the idea of duty as well as commitment in particular to the duties and ideals specific to a particular person. Basic moral principles, such as autonomy, justice, and benevolence, are aspects of loyalty.

Rawls

Rovce

John Rawls (1921-) is interested in how justice might be ensured in a society in which social institutions totally ignore its most disadvantaged members on the premise that the greater good of the greater number is served by abandoning the "underclass," a premise that he finds unjust. According to Rawls, the point at which the institutional practices of a society are determined is the point at which the state of nature is left behind and the civil state is formed. The original social contract becomes a model for a just society. A group of rational people, all of whom are equals who are bargaining for the best possible society without knowing whether they will be advantaged or disadvantaged, will have to establish a set of rules that are fair for all.

According to Rawls, such a group would choose two principles of justice: "First, each person is to have an equal right to the most extensive basic liberty compatible with a similar liberty for others. Second, social inequalities are to be arranged so that they are both (a) reasonably expected to be to everyone's advantage and (b) attached to positions and offices open to all."

King	Martin Luther King, Jr. (1929-1968) explained that the American civil rights movement was working for the cause of justice. He drew from the Biblical tradition, Aquinas, Hobbes, Locke, Jefferson, and Kant. For King, the obligation to do justice overrode the possibilities of violence and threats to order. In a letter from jail justifying the Birmingham boycott of 1963, King explained how he could simultaneously urge people to obey the law and break the law: "I agree with St. Augustine that 'an unjust law is no law at all.' A just law is a man-made code that squares with the moral law or the law of God. An unjust law is a code that is out of harmony with the moral law Any law that degrades human personality is unjust. All segregation statutes are unjust because segregation distorts the soul and damages the personality."
Consequential Ethics	The hedonists of ancient Greece were the first philosophers of consequential ethics, in which the morality of an action is determined by its consequences. Their approach was later adapted by the Utilitarians Jeremy Bentham and John Stuart Mill.
Epicurus	An early hedonist, Epicurus (341 B.C270 B.C.) believed that it was possible to lead a calm and enjoyable life by carefully managing the appetites. Pleasure is the first good; it is the basis of every choice we make for or against something, and it is the standard by which we judge what is good. Epicurus understood pleasure to mean freedom from pain in the body and from trouble in the mind. Prudence, therefore, is the greatest virtue, for it enables us to live pleasantly, managing our desires.
Bentham	Jeremy Bentham's (1748–1832) moral philosophy is based on the principle of utility : "that principle which approves or disapproves of every action whatsoever, according to the tendency which it appears to have to augment or diminish the happiness of the party whose interest is in question; or what is the same thing in other words, to promote or to oppose that happiness." The principle of utility is not easy to apply, because it involves thinking before acting and figuring out the consequences of action for yourself, others, and even the community as a whole.

GENERAL OVERVIEW

Bentham sets forth a method of **calculating the value of consequential pleasure or pain to an individual** according to its intensity, duration, certainty or uncertainty, propinquity or remoteness, fecundity, and purity. To calculate its value to a number of people, one must consider the factors previously listed and add a seventh factor: its extent, that is, the number of people who will be affected by the act. When the interests of a community are affected, a complex process of balancing pleasure and pain is followed.

John Stuart Mill (1806-1873) was the leading exponent of Utilitarian theory in the generation following Bentham. According to Mill, people long for a state of being in which they are as happy as possible, which he called the **greatest happiness principle**. The primary rule of morality is, therefore, to act in a manner that brings the greatest state of happiness to all those affected by our conduct. Thus, actions are judged to be right or wrong based solely on the virtue of their consequences. In assessing consequences, only happiness or unhappiness matters, and no one's happiness or unhappiness is more important than any other person's.

Mill believed that the state has limited authority to interfere with personal freedom as long as the individual's actions are not harming others. The inconvenience to society is bearable because the greater good of human freedom for all is being honored. In addition, he thought that when the state does interfere with purely personal conduct, it usually interferes wrongly.

FEMINIST ETHICS

Mill

A feminist critique of traditional moral philosophy arose in the 1980s on the basis that traditional ethics are ethics of principle based on a "male" way of thinking. Carol Gilligan, a psychologist, suggested that women's basic moral orientation was to care for others (personally, not humanity in general) and to attend to their needs. Their moral responses tend to seem diffuse and confused because they have an overriding concern with relationships rather than logical principles. According to Virginia Held, caring for other people's feelings and needs may be better indicators of what morality requires in specific situations than abstract rules of reason. This feminist approach to moral philosophy is called the **ethics of care**.

THE ETHICS OF VIRTUE

The philosophers who focused on the moral law asked, "What should we do?" Some modern philosophers have suggested a return to Aristotle's approach, asking, "What traits make a good person?"

A trait of character that is demonstrated by habitual action and that is deemed good for a person to have is called a **virtue**. Examples of virtues include benevolence, compassion, courage, fairness, honesty, moderation, self-confidence, self-discipline, tactfulness, and tolerance. Each virtue has its own distinctive characteristics and problems. For example, it can be argued that courage on behalf of an evil cause is wicked, not virtuous, behavior.

ETHICAL ISSUES

As we have seen, ethics deals with questions of right behavior that arise in all areas of life, including our relationships with family and friends, in government and law, in business, in science and medicine, and in our occupational roles. We touch on just a few issues here.

FAMILY AND FRIENDS

People do not treat their family and friends as they do strangers because they are bound to them by ties of kinship and affection. For example, according to some moral theories the idea of impartiality might suggest that parents should treat their children as they would the children of strangers, but that seems wrong; we expect parents to love and pay a great deal more attention to their own children than to others. Similarly, a judge is expected to be impartial when presiding over trials and sentencing criminals, but no one expects a judge to preside over the trial of her own son.

The special treatment afforded family is even codified in our laws: husbands and wives cannot be compelled to testify in court against one another. In relationships with family and friends, therefore, loyalty usually prevails over justice.

Government and the Law

Questions of ethics arise in almost all aspects of government and law, from the law's intrinsic impartiality and fairness (justice) to the rightness of defending criminals to the idea of retribution, to name just a few.

JUSTICE

The most fundamental principle of **justice** is that people should be treated the same unless they differ in ways that are relevant to the situation at hand. This is the basic principle underlying equal employment opportunity legislation, which seeks to prevent discrimination in employment on the basis of gender, race, sex, religion, or national origin. In most employment situations, these characteristics are considered irrelevant to the ability to do a job and are not to be used to discriminate against an individual. For example, a woman should be paid the same wages if she is doing the same job as a man. However, there are situations in which one of the characteristics might be relevant. For example, an airline would be justified in discriminating against an elderly pilot on the grounds that age affects performance in that job.

There are different kinds of justice:

- Distributive, or social, justice refers to the extent to which our legal and social institutions ensure that benefits and burdens are distributed fairly among the members of society. When benefits and burdens are distributed unfairly, we assume that our institutions need to change. Slavery in the United States and apartheid in South Africa were both condemned as unjust because benefits and burdens were distributed unfairly on the basis of race.
- **Retributive justice** refers to the fairness of punishments. In general, punishment is considered fair if it accounts for the seriousness of the crime and the intent of the criminal and if it does not account for irrelevant criteria such as race. The disproportionate number of black men on death row suggests that injustice still exists in the criminal justice system of the United States.
- **Compensatory justice** refers to the extent to which people are fairly compensated for their injuries by those who have injured them. Smokers suing the tobacco companies are seeking compensatory justice.

D	
Business	In a business that takes account of moral as well as economic issues, management assesses the effect of business decisions and actions on society as well as on the business. Three major areas of ethical concern are consumers (product safety, public health, product information, product choices, privacy, and the resolution of com- plaints), employees (equal employment opportunity, affirmative action, and retraining), and the environment (safety, pollution, and conservation).
	In an organization with an ethical corporate culture, ethical guidelines are clearly stated and communicated to employees; managers are committed to ethical values, normal business practices reflect ethical values, and managers are trained to make ethically sound decisions. Ideally, businesses would regulate themselves behaving in an ethical and socially responsible manner. In reality, the government imposes regulations to help ensure that businesses operate in an ethical and socially responsible manner.
Science	There are many ethical issues in science today that involve both the content of experiments (such as embryonic stem cell research or genetic engineering) and the manner in which they are carried out. Two ethical issues that arise frequently are animal rights and informed consent.
Animal Rights	Natural law held that animals were intended for the use of humans. The social contract among rational beings excluded animals because they did not have the ability to reason, and Christian tradition said that animals lacked a "soul" and were not human. Thus, on most fronts of moral philosophy animals could be killed or made to suffer if there was a purpose for doing so. The first philosophers to chal- lenge this view were the Utilitarians. According to Bentham, what matters is whether the animal is capable of happiness or suffering. When animal rights activists protest animal experiments, they use the Utilitarian argument that animals are capable of suffering. Scientists counter with the argument that there is a compensating gain in happiness elsewhere—the possible future benefits to humans

from animal experimentation.

INFORMED CONSENT

When humans are the subjects of experiments, the ethical duty of researchers is to minimize their exposure to physical or psychological risks. Research institutions and hospitals generally have review boards that make sure that each proposed study follows ethical guidelines. Researchers must ensure that participants understand what is or may be involved in the study by obtaining their informed consent before the study begins. Informed consent is premised on the rational capacity of humans to judge the risks and benefits of their actions. Subjects are permitted to withdraw from an experiment at any time. In addition, all information about participants must be kept confidential to protect their privacy.

HEALTH CARE

Scientific and technological advances have enabled medical professionals to treat disorders and prolong life. Along with these new abilities have come ethical issues. Some of these are life-and-death or quality-of-life issues for which there are no accepted moral codes as yet. For example, the care owed to a very premature infant is an area still being explored since our ability to intervene with these babies is so recent. Other ethical dilemmas have arisen in dealing with reproductive technology, organ transplant, keeping terminally ill patients alive on life support systems, and physician-assisted suicide. Ethical dilemmas involving health care are so serious that many hospitals and other health-care institutions seek the advice of ethicists in resolving these problems.

OCCUPATIONAL ETHICS

Many professional groups have codes of ethics that are guidelines for moral behavior. For example, lawyers, psychotherapists, doctors, counselors, and clergy are expected to keep information their clients share with them confidential. Doctors are also expected "to do no harm," which is part of the Hippocratic oath that they take upon entering medical practice. Some occupational ethics may not be articulated in a written code but exist nevertheless. For example, teachers are expected to treat their students impartially. Business people are expected to honor their agreements.

ETHICAL DECISION MAKING

When confronted by a serious ethical dilemma that they cannot resolve instinctively, people are sometimes at a loss as to how to proceed. In such cases, using a framework for ethical decision making can be helpful in clarifying the issues. The framework outlined here is adapted from one developed by Santa Clara University's Markkula Center for Applied Ethics.

RECOGNIZING A MORAL PROBLEM

The first step in any decision-making framework is to make sure the moral problem is thoroughly understood. What exactly is wrong that may result in harm to myself, others, animals, the environment, or society at large? Can the issue be resolved by recourse to the law or to the rules of an institution (a church or school, for example), or must a decision be made independent of these resources?

ESTABLISHING THE FACTS

The fact-finding activities are important because the decision will be made in part based upon an assessment of the facts that exist and the alternatives that are possible. So, for example, in deciding whether or not to intervene medically in a severely premature baby's condition, it is important to know exactly what the condition is and what the probable outcomes are—both of acting and not acting.

Questions to ask include "What are the relevant facts of the situation?" "What people and groups have a stake in the outcome?" "Do some have a greater stake than others?" "Are there people other than those directly involved who might have a stake in the outcome?"

"What are the alternatives for action?" Doing nothing is one alternative, but there may be several others. Involving the stakeholders in the search for alternatives can be helpful. Whose advice on the alternatives might be helpful?

EVALUATING THE ALTERNATIVES

Once it's clear what the alternatives are, each must be evaluated from a moral perspective. There are four major schools of moral philosophy today, Utilitarianism, Kantianism, social contract theory, and virtue theory. Each alternative can be evaluated from the perspective of each of these theories:

- Which alternative would do the most good and the least harm? (Utilitarianism)
- Which alternative takes into account the rights and dignity of everyone involved? Will everyone be treated fairly? (Kantianism)

- Which alternative would increase the common good of the group, company, community, society, etc.? (social contract theory)
- Which alternative would develop the virtues that we value as individuals, as a profession, or as a family? (virtue theory)
- Making a Decision
- After all the alternatives have been considered and reasons for and against each have been evaluated, a decision can be made as to which alternative is best in the circumstances.

Assessing the Decision

At some point in the future it will be possible to look back at the ethical issue and its resolution in order to evaluate the action that was taken. How did solving the problem affect each of the stakeholders? Were there unanticipated consequences? If you were again confronted with this problem, what would you do?

SAMPLE QUESTIONS

- 1. The correct answer is (C). Hobbes thought that when men pursued all their rights and did whatever they could for their own self-preservation, this led to war; in order to avoid war, people had to compromise their rights and turn authority over to the government to enforce the compromise.

CASE STUDY ANSWERS

- 1. The correct answer is No. The issue dramatized is not whether Professor Harrison, like all human beings, always *does* what she believes to be in her self-interest (which is what psychological egoism claims), but what she thinks is the *right* course of action. The issue dramatized is between ethical egoism (the thesis that a person *should* always act in what that person rationally judges to be in own selfinterest) and some non-egoistic ethical system, whether altruistic or deontological.

INTRODUCTION

Human resource management, also called **personnel management**, is the use of an organization's human resources to achieve its goals. Human resource managers function in a staff (advisory) capacity, working with other managers on human resource activities. In a large organization with a human resource department, the top human resource executive reports directly to the chief executive officer or a division head. Human resource middle managers, supervisors, and workers usually specialize in one of the main human resource activities. These include human resource planning, recruiting, and selecting; human resource development; compensation and benefits; safety and health; employee and labor relations; and human resource research.

Globalization, technological change, work force diversity, and a more service-oriented economy have enlarged the role played by human resource management. Today human resource managers work with other top managers to help formulate and execute an organization's strategies.

GENERAL EMPLOYMENT ISSUES

HUMAN RESOURCE PLANNING

Human resource planning is part of a firm's strategic planning process. Plans to expand into new lines of business or acquire another company influence the human resource needs of the organization. For example, decisions must be made regarding the types and number of positions to be added or eliminated. To predict the need for personnel, the demand for the product or service is projected; then the volume of production required to meet demand; and finally the number and type of personnel needed to achieve these production estimates.

A basic employment planning decision is whether to fill positions from inside or outside of the organization. Part of planning involves forecasting (1) overall personnel requirements, (2) the supply of inside candidates, and (3) the supply of outside candidates.

RECRUITMENT

The process of attracting a sufficient number of qualified applicants to apply for jobs within an organization is called **recruitment**. After identifying sources of potential employees, the human resource manager chooses the appropriate methods for internal and/or external recruitment. **Internal recruitment methods** include maintaining management and skill inventories of employees and job posting. **External recruitment methods** advertise in the appropriate media, including the Internet; use public or private employment agencies; canvas high schools and colleges; hold special events such as job fairs; offer internships; and use executive search firms for high-level managers.

Environmental factors can influence recruitment to a great degree. For example, the demand for workers with specific skills may greatly exceed the supply, making extraordinary recruitment efforts necessary. On the other hand, when there is high unemployment in the company's labor market, recruitment is simplified considerably.

SELECTION

In the **selection** process, the best candidate for a particular position is chosen from the pool of applicants. The first step in the selection process is an **initial screening**, often of resumes or letters of application, to eliminate candidates who are clearly unqualified for the job. Next, prospective employees may fill out an **employment application**.

Applicants who progress this far are interviewed. The **interview** is a directed conversation in which the interviewer and applicant give and get information. Interviews may be conducted in many ways. In a group interview, several applicants talk with one or more company representatives at the same time. In a board interview, one applicant is interviewed by several company representatives at once. In a stress interview, the company representative deliberately creates anxiety to see how the applicant reacts. A realistic job preview gives an applicant objective information about the job.

Selection tests are sometimes used to help assess an applicant's skills, abilities, and potential for success. Good tests are objective, standardized, have norms, are reliable (consistent in their results), and valid (the test measures what it is intended to measure). Tests can measure general cognitive abilities, psychomotor abilities, job knowledge, performance, vocational interests, personality, and drug tests.

Reference checks are used to confirm the accuracy of information gained in the selection process. In some cases, background checks are necessary.

Finally, one applicant is offered the position, often contingent on passing a physical examination.

ORIENTATION

Orientation is a procedure in which a new employee is educated about the company and the job. In a small firm, orientation may consist of introducing the employee to everyone. In a large firm, there may be a formal, lengthy orientation program, conducted by the human resource department, including a video presentation, a tour of the facility, and an employee handbook. The remainder of the job-specific orientation is then done by the employee's supervisor.

PROMOTIONS AND **T**RANSFERS

The human resource department helps set company policy on how promotions are handled. Some companies base promotion on an employee's seniority; others use competence as the basis for promotion; and still others use a combination of the two. If competence is the yardstick of promotion, then the company must establish how competence is measured. Competence in performing the tasks of the current job is fairly easy to determine, but promotion involves predicting future performance of higher level tasks. In most cases, future potential is extrapolated from present performance.

A **transfer** is a movement to another job, usually at the same grade level and salary. Employees sometimes seek transfers to get a better location, more interesting work, or better hours. Employers transfer employees in order to vacate an eliminated position or achieve a better fit between employee and job. Transfers have become increasingly common as organizations have flattened, with fewer levels of management in which to be promoted. Transfers can give employees more diverse work experience and opportunities for personal growth.

LAYOFFS, DOWNSIZING, AND OUTPLACEMENT

A **layoff** is a temporary or permanent termination of employment because there is not enough work to be done. In a unionized company, the layoff proceeds according to the terms of the labor contract, usually with the least senior employees going first. In other companies, layoffs may be decided on the basis of competence or internal politics. **Downsizing** involves the permanent shrinking of the organization in order to remain competitive. With downsizing, many employees lose their jobs.

Outplacement is a procedure used to help a terminated employee conduct a self-appraisal and execute a job search. Outplacement is conducted by a human resource department specialist or an outplacement firm.

JOB ANALYSIS

Job analysis is the procedure by which the duties of a specific position and the characteristics of the people who can fill the position are determined. Job analysis yields information used in generating **job descriptions** (what the job involves) and **job specifications** (what kind of people to hire for the job). Information collected in the course of a job analysis may include work activities; human behaviors; machines, tools, equipment, and supplies used; standards of performance; the context of the job—physical, social, and organizational; and human requirements, including knowledge, skills, and personal attributes. The information can be collected in a variety of ways: through interviews, questionnaires, observation, employee diaries/logs, and quantitative techniques.

A job analysis is the basis for several other human resource management activities, including recruitment and selection, compensation, performance appraisal, training, and ensuring that all the firm's activities are explicitly assigned. Thus, it plays a central role in complying with **equal employment opportunity laws** (see page 122). An employer must be able to prove that its employment screening tools, compensation policies, and performance appraisals are actually related to the job in question.

TRAINING AND DEVELOPMENT

Training gives new or current employees the knowledge and skills they need to perform on the job. In contrast, **employee and management development** focuses on long-term issues, preparing employees and managers for future jobs in the organization. **Retraining** refers to programs in which employees whose skills and knowledge are outmoded are trained for new positions in an organization or outside it.

Training and Learning

Since training involves learning on the part of the employee, suggestions based on learning theory can improve results.

One basic principle of learning is that it is easier to learn something if it is meaningful. To that end, trainees should be given an overall picture of the purpose of the training. The material should be broken into meaningful chunks, and familiar terms, examples, and concepts should be used. A second basic principle is that learning must be transferred from the training site to the work site. To accomplish this, the similarity between the training situation and the work situation should be maximized and lots of opportunity to practice should be given. Third, it is easier to learn if there is motivation to learn. Trainees should learn by doing, be praised for correct responses, and be allowed to pace themselves.

TRAINING PROGRAMS

There are many techniques for training employees, including the following:

- **On-the-job training**—A person learns a job by actually performing it. Every employee gets some on-the-job training.
- **Job instruction training**—This is a step-by-step method of teaching jobs that consist of a logical sequence of tasks.
- Lectures—Lectures are used when a lot of knowledge needs to be imparted to a group; for example, teaching the sales force the key features of new products.
- **Vestibule training**—This is a training method that uses simulation in an off-site location.
- **Programmed learning**—This is a system of teaching job skills in which information is presented, a question is asked, the employee responds, and then the employee is given feedback on her answers.
- **Computer-based training**—Employees use an interactive computer programs to increase knowledge or skills.

MANAGEMENT DEVELOPMENT PROGRAMS

Programs designed to improve current or future employee and managerial performance by teaching knowledge, changing attitudes, or increasing skills are called **employee** or **management development programs**. The aim of such programs is to maximize the future performance of the organization as a whole. Thus, a company's needs are first assessed, then its employees' performance is appraised, and finally development programs are implemented. Most employee development programs focus on management development.

There are several **on-the-job training methods** used for management development, including:

- Job rotation—Management trainees are moved from department to department to increase their understanding of the business as a whole.
- **Coaching/understudy approach**—The new manager works directly under the manager he is replacing.
- Junior board—Managers sit on a "board of directors," analyzing company problems and recommending solutions.
- Action learning—Managers work full-time analyzing and solving problems in other departments.

Off-the-job training is also used:

- **Case study method**—Managers are presented with case studies of organizational problems that they must solve.
- Management games—Teams of managers compete by making decisions about realistic but simulated companies.
- **Outside seminars**—Managers attend special conferences and seminars to learn new skills.
- University-related programs—Managers take courses and programs offered at colleges and universities.
- **Role playing**—Managers act out the parts of people in a realistic management situation.
- **Organizational development**—Employees and managers undergo a program designed to change attitudes, values, and beliefs so that they can improve the organization.

CAREER PLANNING AND DEVELOPMENT

A process through which an employee becomes aware of personal career-related attributes and the series of stages in a career is called **career planning and development**. Many companies have instituted programs to help employees manage their careers and to promote from within. In such companies, career-oriented performance appraisals help employees develop appropriate career plans. Career records and open job postings also provide opportunities for employees to advance.

PERFORMANCE APPRAISALS

Performance appraisals are periodic reviews of employee performance, usually conducted by the employee's supervisor with policymaking and advisory input from the human resource department. In some organizations, the human resource department simply provides advice and assistance; in others, it prepares detailed forms and procedures for use throughout the company. The human resource department trains supervisors to conduct appraisals. Finally, the department monitors the organization's appraisal system, ensuring that appraisals comply with equal employment opportunity laws.

PURPOSES OF PERFORMANCE APPRAISAL

Conducting performance appraisals accomplishes three basic purposes: providing information upon which salary and promotion decisions can be made, reviewing and correcting employee behavior, and providing an opportunity to discuss career planning and development.

PERFORMANCE APPRAISAL TECHNIQUES

Appraisals are conducted according to a predetermined format. There are several techniques used alone or in combination:

- **Graphic rating scale method**—Rating employees on a list of traits and/or duties according to a range of performance values, from unsatisfactory to outstanding.
- Alternation ranking method—Ranking employees from best to worst on a particular trait.
- **Paired comparison method**—Comparing each employee to every other employee in the group for each trait, which is a ranking method.
- Forced distribution method—Assigning employees to predetermined performance categories according to preset percentages, which is similar to grading on a curve.
- **Critical incident method**—Keeping a record of an employee's excellent or poor work-related behavior and reviewing it with the employee.
- Narrative forms—Rating performance in terms of standards accompanied by critical incident examples and an improvement plan.
- **Behaviorally anchored rating scales**—Evaluating performance by combining narrative critical incidents and quantified ratings.
- Management by objectives—Setting specific measurable goals with each employee and reviewing those goals periodically.

PROBLEMS

Appraisal problems can undermine the legal defensibility of an appraisal according to equal employment opportunity laws. Problems in the performance appraisal process can arise at any stage. For example, there may be problems with the **standards of performance** being used. They may be irrelevant to the job, subjective rather than objective and measurable, ambiguous, or unrealistic. In some cases there may be no articulated standards against which to judge performance. The supervisor can create problems by skewing the performance ratings in several ways. For instance, the **halo effect** is a problem that occurs when a supervisor's rating on one trait biases the rating on other traits. It is a common problem when the employee is very friendly or unfriendly toward the supervisor. The **central tendency** is to rate toward the middle of a rating scale, making all employees average. Some supervisors are **strict** or **lenient** in rating all of the employees in the work unit. Finally, a supervisor's **bias** in matters such as gender, age, race, and ethnicity can affect appraisal ratings.

In their appraisal interviews with employees, supervisors can create problems by failing to give appropriate feedback in order to improve performance. They can destroy the effectiveness of the process by communicating negative attitudes.

Finally, failure to use the information gathered in the course of performance appraisals means that their purpose is partially negated.

MOTIVATION, COMMUNICATION, AND LEADERSHIP

Motivation is that which energizes, directs, and sustains human behavior. Employees can be motivated by a well-designed incentive system (see Compensation, below) or by the satisfactions built into their jobs. The human resource department plays a role in redesigning work through programs such as alternative work arrangements, quality circle programs, quality improvement programs, self-directed teams, and reengineering.

Communication is a key activity in a well-run organization, especially in ensuring fair treatment of employees. The human resource department in some companies runs programs that encourage two-way communication between management and employees: a confidential hotline that employees can use to communicate about problems and issues, periodic opinion surveys, and top-down communications to ensure that information is disseminated.

The human resource department is also involved in **leadership** identification and training. Through employee skills inventories and career planning programs, employees who show leadership potential are identified. Through employee and management development programs, leadership skills are developed.

COMPENSATION

Compensation refers to all forms of pay and rewards that workers get because of their employment. Compensation may take the form of direct financial payments, such as wages, salary, incentives, commissions, and bonuses, or indirect financial payments like vacation time and employer-paid insurance.

ESTABLISHING PAY RATES

There are several steps involved in establishing pay rates that compare equitably with rates for similar jobs in other organizations and rates of other jobs within the organization.

- 1. Salary survey—A survey is taken to determine the prevailing pay rates for a particular job, called a **benchmark job**. This can be done through informal communication, consulting with employment agencies, reviewing newspaper ads, or conducting a formal survey. Once the salaries of several benchmark jobs are known, salaries of other jobs in the organization can be pegged on those.
- 2. Job evaluation—Job evaluation is a systematic process of determining the worth of one job relative to another. The basic procedure is to compare the content of one job with that of another, in terms of **compensable factors** such as effort, responsibility, skills, and working conditions. Other compensable factors can be used; for example, a method popularized by one consulting firm uses know-how, problem-solving, and accountability.

The simplest method is to rank jobs according to an overall factor such as difficulty. Another method is to categorize jobs into groups: groups with similar jobs are called **classes** and groups with jobs similar in difficulty but different otherwise are called **grades**. A third method, the **point method**, uses several compensable factors and then assigns a point value for each to each job.

- **3. Pay grades**—Once a job evaluation has determined the relative worth of each job, the jobs can be grouped into pay grades. A pay grade consists of jobs of similar difficulty or importance.
- 4. **Pay rates**—To establish pay rates, a wage curve is drawn. A wage curve shows the pay rates currently being paid for jobs in each pay grade, relative to their points or other ranking. Once the rates are plotted, a line called the wage line is drawn through them. Rates along the line are the target pay rates.
- **5. Rate ranges**—Most employers pay a range of rates for a particular job, not just one rate. The range may extend 15 percent above and below the wage line, for example.

WAGE AND SALARY ADMINISTRATION

Wage and salary administration is the human resource function responsible for making compensation policy, implementing compensation systems, and keeping compensation records for an organization. Specialists in this area also ensure that the organization is in compliance with the many laws that apply to employee compensation.

INCENTIVE PLANS

Programs that link pay directly to performance are called **incentive plans**. Different types of incentive plans are used for different categories of employees. Typical incentive plans for operations employees include:

- **Piecework plan**—A system of paying employees for the number of items they process. In a straight piecework plan the employee is paid a certain amount per item. In a guaranteed piecework plan, the employee is paid the minimum wage and additional per-item compensation for production above a certain number of items per hour.
- **Standard hour plan**—A system in which employees are paid a base hourly rate and an additional percentage of the base rate for production above a certain standard per hour or per day.
- **Team or group incentive plan**—A plan in which production standards are set for a work group and incentives are paid out if the team exceeds the standard.

For managerial employees, incentive plans include:

- Annual bonus—A payment designed to motivate the shortterm performance of executives and managers and tied to company profitability.
- **Stock options**—The right to purchase a specified number of shares of company stock at today's price some time in the future.

Incentive plans for sales people include:

- **Salary plan**—A fixed salary with occasional bonuses or prizes. Typically used when a salesperson's major activity is prospecting or servicing accounts.
- **Commission**—Payment in direct proportion to sales.
- **Combination plan**—A base salary plus an additional proportional incentive, such as a commission.

There are also incentive plans that apply to many employees or an entire organization:

- Employee stock ownership (ESOP) plan—A corporation contributes stock to an employee account held in trust; the employee gets the stock upon retirement or other separation.
- **Gainsharing plan**—A plan that engages employees in an effort to achieve improved productivity and to share the gains.
- At-risk pay plan—A plan that puts a percentage of an employee's pay at risk, subject to the company's meeting its financial objectives.

BENEFITS

Benefits are a form of financial compensation that employees receive indirectly. They are not tied to individual employee performance, but rather are available to employees as members of the organization. There are several major types of benefits:

- **Payment for time not worked**—This includes paid vacation, paid holidays, sick time, and severance pay.
- Health and security benefits—These include health insurance, dental insurance, disability protection, vision care, life insurance, retirement plans (including social security and pensions), and supplemental unemployment insurance.
- **Employee services**—Organizations provide services such as employee cafeterias, fitness centers, day-care centers, legal advice, credit unions, discounts on products and services, parking spaces, and tuition reimbursement.

Employees tend to prefer certain types of benefits depending on their age, marital status, and gender. As a result, many companies provide a **cafeteria approach** to benefits, allowing each employee to put together his or her own benefit plan, subject to a maximum cost and nonoptional inclusion of certain items.

NONFINANCIAL INCENTIVES

Although compensation is the major motivation for most employees, many employees also appreciate nonfinancial incentives for work performance. These may include flextime, a four-day workweek, job sharing, or telecommuting. They also include programs that give employees more control over their work, such as quality circles, total quality management programs, self-directed work teams, participative decision making, and reengineering work processes.

SECURITY ISSUES

EMPLOYEE SAFETY AND HEALTH

	Accidents occur by chance, because of unsafe conditions or due to unsafe acts on the part of employees. Work-related factors also contribute to accidents, including the job itself, the work schedule, and the atmosphere of the workplace. Employers institute safety programs for moral, legal, and economic reasons. There are several approaches: to remove unsafe conditions, to hire and place people appropriately, to train, through propaganda, and through the commit- ment of top management to safety. Employee health problems can adversely affect the workplace. Alcoholism, drug abuse, stress, and mental illness are particularly serious problems. Techniques for dealing with these include counsel- ing, referrals to outside agencies, disciplining, and discharge.
Discipline	The process of correcting or punishing an employee for breaking a rule or violating a procedure is called discipline . In most large organizations, discipline is a formal procedure with rules and regulations, a system of progressive penalties, and an appeals process. Since arbitration may be a step in the process, especially in unionized workplaces, employers must ensure that discipline is well documented and fair.
Dismissal	There are four basic grounds for dismissal:
	• Unsatisfactory work performance—A persistent failure to

- Unsatisfactory work performance—A persistent failure to perform assigned tasks or to meet standards on the job. Excessive absenteeism, lack of punctuality, and a negative attitude toward fellow employees and the company are included under this category.
- **Misconduct**—Willful and deliberate breaking of the employer's rules, including stealing and insubordination.
- Lack of qualifications—An inability to do the job despite diligent effort. Dismissal is a last resort for these employees.
- **Changed requirements of the job**—An inability to do the job once it changes despite effort. Again, dismissal is a last resort.

LEGAL ISSUES

EQUAL EMPLOYMENT OPPORTUNITY

Congress passed the **Civil Rights Act of 1964, Title VII** of which bars employment discrimination because of race, color, religion, sex, or national origin. One provision of the act was to create the **Equal Employment Opportunity Commission**. It is empowered to conciliate discrimination complaints; if these fail, the Commission can go to court to enforce the law. Other laws and regulations that bar discrimination include the Equal Pay Act of 1963, the Age Discrimination in Employment Act of 1967, the Pregnancy Discrimination Act of 1978, the Americans with Disabilities Act of 1990, executive orders, federal guidelines on selection tools, Supreme Court cases, and state and local laws.

Until the late 1980s, most Supreme Court decisions regarding workplace discrimination came down on the side of women and minorities. However, in 1989 several Supreme Court decisions made it more difficult for employees to prevail in the courts. In response, Congress passed the **Civil Rights Act of 1991**. This returned the burden of proving that a job qualification was a **business necessity** or **bona fide occupational qualification** back to the employer. In addition, the act provides for compensatory and punitive damages and a jury trial.

Sexual harassment refers to harassment on the basis of sex that has the purpose or effect of substantially interfering with work performance or that creates a hostile environment. The harassment may take the form of quid pro quo (rejecting a sexual advance may have affected an employee's raises or promotions); a hostile environment created by a supervisor (consequences of harassment can be intangible, such as psychological stress); or a hostile environment created by coworkers or nonemployees.

AFFIRMATIVE ACTION

Affirmative action goes beyond equal employment opportunity by requiring that employers make an extra effort to hire and promote those who are in protected groups. Affirmative action includes specific actions in recruitment, hiring, promotions, and compensation that eliminate the present effects of past discrimination.

GENERAL OVERVIEW

Two basic strategies underlie affirmative action plans. The first is the **good faith effort strategy**, in which the employer changes practices that in the past contributed to excluding or underusing members of protected groups. The assumption underlying this approach is that if the obstacles to hiring and advancement are removed, the result will be that more women and minorities will succeed. The second is the **quota approach**, in which the employer mandates affirmative action results by setting numeric hiring and promotion goals. This approach has been challenged by members of unprotected groups, such as white males, on the basis of **reverse discrimination**.

COMPENSATION There are many laws that regulate what an employer must pay in terms of minimum wages, overtime, and benefits. These include: • Fair Labor Standards Act of 1938 (amended)—This act contains provisions regarding minimum wage, overtime pay, equal pay, recordkeeping, and child labor protection. It covers most employees. • Equal Pay Act of 1963—This act requires equal pay for women doing the same work as men. • Employee Retirement Income Security Act of 1974 (ERISA)—A law that provides government protection of pensions for employees of companies with pension plans. It regulates vesting and portability rights. • Unemployment insurance or compensation acts—These are state laws that provide weekly benefits if a person is unable to work through no fault of his own. • Worker's compensation laws—These are state laws that provide income and medical benefits to workers injured on the job.

SAFETY AND HEALTH

In 1970 Congress passed the Occupational Safety and Health Act, the purpose of which was to ensure the health and safety of workers on the job. Under the provisions of the act, the **Occupational Safety and Health Administration (OSHA)** was established as part of the Department of Labor. The purpose of OSHA is to administer the provisions of the act and to set and enforce safety and health standards.

OSHA standards are very comprehensive and detailed. In addition to specifying physical conditions such as the dimensions of a guardrail, OSHA requires that employers establish hazard communication programs to inform employees about dangerous chemicals. OSHA standards are enforced through inspections and citations.

OSHA requires that all employers with more than 11 employees keep detailed records of occupational injuries and illnesses. Injuries requiring medical attention and illnesses must be reported. If a workplace accident results in the death of an employee or the hospitalization of 5 or more employees, all employers, even those with fewer than 11 employees, must report the incident.

OTHER LEGISLATION

- The Family and Medical Leave Act of 1993 provides for up to twelve weeks of unpaid leave for an employee's own serious illness, the birth or adoption of a child, or the care of a seriously ill child, spouse, or parent. This law applies only to private employers with 50 or more employees.
- Comprehensive Omnibus Budget Reconciliation Act (COBRA)—This law requires that private employers offer continued health benefits to terminated or retired employees for a period of time, usually eighteen months.

LABOR RELATIONS

LABOR UNIONS

Approximately 16 percent of U.S. workers belong to **labor unions**, organizations of workers that bargain collectively for a labor contract with an employer. In general, the weekly earnings of unionized workers are higher than those of nonunionized workers, and they receive significantly more benefits.

There are several ways in which a union can organize the employees of a work unit:

- **Closed shop**—The company can hire only union members; this was outlawed in 1947 but still exists in a few industries.
- Union shop—The company can hire nonunion workers, but they must join the union and pay dues within a specified period of time.
- Agency shop—Both union and nonunion employees must pay union dues since what the union does benefits all workers.
- **Open shop**—Both union and nonunion employees work, but only union employees must pay dues.

The American Federation of Labor and Congress of Industrial Organizations (AFL-CIO) is a voluntary federation of about 100 national and international labor unions. Workers belong to a local union, which is a chapter in a national union that may belong to the AFL-CIO. Although the AFL-CIO has limited power to act, it has a great deal of political power as the representative of labor.

LABOR LAW

Several laws affect union activity and labor-management relations, including:

- Norris-LaGuardia Act of 1932—Guaranteed each employee the right to bargain collectively.
- National Labor Relations (Wagner) Act of 1935—Banned certain unfair labor practices and provided secret ballots and majority rule in elections determining whether or not a firm's employees would join a union.
- Taft-Hartley Act of 1947—Prohibited certain unfair labor practices on the part of unions and listed the rights of employees as union members. The act allows the president to intervene in national emergency strikes.
- Landrum-Griffin Act of 1959—Protects union members from wrongdoing on the part of union leaders.

COLLECTIVE BARGAINING

Collective bargaining is the process through which a labor contract is negotiated between management and the labor union. Bargaining must be conducted in **good faith**, meaning that both sides are communicating, negotiating, and matching proposals with counterproposals in an effort to arrive at an agreement. Items on which agreement must be reached may be mandatory (such as wages and hours of employment); permissible (pension benefits, employment of strikebreakers); or illegal (closed shop, discriminatory treatment).

Collective bargaining usually goes through several stages. First, both sides present their demands; they are typically far apart on many items. In the second stage, both sides back off a little from their initial positions and trade off some demands for others. The third stage is the formation of subcommittees to work out alternatives. Next, an informal settlement is reached and each group goes back to its constituents to consult. Last, a formal agreement is written and signed. When collective bargaining reaches an impasse, it is sometimes resolved through a mediator or arbitrator. A **mediator** is a neutral third party who helps the two parties reach an agreement. An **arbitrator** usually has the power to determine and dictate the terms of the settlement. If labor decides to withdraw from the negotiations, a **strike** is called.

GRIEVANCES

Under the terms of a labor contract, a **grievance** is any factor involving wages, hours, or conditions of employment that an employee complains about. Most contracts have a very specific grievance procedure. Grievance procedures that are designed by the human resource department are used for nonunion employees.

CURRENT ISSUES AND TRENDS

COMPARABLE WORTH

Equal pay legislation mandates that women must be paid equal wages for doing equal work. The concept of **comparable worth** is that women should be paid equal wages for doing work comparable to work done by men. Comparable worth court cases are usually based on a company's use of points in a job evaluation system. If two dissimilar jobs, such as a clerk-typist and a junior engineer, have the same number of points, this implies they should be paid at the same rate even though market rates for engineers (usually male) are higher than for clerk-typists (usually female).

EMPLOYEE PARTICIPATION GROUPS

Plans designed to increase worker motivation, involvement, and commitment to the organization, such as quality circles and total quality management, are often viewed by unions as attempts to deflect worker loyalty from the union to management. Research indicates that most employee participation groups are not the threat that labor unions fear them to be. In general, labor-management conflict can be reduced when union representatives participate in the programs.

ALTERNATIVE WORK ARRANGEMENTS

Alternative work arrangements allow employees some flexibility in setting up their work schedules.

- Flextime is a plan in which the employer sets up core hours around midday during which all employees are expected to work, and then allows workers to set their own starting and ending times.
- A **four-day workweek** allows workers to work four 10-hour days instead of five 8-hour days.
- Job sharing allows two or more people to share a single job.
- Telecommuting allows workers to work from home.
- Flexyears allow workers to choose how many hours they want to work each month for the next year.

ECONOMIC ISSUES AFFECTING BUSINESS

A **business** is an organization of individuals that, for a profit, produces and sells goods and services that satisfy a society's needs. **Profits** are the rewards earned by businesses after all the expenses of doing business have been subtracted from revenue, or income. In contrast, the primary purpose of **nonprofit organizations**, such as museums and universities, is something other than to make profits for their owners.

PRIVATE ENTERPRISE SYSTEM

U.S. businesses operate as part of the **private enterprise system**, or **capitalism**, an economic system in which businesses must match and improve on the offerings of their competitors in order to succeed. The key characteristic of a private enterprise system is **competition**, the battle among businesses for consumer acceptance. Over time, businesses that satisfy consumers will succeed, and those that do not will fail. **Entrepreneurs** are key figures in private enterprise systems. They take the risk of exploiting an opportunity to make a profit by forming a new business or revitalizing an old one.

In the private enterprise system, there are four **factors of production**, or inputs, that businesses need in order to operate successfully. These include natural resources, human resources, capital, and entrepreneurship. Each business uses a unique mix of the four factors.

In order for the private enterprise system to succeed, people must have certain **rights**. These include the right to own private property, to keep their profits, and to choose their employment and purchases. In addition, people have the right to make rules concerning fair competition.

Competition takes different forms in different industries. **Pure competition** is characterized by many businesses of similar size that sell similar products, so no one firm can influence prices (farms). In **monopolistic competition**, businesses differentiate their products and have some influence over prices (department stores). An **oligopoly** is a situation in which there are few companies, and the price of entering the industry is high (automobiles, aircraft manufacture). In a **monopoly**, there are no direct competitors and the industry is regulated by the government (some utilities).

OTHER ECONOMIC SYSTEMS

Communism	
	In a communist system, all property is owned by the people in common, and a strong central government directs production. The government is the employer as well as the provider of goods, so there is little choice on the part of workers and consumers. Karl Marx , whose theories form the basis of communism, thought that each person should contribute to society according to his or her abilities and should be rewarded according to his or her needs. In an ideal communist society, there would be no economic classes. During the twentieth century, until the breakup of the Soviet Union and the loosening of its hold on Eastern Europe, many nations had a commu- nist system. Today only a few, such as Cuba, remain.
Socialism	
	Socialism is similar to communism in that the government owns key industriesùthose considered vital to the welfare of the nation, such as utilities, energy, health care, and transportation. Private ownership is permitted in less important sectors. Israel is a socialist nation, although it is moving in the direction of privatization for many enterprises.
Mixed Economies	
	Many nations have mixed economies that combine public and private ownership to different degrees. Great Britain, the Netherlands, and Chile are a few examples.
Today's Challenges	
	The environment of business today includes several major influences:
	 Globalization—Increasingly, businesses operate internationally, whether through exporting or importing goods or establishing production and/or marketing facilities overseas. Strategic alliances—Businesses often form alliances with other businesses in order to improve their competitiveness in a market or when they enter new markets. Quality—Commitment to quality is an important factor in business in order to attract new customers and retain old ones. Technology—The pace of technological development means a constant research and development effort to bring new products to the market place and to use technology to the greatest benefit in operations.

- **Outsourcing**—Companies often subcontract internal operations to an outside vendor in order to save money. Examples of outsourced operations include payroll, warehousing, delivery, and data processing.
- Employee empowerment—A growing emphasis on the importance of human resources has meant increased employee control over decision making, more teamwork, and a flatter organization.

INTERNATIONAL BUSINESS

There are three major aspects to international business: (1) **exporting**, or selling U.S. goods and services abroad; (2) **importing**, or buying raw materials, products, and services from businesses in foreign nations; and (3) **foreign production**, making goods and supplying services in a foreign nation for sale there or elsewhere.

LEVELS OF INTERNATIONAL INVOLVEMENT

The most common form of international business is exporting. A company may have an export manager on staff or may rely on an exporting firm for expertise. With **foreign licensing**, a company allows foreign firms to produce and/or distribute its products or services in a particular region abroad. Because there is little capital investment, this is a low-cost way to enter foreign markets. With **overseas marketing**, a company opens a sales office in a foreign nation and manages foreign sales itself. The highest level of international involvement is foreign production, when a company both produces and markets its products overseas. This is sometimes done by means of a joint venture with a local company. Businesses with significant international operations are called **multinational corporations**.

OBSTACLES TO INTERNATIONAL BUSINESS

Doing business internationally can be very difficult, and problems often arise in several key areas. **Cultural misunderstandings** result from a firm's ignorance of key factors such as language, customs, education, social values, religious values, and consumer behavior. **Physical barriers** such as distance, time zone differentials, poor terrain and roads, and lack of infrastructure pose problems for people seeking to do business overseas. **Tariffs** (tax on imported products) and **trade restrictions** such as import quotas impede a firm's ability to trade freely. An **embargo** is a complete restriction on trade of certain products and/or with certain nations. Nations can also restrict trade through currency exchange controls, requiring that foreign businesses buy and sell only through the country's central bank or another designated agency. Although tariffs and trade restrictions continue to affect international business, the trend in recent years has shifted toward relaxing restrictions. The General Agreement on Tariffs and Trade (GATT) is an international agreement that has reduced tariffs and restrictions.

MULTINATIONAL ECONOMIC ORGANIZATIONS

Several multinational economic organizations have been established since World War II to facilitate trade among members, including:

- North American Free Trade Agreement (NAFTA)—This agreement established a free trade zone consisting of the United States, Canada, and Mexico.
- **European Union**—This is a common market of twelve nations working together to reduce trade barriers. It has adopted a common currency, the euro, to facilitate trade.

GOVERNMENT AND BUSINESS

Some government activity benefits and supports the interests of business. For example, the U.S. Census Bureau collects and makes available huge amounts of demographic information that businesses use in marketing. Other agencies provide information and assistance to businesses. The government also funds much of the basic research that leads to new product development. It is a major consumer of products and services sold by American businesses.

REGULATIONS REGARDING COMPETITION

Some federal laws protect competition, including:

- Sherman Antitrust Act (1890)—Prohibits any contract or agreement entered into for the purpose of restraining trade. This includes price fixing, market allocation, and boycotts in restraint of trade.
- Clayton Act (1914)—Prohibits five practices: price discrimination, the tying agreement, the binding contract, the interlocking directorate, and the community of interests.
- Federal Trade Commission Act (1914)—Created the Federal Trade Commission (FTC), which investigates illegal trade practices and enforces antitrust laws.

OTHER **R**EGULATIONS

Many government agencies have regulatory power over specific aspects of business. A few of these include:

- Environmental Protection Agency—Regulates pollution
- Equal Employment Opportunity Commission—Regulates discrimination in employment practices
- Federal Communications Commission—Regulates broadcast, telephone, and telegraph communication
- Interstate Commerce Commission—Regulates railroads, bus lines, trucking, pipelines, and waterways

FORMS OF BUSINESS OWNERSHIP

SOLE PROPRIETORSHIP

A **sole proprietorship** is a business owned and operated by one person. It is the oldest and simplest form of ownership. About two thirds of the businesses in the United States are sole proprietorships.

Sole proprietorships are easy to start and easy to dissolve. All the profits from the business belong to the owner. Since decision making is done by just one person, it is easy to change the business's operations. Sometimes there are tax advantages, because the income of the business is taxed as the personal income of the owner. On the other hand, the owner has unlimited liability for all debts. He or she has a limited ability to borrow and limited skills and knowledge. In the event of the owner's death, the business dissolves.

PARTNERSHIP

A **partnership** is an association of two or more people to act as co-owners of a business for profit. About one tenth of U.S. businesses are partnerships. There are many types of partners, including (1) a **general partner**, who assumes full or shared responsibility for the operation of the business; and (2) a **limited partner**, who contributes capital to a business but does not take part in managing it.

Partnerships are easy to form; there are multiple sources of capital, all profits belong to the partnership, there are several sources of business skills and knowledge, and the partners have a strong personal interest in the business. Disadvantages include unlimited liability for general partners, the lack of continuity in cases of death, the potential for serious disagreements among partners, and difficulty in withdrawing the partner's investment from the firm.

CORPORATION

A **corporation** is an artificial person created by law, with most of the legal rights of a person. The corporation is owned by people called shareholders, or stockholders, in the form of shares of stock. A **close corporation** is owned by a few people and is not openly traded on a stock market; an **open corporation** is one whose stock is traded openly and can be bought by anyone. About one fifth of U.S. businesses are corporations; they earn about nine tenths of sales.

One of the main advantages of a corporation is that it is a separate legal entity with limited liability on the part of the owners. Other advantages include easy transfer of ownership through the sale of stock, ease of raising capital, perpetual life of the business, and specialized management. Disadvantages include difficulty and expense of formation, much government regulation, double taxation of income, and lack of secrecy.

SMALL BUSINESS, ENTREPRENEURSHIP, AND FRANCHISES

According to the Small Business Administration, a **small business** is "one which is independently owned and operated for profit and is not dominant in its field." The size of a small business can vary considerably, depending on the industry. Certain industries are suitable for small businesses because they do not require a huge outlay of capital: retailing, wholesaling, transportation, services, financial services, agriculture, construction, mining, and some manufacturing.

Small businesses are usually operated by the entrepreneurs who started and own them. Most entrepreneurs are between the ages of 25 and 44, and they have acquired the knowledge and management ability to run a successful business, often by working for another firm. These small businesses promote technical innovation, provide employment, and compete with larger firms in certain niches.

More than 70 percent of new businesses fail within the first five years, usually because of problems with capital, management, and/or planning. Entrepreneurs often lack the capital to run a business during the sometimes lengthy startup phase when there are no profits. Many start with a good idea but lack the management skills needed to run a business. Sometimes success and overexpansion tax the capacity of the business to function effectively. A **franchise** is a license to operate an individually owned business as if it were part of a chain. The **franchiser** provides the business name, management skills, business methods and procedures, training, and any required materials. The **franchisee** provides capital and labor and operates the business abiding by the terms of the franchise agreement. Oil company service stations, new car dealers, soft drink bottlers, and fast food outlets are usually franchises.

THE MANAGEMENT PROCESS

MANAGING THE ORGANIZATION

Before a business can operate effectively, it must have an articulated purpose and a plan for achieving that purpose. To these ends, the top managers of a company formulate a **mission statement**, a written explanation of a company's aims. The mission statement may include information about goods, services, and markets as well as less tangible matters, such as beliefs, values, and attitudes. Top managers also set forth objectives, goals that the company should accomplish in specific areas such as sales and customer service.

MANAGEMENT FUNCTIONS

The basic management functions include five broad processes:

- **Planning** is the process of establishing guidelines for achieving objectives. The outcome of the planning process is a plan, a road map for achieving goals.
- **Organizing** is a natural outgrowth of planning. At its most fundamental level, organizing involves a division of labor and an allocation of resources. For instance, there are thousands of tasks that need to be done in order to accomplish an organization's objectives.
- **Staffing** begins with the organization's structure—the kinds of jobs and workers that are needed to meet the organization's objectives.
- **Directing** involves using human relations skills, technical skills, and administrative skills to guide the activities of employees.
- **Controlling** ensures that plans are being carried out and objectives are being reached.

MANAGERIAL DECISION MAKING

Decision making is the process of examining alternative solutions to a problem and choosing one of them. Managers are required to make decisions about complex problems in a variety of situations. To do this effectively, they use a systematic approach involving four steps:

- 1. Identify and define the problem or opportunity.
- 2. Come up with alternative solutions or approaches.
- 3. Select the most effective and practical alternative.
- 4. Implement the decision.

HUMAN RELATIONS

Human relations are an important aspect of management. To succeed, managers must be able to motivate, lead, and effectively communicate with people.

- **Motivation** is that which energizes, directs, and sustains human behavior. Employees can be motivated by monetary rewards and by the satisfactions built into their jobs.
- Leadership is the ability to get others to do what the manager wants them to do without coercion. Typically, a good leader can adjust his or her leadership style to match the leader's abilities, the situation at hand, and the people involved.
- **Communication** is a key activity in a well-run organization, especially in ensuring that objectives are met and employees are satisfied. Two-way communication between management and employees as well as top-down communication ensures that information is disseminated throughout an organization.

SOCIAL RESPONSIBILITY, BUSINESS ETHICS, AND REGULATION

In a business that values **social responsibility**, management assesses the effect of business decisions and actions on society as well as on the business. Three major areas of social concern are consumers (product safety, public health, product information, product choices, and the resolution of complaints), employees (equal employment opportunity, affirmative action, and retraining), and the environment (safety, pollution, conservation). **Business ethics** is the application of moral standards to business situations. In an organization with an ethical corporate culture, ethical guidelines are clearly stated and communicated to employees, managers are committed to ethical values, normal business practices reflect ethical values, and managers are trained to make ethically sound decisions.

Ideally, businesses would regulate themselves, behaving in an ethical and socially responsible manner. In reality, the government must impose regulations to help ensure that businesses operate in an ethical and socially responsible manner. Regulation exists in the areas of maintaining fair competition, specific business practices, consumer protection, environmental protection, employment practices, etc.

HUMAN RESOURCE MANAGEMENT

Human resource management consists of the activities required to acquire, maintain, and develop the human resources of an organization. In very small organizations, the owner or manager performs all the human resource management functions. In large organizations, a human resource department is responsible for these activities. Human resource management can be divided into three main areas: acquiring human resources, maintaining human resources, and developing human resources.

HUMAN RESOURCE ACQUISITION

Acquiring the appropriate people to staff an organization has several basic steps. These include:

- **Planning**—From the company's strategic plan, human resource managers can forecast the future staffing needs of the organization and come up with a plan to meet them.
- Job analysis—Through job analysis, the organization determines the elements and requirements of each job and comes up with job descriptions and job specifications (the skills and qualities needed to perform a job).
- **Recruitment, selection, and orientation**—The human resource staff finds appropriate candidates, evaluates and chooses the best candidates, and introduces them to the organization and the job.

HUMAN RESOURCE MAINTENANCE

The chief activity involved in maintaining a firm's human resources is to reward employee effort through compensation (monetary payment) and benefits (services or expenses paid by the company).

The **compensation system** of a firm must be positioned relative to the pay levels of competing firms in the industry. Within the organization, the relative wages for all positions must be determined. Finally, the specific payment that an individual worker receives must be decided upon. Compensation may take many forms, including wages, salary, commissions, bonuses, and profit sharing.

Benefits are a form of compensation that employees receive indirectly. There are several major types of benefits, including payment for time not worked (vacations, sick days), health and security benefits (insurance, retirement plans), and employee services (cafeterias, tuition reimbursement).

HUMAN RESOURCE DEVELOPMENT

Training and development are both aimed at improving employees' knowledge and skills. **Training** generally involves teaching employees the skills they need to do their present jobs; **development** generally prepares employees to take on additional responsibility in the future.

Another function of human resource development is **performance appraisal**, a periodic evaluation of employees' work-related behavior. Conducting performance appraisals accomplishes three basic purposes: providing information upon which salary and promotion decisions are made, reviewing and correcting employee behavior, and providing an opportunity to discuss career development.

LABOR RELATIONS

About one sixth of U.S. workers belong to **labor unions**, organizations of workers that bargain collectively for a labor contract with an employer. The **American Federation of Labor and Congress of Industrial Organizations (AFL-CIO)** is a voluntary federation of about 100 national and international labor unions. Workers belong to a local union, which is a chapter in the national union, which in turn may belong to the AFL-CIO. **Collective bargaining** is the process through which a labor contract is negotiated between management and the labor union. Bargaining must be conducted in **good faith**, meaning that both sides are communicating, negotiating, and matching proposals with counterproposals in an effort to arrive at agreement. Items on which agreement must be reached may be mandatory (such as wages and hours of employment), permissible (pension benefits, employment of strikebreakers), or illegal (closed shop, discriminatory treatment).

PRODUCTION AND OPERATIONS MANAGEMENT

Production is the application of resources like raw materials and people to convert materials into finished goods or services. **Production and operations management** is the management of this process.

Production and operations management often begins with the **research and development (R&D)** effort. The result may be a completely new product or an alteration of an existing product.

Next, operations planning involves the design of both the product and the manufacturing processes. Then, through operational planning, managers determine how to use facilities and resources to produce enough to meet customer demand.

Finally, operations control involves several major functions: purchasing, inventory control, scheduling, and quality control.

MARKETING MANAGEMENT

According to the American Marketing Association, **marketing** is "the process of planning and executing the conception, pricing, promotion, and distributions of ideas, goods, and services to create exchanges that satisfy individual and organizational objectives." The **marketing concept** is an approach to business in which the entire organization, from product development to accounting to sales, is involved with satisfying customers' needs while achieving the organization's goals.

A **market strategy** is a plan that enables an organization to make the best use of its resources in order to meet its objectives. It typically consists of the selection and analysis of a target market and the development of an appropriate marketing mix (a combination of product, price, distribution, and promotion).

TARGET MARKETS

A **target market** is a group of customers and potential customers for whom a firm develops and maintains an appropriate market mix. There are two basic approaches to selecting a target market.

TOTAL MARKET APPROACH

In the **total market approach**, also called the undifferentiated approach, a company designs a single marketing mix for a product or service and directs it at the entire market. The company assumes that individual customers who buy the product have similar needs, and therefore they will all be satisfied with one marketing mix. Examples of products that are often marketed this way are staple foods, such as salt or flour, and certain types of produce.

MARKET SEGMENTATION APPROACH

In the **market segmentation approach**, a company focuses on a market segment, a group of individuals or organizations within a market who share one or more common characteristics. The company develops and directs its marketing mix for a product or service at one or more segments rather than the entire market.

To market successfully, a company must segment a market based on characteristics that actually relate to differences in people's need for a product or service. Common bases of market segmentation include product-related characteristics (end use, brand loyalty), demographic characteristics (age, sex, income), psychographic characteristics (personality traits, lifestyles), and geographic characteristics (region, climate, urban).

MARKETING MIX

PRODUCT

The **marketing mix** consists of four elements in combination: product, price, distribution, and promotion.

A **product** may be an idea, service, or manufactured item. Products are classified according to their ultimate use, the two main types being consumer products and industrial products. A **product line** is a group of similar products marketed by a firm. The company's **product mix** is all the products it markets.

Each product goes through a series of four stages—introduction, growth, maturity, and decline—which together form the product's life cycle. As a product moves through the life cycle its profitability increases, peaks, and then declines. Companies must continually introduce new products in order to replace the declining products.

INTRODUCTION TO BUSINESS

Price	In an ideal world, product prices would be set by the laws of supply and demand. However, sellers do exert some control over the prices of their products, primarily through product differentiation. When setting a price, a company must decide whether it will compete on the basis of having a low price or on the basis of some other characteristic. It also must take into account whether or not price is an important consider- ation in the target market. Prices are generally set based on a combina- tion of costs, demands, and the competition's prices.
Distribution	A marketing channel is a chain of marketers that moves a product from its producer to its ultimate user. For consumer products, the marketing channel may go from producer to consumer; producer to retailer to con- sumer; producer to wholesaler to retailer to consumer; or producer to agent to wholesaler to retailer to consumer. For industrial products, the major marketing channels are producer to user and producer to middle- man to user. Wholesalers are intermediaries who buy products from producers or other intermediaries and sell them to industrial users, retail- ers, or other wholesalers. Wholesalers generally provide product-related services to both producers and other intermediaries. One of the responsibilities of the organizations in the marketing channel is the physical distribution of goods. Physical distribution includes inventory management, warehousing, order processing, materials handling, and transportation.
Promotion	 Promotion is communication with two main purposes: (1) to expedite sales directly by conveying information about a product, idea, or service to a particular market segment; and (2) to expedite sales indirectly, by maintaining good relationships with the various groups in the company's environment. There are several promotional methods that a company can use to communicate: Advertising—Paid message communicated to a selected audience through the media Personal selling—A one-to-one personal communication designed to inform customers and persuade them to purchase the company's products Sales promotion—Activities or materials that offer incentives to consumers or salespeople to buy a product Publicity—An unpaid message, usually in the form of a news story, about a product or company The promotion mix for a particular product is the combina-

• The **promotion mix** for a particular product is the combination of promotional methods put together for that product.

FINANCIAL MANAGEMENT

MONEY

Money is anything used to purchase goods or services. Money (1) functions as a means of exchange, (2) serves as a yardstick of value, and (3) represents a store of value.

In the United States, there are three measures of the supply of money in the economy:

- **M**₁ **supply**—Currency and demand deposits (amounts on deposit in a checking account)
- M₂ supply—The M₁ supply plus certain securities and small-denomination time deposits
- **M**₃ **supply**—The M₁ and M₂ supplies plus large time deposits of \$100,000 or more

The **Federal Reserve System** (the Fed) is the U.S. agency that regulates the supply of money and the banking industry. The Fed controls the money supply by (1) controlling the **bank reserve requirement**, the percentage of deposits a bank must have on hand; and by (2) setting the **discount rate**, the interest rate it charges member banks on loans. When the discount rate is lowered, the money supply increases, decreasing key interest rates and stimulating the economy. When the discount rate is raised, the money supply decreases, increasing interest rates and slowing the economy.

BANKS AND OTHER FINANCIAL INSTITUTIONS

There are several types of banks:

- **Commercial bank**—A profit-making institution that accepts deposits, makes loans, and provides related services
- State bank—A commercial bank chartered by an individual state
- National bank—A commercial bank chartered by the federal government

In addition, there are other types of financial institutions:

- Thrift institutions—Institutions, such as savings and loan associations and savings banks, that offer banking services (home mortgages, savings accounts, loans, and time deposits, etc.)
- **Credit unions**—Member-owned financial cooperatives that pay interest to depositors, make short-term loans, and offer mortgages
- Non-deposit institutions—Insurance companies, pension funds, and consumer and commercial finance companies that offer various types of financial services

FINANCIAL STRATEGIES

Financial management consists of all the activities related to obtaining and using money. Money is needed to start a business and keep it going. In a successful business, the income from sales is enough to keep the business operating. However, sales income does not flow evenly, so temporary funding of operations may be necessary. In addition, money may be needed to finance the purchase of a plant, equipment or to expand into new markets. Thus, businesses have several sources of financing: sales revenue, equity capital (from the sale of stock), debt capital, and proceeds from the sale of assets. Once money is obtained, the firm's financial managers are responsible for monitoring its effective use and its repayment.

Short-term financing is money that will be used for a period of a year or less and then repaid. Sources of unsecured short-term financing (no collateral) include promissory notes issued to suppliers, unsecured bank loans, commercial paper, trade credit, and commercial drafts. Sources of secured short-term financing include loans secured by inventory or accounts receivable and the sale of receivables to factors.

Long-term financing is money that will be used for more than one year, as in a business startup or expansion or for the purchase of assets. Sources of long-term debt financing are the sale of corporate bonds with maturities of up to forty years and long-term loans such as mortgages.

Securities Markets

Securities, or stocks, may be bought in either the primary or secondary markets. In the **primary market**, investors purchase financial securities (common stock or preferred stock) from the issuer of those securities, using the services of an investment bank (a company that assists corporations in raising funds) or another representative. The **secondary market** involves buying and selling securities through a securities exchange or over-the-counter market. The New York Stock Exchange and American Stock Exchange are the largest U.S. securities exchanges. The **over-the-counter market** is a network of stockbrokers who deal in securities that are not traded in exchanges. The National Association of Securities Dealers Automated Quotation (NASDAQ) is a large nationwide over-the-counter market. Both individual and institutional investors buy securities. Institutional investors include mutual funds, pension funds, insurance companies, and commercial banks. **Bonds** are another type of financial instrument. Bondholders are creditors, rather than owners, of a corporation or government agency. The **Securities and Exchange Commission** regulates the stock exchanges and over-the-counter market.

RISK MANAGEMENT AND INSURANCE

A **risk** is the chance that an injury or loss will occur. Some risks are **speculative risks**; they accompany the possibility of earning a profit. Marketing a new widget involves speculative risk because the widget may fail in the marketplace. Other risks are **pure risks**; they involve only the possibility of loss with no potential for gain. Damages caused by weather or accidents are pure risks. **Risk management** is the evaluation of risks faced by an organization and the minimization of their costs. There are several **strategies for risk reduction**: avoiding the risk (never ride in a car), reducing the risk (wear a seat belt), assuming the risk (drive anyway), and shifting the risk (buy auto insurance).

An insurance company assumes financial responsibility, for a fee called a premium, for all or part of a risk. In general, pure risks are insurable and speculative risks are not. In the event of a loss, the insured person or organization cannot collect more than the dollar amount of the loss from the insurer, a concept known as the **principle of indemnity**.

Property and casualty insurance protects the insured against losses of property and losses due to accidents. Businesses may buy fire insurance; burglary, robbery, and theft insurance; fidelity bonds (which protect against theft, forgery, or embezzlement by employees); motor vehicle insurance; business liability insurance, including public liability insurance and product liability insurance; marine or transportation insurance; and business interruption insurance.

MANAGEMENT INFORMATION SYSTEMS AND ACCOUNTING

A management information system (MIS) is an organized method of providing useful and timely information for managerial decision making. The information comes both from internal operations and the external environment. Large organizations generally place responsibility for MIS and computer operations under the chief information officer (CIO). Functions of the MIS include collecting reliable internal and external data; storing and updating data; processing data into a useful form; and presenting information, usually in the form of reports. The basic element of an MIS is the organization's **database**, a centralized, integrated collection of data resources. Computer networks connect the organization's computers internally, and the Internet links the organization to the outside world. While both of these developments have greatly improved access to and use of information, they have also introduced new risks, including computer crime, hacking, and viruses.

Accounting is the process of systematically collecting, analyzing, and reporting the financial information of a firm. Accounting information is used by the organization's management as well as creditors, suppliers, investors, and government agencies. The accounting process is based on the basic **accounting equation**: Assets = Liabilities + Owner's Equity. Double-entry bookkeeping keeps the accounting equation of a firm in balance.

The accounting cycle has several basic steps:

- **1.** Source documents are analyzed to determine which accounts, and therefore which parts of the accounting equation, are affected by a transaction.
- 2. Each transaction is recorded chronologically in a journal.
- **3.** Each journal entry is posted to two or more appropriate ledger accounts.
- **4.** At the end of each accounting period, the balances in the accounts are tallied and checked to ensure that the accounting equation balances.
- **5.** Financial statements, including the income statement, owner's equity statement, and balance sheet are prepared.

GENERAL OVERVIEW

OVERVIEW

The Field of Organizational Behavior

Organizational behavior is the study of how people behave in organizations and the application of this knowledge.

UNDERLYING CONCEPTS

Several fundamental concepts underlie the field. They include assumptions about **human nature**:

- **1.** Each individual is unique.
- 2. In organizations, people function as total human beings.
- 3. A person's behavior is guided by motivations.
- **4.** Every person has human dignity.

They also include assumptions about the **nature of organizations:** (1) Organizations are social systems governed by social laws as well as the psychological needs of their members. (2) Organizations and their members have mutual interests. Thus, the organization and its people form a system of interrelated interactions.

HISTORY

The field of organizational behavior arose from the industrial revolution. In the 1800s, a few factory owners began to recognize the human factor in manufacturing, providing workers with some training and improved working conditions. In 1911 **Frederick W. Taylor** published *The Principles of Scientific Management*, an influential work that described how human factors influence technical efficiency. In the 1920s and 1930s, the idea that an organization is a social system and that its workers are its most important element took hold. In 1957 **Douglas McGregor** first presented his idea that management actions flow from assumptions about human nature. Those who adhere to **Theory X** take an autocratic approach; and those who adhere to **Theory Y** take a humanistic approach. McGregor's ideas helped clarify the field of organizational behavior in the 1950s and 1960s. Contemporary organization theory focuses on the idea of organizations as systems of interrelated variables.

THE STUDY OF ORGANIZATIONAL BEHAVIOR

Studies of organizational behavior follow the **scientific method**: (1) observe phenomena; (2) formulate an explanation for the phenomena; (3) make a prediction or hypothesis about the phenomena; (4) test the hypothesis; (5) draw conclusions about the hypothesis based on the results. The scientific method is applied using one of several basic research designs:

- Naturalistic observation involves watching real-life events.
- In **survey research**, data is collected by means of questionnaires.
- In a **field study**, the researcher studies the relationship between two variables but does not attempt to alter any variables.
- A **field experiment** is similar to a field study, but the researcher manipulates one of the variables to see what effect that has.
- In a **laboratory experiment**, the researcher manipulates a variable in a controlled setting to see its effect.

While naturalistic observation usually yields qualitative data, field studies, field experiments, and laboratory experiments usually yield quantitative data that can be analyzed using statistical methods.

INDIVIDUAL PROCESSES AND CHARACTERISTICS Perception

The process of selecting, organizing, and interpreting stimuli is known as **perception**. At any given moment, the environment contains thousands of stimuli competing for our attention. First, we choose what we will attend to, a process called **selective attention**. We then organize or categorize the stimulus, a process called **perceptual organization.** Perceptual organization is influenced by our prior experiences. Finally, we interpret the stimulus and behave accordingly.

SOCIAL PERCEPTION

The process by which we perceive other people is called social perception. Our perceptions are influenced by the characteristics of:
(1) the person perceived, (2) the situation, and (3) the perceiver.
Barriers to accurate social perception include:

• **Stereotyping**, or attributing characteristics to a person because of his or her membership in a particular group

Dantes/DSST Program

- The **halo effect**, allowing knowledge of one trait to influence knowledge of other traits
- Implicit personality theory, having a fixed set of biases
- Selective perception, limiting our perceptions of others
- **Projection** of our own self-concepts onto the other person

ATTRIBUTIONAL APPROACHES

Attributional approaches to perception and behavior emphasize that behavior is influenced by perception, not actual causes. When a person interprets an event in a particular way, he or she rethinks assumptions about possible causes. Based on the new cognitive structure (way of thinking), the individual makes decisions about behavior. **Locus of control** is an important concept in this approach. An internal locus of control is a feeling that we can personally influence the outcome of events. An external locus of control is a feeling that outcomes are imposed by others.

PERSONALITY Theories of Personality

A person's characteristic way of thinking, feeling, and acting is his or her **personality**. There are several theories of personality:

- **Psychoanalytic**—Personality is the result of conflicts between pleasure-seeking impulses and social restraints.
- **Trait**—Personality expresses biologically influenced dispositions, such as extroversion.
- **Humanistic**—Personality is the processing of conscious feelings about oneself in light of experiences.
- **Social-cognitive**—Personality is influenced by the interrelationships of people and situations and is colored by perceptions of control.

Traits

Personality is usually described in terms of basic **traits**, or characteristic behaviors. Some psychologists recognize five basic trait dimensions that cover a range of behavior:

Emotional stability \leftrightarrow Emotional Instability Extroversion \leftrightarrow Introversion Openness \leftrightarrow Rigidity Agreeableness \leftrightarrow Disagreeableness Conscientiousness \leftrightarrow Carelessness

Personality and the Organization

Some theorists believe there is a fundamental conflict between the needs of a person with a mature personality and the needs of a typical organization. Whereas mature, emotionally stable employees want meaningful work that takes advantage of their internal locus of control, flexibility, and openness, many organizations want employees to follow rules, be dependent, and perform repetitive tasks. The strongest conflict occurs when employees are highly mature, the organization is highly structured and formal, and jobs are fragmented and automated.

ATTITUDES

An **attitude** is a tendency to respond in a favorable or unfavorable way to stimuli in the environment. There are three components to attitudes: (1) beliefs and ideas about a person or object, (2) feelings toward the person or object, and (3) behavioral intentions toward the person or object. **Beliefs** are perceived relationships between people, objects, and events. They differ from values in that they have a basis in fact, or at least in what the person holding the belief thinks is fact. **Values**, on the other hand, are closely held norms. They are standards of idealized behavior.

Attitude Formation and Change

There are four major influences on attitude formation: (1) cultural influences, (2) group membership, (3) family, and (4) prior experience. Since attitudes are learned, they can be modified or altered by providing new information that changes beliefs, by arousing and reducing fear, creating cognitive dissonance (an inconsistency between beliefs and behaviors), and by participation in decision making.

ATTITUDES AND WORK

From the organization's point of view, attitudes relating to job satisfaction are the most important. **Job satisfaction** is a positive emotional state that develops as a result of appraising one's job experience. Job satisfaction differs from employee to employee because it results from comparing what an individual expects of a job to what he or she actually experiences. Job satisfaction affects turnover, absenteeism, and organizational effectiveness.

GENERAL OVERVIEW

Learning	
	Learning is a relatively permanent change in a person's behavior as the result of experience. There are several models of learning:
	• In classical conditioning , we learn to associate two stimuli; for example, that a bell ringing indicates the end of a shift.
	• In operant conditioning , we learn to associate a response and its consequence; for example, that high output results in a bonus.
	• In observational learning , we learn by watching and imitating the behavior of others; for example, that there are standards of dress.
	Learning effectiveness depends on a person's motivation to learn, feedback on performance, prior learning of similar tasks or concepts, whether or not the material to be learned is presented in whole or in part, and if the learning is done in concentrated or distributed sessions. However, the greatest influence on learning is reinforce- ment.
Reinforcement	
	Anything that causes a behavior to be repeated is called reinforce- ment . Positive reinforcement consists of giving someone a reward following a desired behavior. For example, if an employee exceeds her sales quota, her boss gives her a bonus. Negative reinforcement consists of removing something unpleasant following a desired behavior. For example, an employee who completes a task promptly no longer has to listen to his supervisor's reminders. In contrast, punishment is an unpleasant response that reduces or stops a behavior. The frequency and timing of reinforcement affects learning. With continuous reinforcement , learning occurs rapidly, but when the reinforcement is stopped, the desired behavior stops, a process called extinction . With partial reinforcement schedules , the effect on learning varies, and extinction is harder to achieve.
MOTIVATION	

Theories of Motivation

Motivation is that which energizes, directs, and sustains human behavior. There are both process and content theories of motivation.

One cyclical model of the **basic motivational process** includes the following sequence: an inner state of disequilibrium involving needs, desires, and/or expectations; behavior; incentives or goals; feedback; reassessment; and modification if necessary.

ORGANIZATIONAL BEHAVIOR

The best-known content theory of motivation is **Abraham Maslow's hierarchy of needs**. According to Maslow, people are motivated by five basic needs arranged in a hierarchy. Maslow proposed that people generally satisfy their needs in the following sequence: physiological needs, security, belongingness, respect, and self-actualization (self-fulfillment).

A modification of Maslow's hierarchy was proposed by Clayton Alderfer. Known as **ERG theory**, it reformulated needs into three levels: *existence* needs, *relatedness* needs, and *growth* needs. In ERG theory, people both progress and regress as they attempt to satisfy their needs. In addition, more than one need may be activated at a time.

David McClelland developed the idea of the **need for achievement**, one of four important needs in organizational settings. (The others are affiliation, autonomy, and power.) According to McClelland, the need for achievement is characterized by the assumption of personal responsibility for solving problems, a tendency to set moderately difficult goals, a desire for feedback, and a preoccupation with task and task achievement. The need for achievement is an important motive for entrepreneurs.

APPLICATIONS

Very basically, motivation theories suggest that managers should create a work climate that satisfies employee needs. Using the process model, managers can try to change behavior by influencing the motivation of employees at the goal-setting and feedback stages. Jobs can be designed to provide opportunities for personal growth and high achievement.

IMPLICATIONS FOR MANAGERS

McClelland suggests that the best managers do not have a high need for achievement or affiliation. Achievement-oriented managers tend to be too task-oriented; affiliation-oriented managers tend to be indecisive and avoid conflict. In contrast, managers with a high need for institutional power tend to have the most productive and most satisfied work groups.

STRESS

Stress is the psychological and physical reaction to stimuli in the environment that are perceived as threatening. It is the result of a poor fit between individual capabilities and the demands of a situation.

ORGANIZATIONAL INFLUENCES ON STRESS

	Organizational influences on stress include occupational differences (for example, air traffic controllers experience more stress than college professors); role ambiguity, or uncertainty about the job; role conflict; overwork, underwork, or inappropriate work; responsibility for people; and lack of participation. Personal influences include having a Type A personality (impatient, restless, aggressive), locus of control, life-changing events, and abilities and needs.
R ESULTS OF S TRESS	
	Under conditions of no stress, job performance is likely to remain at the status quo. Under low stress, job performance improves acting as a stimulus that increases motivation. Under high stress, job perfor- mance deteriorates because the stress consumes the worker's attention. For an individual, chronic stress can lead to psychological or physical damage, including anxiety, fatigue, and high blood pressure. From the organization's point of view, prolonged stress leads to high turnover, absenteeism, substance abuse, and aggression.
COPING WITH STRESS	
	Individual strategies for coping with stress include increased self- awareness, outside activities and hobbies, regular exercise, and leaving the organization. Organizational strategies include better selection and placement of employees to improve fit between person and job, skills training, job enrichment when appropriate, job rotation, fitness programs, counseling programs, increased employee participation in decision making, increased group cohesiveness, and better communication.

INTERPERSONAL AND GROUP PROCESSES AND CHARACTERISTICS

GROUP DYNAMICS

A **group** is two or more people who share a set of norms, play different roles, and interact to pursue common goals.

TYPES OF GROUPS

There are two basic types of groups: formal and informal. **Formal groups** are work units, such as the accounts payable section of the accounting department, that are set up by the organization. Formal groups are set up by management to accomplish specific tasks; people are assigned roles and many behaviors are prescribed through policies and procedures. **Informal groups** arise naturally as people with common interests, mutual friendship, or similar social needs band together. Informal groups develop norms, roles, and unwritten rules of behavior. People join formal and informal groups for many reasons: a feeling of security, the need for social interaction, the need for self-esteem, economic rewards, and a chance to achieve goals.

GROUP DEVELOPMENT

There are several stages in group development:

- **1.** Testing and dependence—In the first stage, members try to intuit which behaviors are acceptable and which are unacceptable.
- **2. Conflict**—During the early stages of group formation, there is much conflict as members attempt to find their places in the group and to influence the development of norms and roles.
- **3. Group cohesion**—After a while, the group comes to accept its members and develops a sense of unity and common purpose.
- 4. **Performance**—Once the group has a common purpose, members take on specific roles to help achieve group goals.

CHARACTERISTICS OF GROUPS

All groups have norms, roles, and a degree of cohesiveness. A group **norm** is a standard that members agree upon and that regulates their behavior. The social pressure to conform to group norms is very powerful, and members often do so even against their best interest or better judgment. Within the group, work activities are specialized, and each member takes on a **role**, an expected pattern of behavior assigned to a particular position. The third characteristic of groups is **cohesiveness**, the degree to which members of a group are motivated to perform as a group.

GROUP BEHAVIOR AND CONFLICT Types and Levels of Conflict

Groups may have conflicts about goals, thoughts and opinions, feelings and emotions, and behavior. Conflict can be found on several levels as well. There may be intrapersonal conflict within a single individual, interpersonal conflict between two people, intragroup conflict within the group, and intergroup conflict with other groups in the organization.

Functional and Dysfunctional Conflict

Functional conflict can lead to new ideas, procedures, innovation, and change for the group as well as personal growth and development for members. On the other hand, dysfunctional conflict diverts people's energies from job performance and goal achievement. It can negatively affect the psychological well-being of group members, causing stress. Eventually dysfunctional conflict can destroy group cohesiveness.

Conflict Management

Conflict in organizational groups can be resolved in several ways.

- **Problem solving**—The most straightforward way to resolve conflict is to determine its cause and come up with a solution that is acceptable to everyone.
- **Persuasion**—One person attempts to convince another to change his or her opinion about the conflict and/or its solution.
- **Politics**—A person who has accumulated political power in the group or organization uses influence to resolve the problem.
- **Bargaining**—Parties involved in the conflict give something up and gain something, so no clear winner emerges.

LEADERSHIP

Leadership is the ability to get others to do something, not because it is required or that it will result in punishment, but because they want to do it. The leadership process involves three elements: the leader, the followers, and the situation. Successful leadership requires behavior that stimulates followers to behave certain ways in specific situations. Leaders provide task and psychological support to followers and also provide a role model of behavior. To do this, they draw on technical, human relations, and conceptual skills.

Theories of Leadership

Theories of leadership fall into three broad categories: the trait approach, the behavioral or functional view, and the situational or contingency perspective.

Early approaches to leadership were **trait theories**, which focused on the physical characteristics, personality traits, and cultural background thought to characterize leaders. Although theorists posited traits that characterized leaders, research failed to show any significant relationship between these traits and effective leadership.

Another approach to leadership is to focus on **behavioral or functional patterns or styles** used by leaders. Leaders with an **autocratic style** keep power and decision making to themselves. They focus on tasks, taking full authority and responsibility. Leaders with the **democratic style** lead through group input and decision making. Leaders with the **laissez-faire style** play a minor role in the group, allowing the group almost total freedom.

This research was extended into the behavioral aspects of leadership. Two **dimensions of leadership** were proposed: Leaders high on the dimension of **initiating structure** tended to tell employees what to do; and leaders high on **consideration** for others focused on their workers' satisfaction. In the 1960s, two attitudinal/ behavioral dimensions were combined on the **Managerial or Leadership Grid**, which is the concern for people and production. Another approach was to see the role of the manager as two-fold: leader of one group and subordinate in another. This theory, called the **linking pin theory**, views effective leadership behavior as working upward as well as downward.

GENERAL OVERVIEW

Contingency theories of leadership emphasize that there is no single best way to lead; rather, the most effective style of leadership is contingent or dependent upon the situation. Situational (or contingency) leaders are able to adapt their leadership style to both the group and to the situation. Fred Fiedler proposed one of the classic contingency theories; that effective leadership is based on the degree of fit between a leader's style and the extent to which the situation enables him or her to use it. In this view, three factors influence the favorableness of a situation for a leader: leader-member relations; task structure; and leader's position power. Another contingency theory, path-goal theory, is based on expectancy theory and motivation. A leader's effectiveness is based on the ability to clarify the path to an outcome when tasks are ambiguous but to refrain from interfering when tasks are routine. A recent contingency theory is called situational leadership, and it attempts to integrate what is known about leadership into a comprehensive model. It focuses on the amount of direction a leader gives, the amount of socio-emotional support he or she provides, and the readiness of group members to perform appropriately.

Implications for Managers

Even though organizations are highly structured with clear lines of authority and stated objectives, leadership is required to manage effectively. Leaders have a great impact on group performance. Understanding the various theories of leadership and using the appropriate style or behavior in particular situations can improve managerial effectiveness.

POWER AND POLITICS

Power is a person's ability to influence people and events. Power differs from authority because authority is given by higher management, whereas power is earned on the basis of an individual's personality and behavior. **Politics** refers to the ways in which a person earns, gains, or uses power to control events. It may involve compromise, negotiation, trade-offs, conciliation, and many other activities. People who are capable but lack political skills usually do not rise to the top of their organizations.

Interpersonal Sources of Power

In some cases a person acquires power through the force of his or her personality. This type of power, called **referent power**, the **power of personality**, or **charisma**, is an innate quality of an individual. The person has personal attractiveness, self-confidence, and a belief in objectives that others find appealing. People submit to this type of power willingly. Note that a person with this type of power may exist at any level of the organization, in a formal or informal group.

Political power is another type of interpersonal power. It develops as a result of a person's ability to work with people and social systems to gain their support.

Structural and Situational Sources of Power

In most cases a person acquires power as a result of his or her position in an organization. Called **legitimate power**, it arises from the cultural assumption that power can be delegated from higher to lower authorities. Legitimate power gives leaders the ability to direct, reward, and punish others. People accept it because it imposes order on what would otherwise be chaos.

Through **expert power**, people exert influence in situations in which specialized learning is required. Known as the authority of knowledge, it develops as the result of a person's having specialized and extensive skills or information that other people need.

POLITICAL BEHAVIOR IN ORGANIZATIONS

There are many types of political behavior that people use to achieve their goals in organizations. Managers use trade-offs to get something they want in return. Managers form alliances with others to work together toward common goals. They form relationships with people higher up in the organization so that some of the power "rubs off" on them. Managers control the flow of information, withholding information from those who do not cooperate with them. Managers are more helpful to those who in turn help them. They use office space, furniture, and other perks as status symbols. Some managers make power plays, taking power away from others, although this tactic is risky because it invites retaliation.

COMMUNICATION

Communication is the transfer of meaning from one person to another. In order for communication to occur, a **communicator** must encode and send a **message** to a **receiver**, who decodes it and responds. Two-way communication occurs when the receiver sends feedback to the communicator. One-way communication occurs when the receiver decodes the message but does not respond.

In organizations, social factors affect what is said, who can say it, to whom it is said, and how it is said. Perceptual processes influence how messages are decoded. In addition, the structure of an organization influences communication. When messages pass through the levels of a hierarchy, there are many opportunities for distortion.

Communication Styles

Communication is influenced by culture, gender, age, and personality. There are many differences in the way people communicate. One way to identify communication styles is to evaluate the degree of responsiveness to others and the assertiveness that a person displays. People with high degrees of both responsiveness and assertiveness are good, forceful communicators. Those with high responsiveness and low assertiveness may be better listeners than speakers. People with low responsiveness and high assertiveness tend to be autocratic in their dealings with others. Finally, people with low responsiveness and low assertiveness are guarded with others and uncomfortable communicating openly.

Communication Networks

There are several communication network patterns in groups. In the chain, a message is passed from one person to the next, often following the chain of command. The Y pattern is similar to the chain, but it branches. In the wheel, the person at the hub communicates with all of the people on the spokes. In the all-channel pattern, all members of the group communicate with each other. In the circle, a message is passed around until it returns to the original sender.

Barriers to Effective Organizational Communication

In organizations, several problems may arise that interfere with effective communication. Distortion may occur as a message is passed from one person to another. Omission occurs when part of an intended message is left out, whether intentionally or not. Overload occurs when too much information is communicated and the receiver cannot distinguish between what is important and what is not. Some messages are communicated too soon and are forgotten; others are communicated too late to be acted upon effectively. Refusal to accept a message occurs when the sender doesn't have the authority and/or credibility to send it.

Nonverbal Communication

Nonverbal communication often imparts as much information as verbal communication, especially about emotions and attitudes. Body language, gestures, facial expressions, eye contact, smiling, and the use of personal space all convey meaning. Miscommunication sometimes occurs when there are cultural or gender differences in interpreting the meaning of nonverbal cues.

ORGANIZATIONAL PROCESSES AND CHARACTERISTICS Organizational Decision Making

Decision making is the process of choosing one out of many alternatives. There are three stages in the process: (1) recognize and understand the nature of the problem, and look for causes and solutions; (2) formulate and assess alternative strategies to solve the problem; and (3) select the most appropriate alternative.

Models of the Decision-Making Process

There are several models of the decision-making process, all making different assumptions about how individuals and organizations make decisions.

The **econological model** is based on the assumption that people are economically rational and that they try to maximize outcomes in an orderly way. Thus, people will gather all relevant information and choose the alternative that has the greatest benefit. The strength of this model is that it shows how decisions should be made; the weakness is that people do not behave entirely rationally, and so it does not show how decisions are actually made. The **bounded rationality model** assumes that people will try to find the best solution, but they will settle for much less because the decisions they make require more information and thought than they are capable of. In this model, people consider alternatives in sequence, they use heuristics (mental shortcuts) to limit the search for solutions, and they settle for an acceptable, although not necessarily the best, solution.

The **implicit favorite model** assumes that people arrive at a choice intuitively and then distort their assessments of other alternatives in order to justify their initial choice. This model may reflect how unstructured, one-of-a-kind (nonprogrammed) decisions are made, but it does not reflect how repetitive, routine (programmed) decisions are made.

Individual Versus Group Decision Making

Whereas the decision-making process may be similar in individuals and groups, the outcomes differ. Groups are usually better than individuals at establishing objectives and evaluating alternatives, because groups have more knowledge and points of view than do individuals. In identifying alternatives and implementing the decision, individuals perform better than groups where responsibility is diffuse. Finally, in choosing an alternative, a group decision has greater acceptance than an individual decision.

ORGANIZATION STRUCTURE

Organization structure refers to the way in which organizations arrange their human resources in order to accomplish their objectives.

Dimensions of Organization Structure

There are several dimensions in which structure can be understood.

- **Decentralization**—The extent to which power and authority are extended throughout the organization
- **Specialization**—The number of divisions in an organization and the number of specialized sections within each division
- Formalization—The degree to which employee job activities are regulated by rules, procedures, policies, and so on
- Span of control—The number of employees per supervisor
- **Organization size**—The way in which the size of an organization affects its structure
- Work unit size—The way in which the size of a work group affects employee attitudes and behavior

Types of Organization Structure

There are several types of organization structure:

- In a **functional organization**, each group performing related activities reports to a manager responsible for that function.
- In a **line and staff organization**, there are staff departments that advise and support the departments directly involved in producing goods or services, the line departments.
- The **product or divisional organization** is a variation of the line and staff organization, in which each major product line has its own suborganization, or division.
- The **matrix organization** is structured around projects, task-force work, or other one-of-a-kind programs.

Responsibility and Authority

In large part, organization structure determines the authority associated with given positions. Managers must have **authority**, that is, the power to make decisions and take action in order to carry out their **responsibilities**, the tasks, and outcomes for which they are held accountable. Even though managers may carry out their responsibilities through delegation, they remain accountable for getting the job done.

ORGANIZATION DESIGN

There are classical and contingency approaches to organizational design.

Classical Organization Theory

In the classical approach, work is divided by function, level of authority, and level of responsibility (scalar process). Work is communicated and assigned to people by means of delegation. This results in a high degree of specialization. The benefits of specialization are technical and economic, leading to great productivity, and its drawbacks are essentially psychological, especially when specialization is extremely narrow.

In classical theory, span of control determines whether an organization is tall or flat. In a **tall organization**, the span of control is small and managers and supervisors work with few people. Thus, there are many levels in the organization. The tall organization is hierarchical; it permits close contact with employees and close control of work. Communication tends to be vertical, in the chain pattern, providing many opportunities for miscommunication.

In a **flat organization** the span of control is much greater and there are few levels of management. Because each manager has so many people to direct, the time that can be spent with a single employee is very limited. Thus, employees have more control over their own work. In general, employees in flat organizations have less stress, greater job satisfaction, and better productivity than those in tall organizations.

Contingency Organizational Design

The more modern approach to organizations is to be flexible in terms of systems and structure, changing them according to a contingency relationship with the environment. The hallmark of this approach is that the structure that may work best in one environment may not work well in another.

Contingency design distinguishes between mechanistic and organic organizations. In a **mechanistic organization**, control and authority are centralized, tasks are specialized, and lines of communication are vertical, flowing along the lines of the hierarchy. Work is carefully scheduled and apportioned to employees whose roles are strictly defined.

In an **organic organization**, there is decentralization of control and authority, task interdependence, and horizontal lines of communication. Tasks and roles are less rigidly defined, allowing people to adjust to changing conditions. Communication occurs in all directions and consists more of information and advice than rules and instructions. Decision making is more decentralized, and the organization is more open to the environment.

In certain environments, the mechanistic structure is very effective. If tasks are stable, changing little over time, and workers prefer stability, then the mechanistic structure is productive. In addition, if changes in technology, the market, and other environmental factors are minimal, the mechanistic structure works well. On the other hand, organic structures tend to be more effective in dynamic environments, which are typical of modern life. When the environment changes constantly and rapidly, the organic structure provides the flexibility for quick adjustments. When tasks are not well-defined and employees prefer autonomy, variety, and opportunity, the organic structure provides flexibility. Within a single organization, some departments may be organized according to mechanistic principles and others according to organic principles.

CHANGE AND DEVELOPMENT

BASIC PROCESSES AND CONCEPTS

Sources of Change

Management initiates a good deal of the changes that organizations experience. However, management is often not the original source of change. Many changes originate in the external environment. Changes in laws and regulations, technology, markets, customers, labor unions, and so on all result in organizational change. The more dynamic the environment, the more change an organization undergoes.

The Change Process

Instituting a change involves three steps:

- **1. Unfreezing**—Old ideas, procedures, and structures must be gotten rid of.
- 2. Changing—New ideas and practices are implemented so that employees can do their jobs in new ways.
- **3. Refreezing**—The changes that have been made are integrated into the organization's structure and practices.

Individual and Group Change

People are affected in different ways by change. Some have personality traits that allow them to adjust relatively painlessly to new things; others have more rigid personalities. In many cases, change affects employees differently because their roles in the organization differ; some may benefit and others may lose. When an employee has a great deal of trouble adjusting, stress may affect his or her health.

If a group is cohesive, it becomes an instrument of change as long as its social system is not disrupted. Participation with others in change makes the adjustment easier.

Resistance to Change

In instituting change, management tries to restore the individual and group equilibrium that existed before the changes were made. However, this effort often meets **resistance**, or opposition, among both managers and workers. There are three types of resistance to change: logical, based on reasoning; psychological, rooted in emotions and attitudes; and sociological, based on group interests and values.

Organizational Culture

An organization's **culture** is its shared pattern of beliefs, assumptions, and expectations held by its members; their characteristic perceptions of the organization and its environment; and the norms, roles, and values that characterized the organization. An organization's culture affects individual and group behavior, often in subtle ways. Although culture creates social order and has many benefits, it can also discourage change by constraining members to work within the existing framework of beliefs and values.

Organizational Development

Organizational development is a strategy designed to bring about planned change. It uses group processes to focus on the culture of the entire organization, and it views the organization as an operating system. The process of organizational development is time-consuming, and to be successful it must have the support of top management.

A typical organizational development program has many steps, including diagnosis, data collection, feedback, confrontation, action planning, team building, intergroup development, and follow-up.

Some organizational development programs focus on organizational structure and others on employee consideration; still others blend the two approaches of institutional change and take a sociotechnical approach. There are several programs that have been used extensively, including the managerial grid, systems one through four, 3-D management, and enriched sociotechnical work systems.

GENERAL OVERVIEW

OVERVIEW

Personal finance is money management for individuals and households. It covers a wide range of activities, from budgeting to paying taxes to buying a house to investing to estate planning. At any given point during a person's life, the relative importance of different aspects of personal finance changes as needs and goals change.

FINANCIAL VALUES AND GOALS

In the United States, great value is placed on material success. For some, financial success is equated with personal self-worth. For others, material well-being is simply a means to achieve personal goals. Values underlie the financial goals people set (or fail to set). They are the foundation of all personal finance decisions.

The types of goals that involve money vary considerably. However, besides an individual's unique goals, most people have goals relating to basic security, indebtedness, home ownership, college education for their children, recreation, and retirement.

NET WORTH

The first step in a money management program is to prepare a financial statement that lists assets and liabilities to arrive at net worth. **Assets** include land, a house or other buildings, furniture, automobiles, checking and savings accounts, stocks, bonds, mutual funds, and retirement accounts. Items that do not have a cash value (like cars or antiques) are appraised at a reasonable selling price. **Liabilities** include everything a person owes: current bills; a mortgage; a home-equity loan; installment loans (car, education, or other bank loans); credit card balances; and any other indebtedness. **Net worth** is figured by subtracting liabilities from assets.

BUDGETING AND CASH FLOW

The purpose of **budgeting** is to devise a plan to keep expenses within income, distribute spending appropriately, and achieve financial goals. **Income** includes salary, alimony, child support, welfare payments, food stamps, social security, disability payments, financial aid, tax refunds, interest, dividends, and capital gains. **Expenses** are either fixed or variable. **Fixed expenses**, such as a mortgage or rent payment, are the same each month, quarter, or year. **Variable expenses**, such as clothing or vacations, change each period.

The first step in making a budget is keeping track of **cash flow**, money coming in and going out, for a period of time, such as two months. At the end of the period, expenses are classified, totaled, and figured as a percentage of gross income. With this process, it is easy to identify expenses on which too much or too little was spent and to incorporate this into a budget.

Some Basic Economics Terms

INSTITUTIONAL ASPECTS OF FINANCIAL PLANNING

Many organizations play a role in personal finance management. Among them are:

- **Consumer Credit Counseling Service**—An organization that helps consumers pay off debts
- Federal Deposit Insurance Corporation (FDIC)—A federal agency that insures savings accounts of member institutions up to \$100,000 each
- Institute of Certified Financial Planners (ICPA)—An association of financial planners who have passed a certification exam

- National Association of Securities Dealers (NASD)—An association of stockbrokers that has licensing information and consumer complaint information
- Securities and Exchange Commission (SEC)—Government agency that regulates stocks, bonds, and mutual funds and provides free information about investing

CREDIT AND DEBT

CREDIT CARDS

Credit cards allow the consumer to purchase items or obtain cash advances up to a certain credit limit and to carry most of the debt forward from month to month. However, interest is added to the unpaid balance, sometimes at rates as high as 18 to 20 percent.

Choosing a Credit Card

When choosing a credit card, consumers should check the following:

- Annual percentage rate (APR)—The total cost of credit expressed on an annual basis
- Annual fee—A fee that ranges from \$20 to \$100
- **Grace period**—The amount of time finance charges are not assessed if the balance is paid in full before the due date. If a balance is carried on a card, there is usually no grace period for new purchases.
- **Miscellaneous fees**—These may include fees for late payment, exceeding the credit limit, or taking out a cash advance.
- **Minimum payment**—This ranges from 2 to 2.8 percent of the total balance.

Consumers who tend to carry a balance from month to month should look for a card with a low interest rate. Consumers who pay their full balance each month should look for a card with a low annual fee.

Installment Loans

An **installment loan** is a loan that must be paid back in installments over a specific period of time. Interest rates may be either fixed or variable. The most common types of installment loans are car loans, student loans, and personal loans.

Car Loans	
Car Loans	Car loans are offered by automotive finance companies, banks, savings and loans, and credit unions. The term of a car loan ranges from two to ten years, although five years is usually the reasonable maximum for the average car. In general, the term of the loan should not exceed the amount of time the consumer anticipates keeping the car. Car dealers often offer financing for new cars at very low interest rates. These loans usually have conditions: they may be available only on certain models; the consumer must forego a cash rebate; and the low interest rate may be available only with a short-term loan, such as two years, making the monthly payments very large. Credit unions, banks, and savings and loans also offer car loans. In general, credit unions offer loans at nearly a percentage point less than do banks and savings and loans. Rates for used cars are higher than rates for new cars by one to two percent. Finally, homeowners often use home equity loans to finance car purchases. Unlike the other types of car loans, a home equity loan is secured by a house rather than a car. Home equity loans have several advantages: rates are usually lower, interest is tax deductible, and the
Student Loans	loan can usually be paid off over a very long period of time. Student loans are used to finance a college education. Many of these loans are subsidized and insured by the federal government. In general, payment is deferred as long as the student attends school more than half-time.
Personal Loans	A personal loan from a credit union, bank, or savings and loan is the most expensive financing after credit card cash advances. It usually has a term of one to five years and a very high interest rate.
INTEREST CALCULATIONS	The two most important factors in evaluating the interest charged on credit is the annual percentage rate, which includes interest, finance charges, and other fees to yield the yearly cost of credit; and (2) whether or not the financing has a fixed rate or a variable rate . Fixed rate loans have the advantage of having predictable payments. However, variable rate loans may be cheaper in the long run as long as inflation stays in check. Most variable rate loans are adjusted once a year and have a cap on how high the interest can go.

PERSONAL FINANCE

In addition, the way in which credit card issuers compute the account balance makes a difference in the amount of interest paid.

- Average daily balance (excluding new purchases)— Interest is charged on the average daily balance during the billing period without counting new purchases. This method results in the lowest interest charges.
- Average daily balance (including new purchases)— Interest is charged on the average daily balance, including new purchases.
- Two-cycle average daily balance (excluding new purchases)—Interest is charged on the average daily balance for two billing periods, not including new purchases.
- **Two-cycle average daily balance (including new purchases)**—Interest is charged on the average daily balance for two billing periods, including new purchases.

For installment loans, consumers should check whether or not the loan is **front-end-loaded**, meaning that more interest is paid in the early rather than the later months. This costs more than a loan at the same rate with equal interest payments and is disadvantageous if the loan is prepaid.

FEDERAL CREDIT LAWS

If a credit card is lost or stolen and the consumer reports it to the bank before a fraudulent charge is made, the consumer is charged nothing. If the report is made after fraudulent charges are incurred, the consumer is charged a maximum of \$50. If fraudulent use is made of the credit card account number and the consumer is still in possession of the card, the consumer pays nothing.

Billing errors and withheld payments for defective merchandise or services are covered under the **Fair Credit Billing Act**. The credit card issuer must be notified in writing and within 60 days of the bill of the nature of the problem. The card issuer has up to 90 days to resolve the problem. In the meantime, the consumer can withhold payment on the disputed item while paying the other charges.

CREDITWORTHINESS, SCORING, AND REPORTING

Lenders have computer models that define **creditworthy** borrowers—those who can be counted on to repay their debts. They assign points for being in a job for a certain amount of time, owning a home, living in a home for a while, having few credit cards, paying bills on time, having a reasonable debt compared to income, and working in a steady field. If a consumer's score is high enough, he or she qualifies for credit.

Credit reporting agencies keep records of consumers' debt payment history and the amount of credit consumers have. They sell this data to potential credit issuers. Consumers can get a copy of their credit reports for free or a nominal charge. If a consumer has been denied credit, the report is free.

BANKRUPTCY

When consumers cannot pay lenders on time, they should inform the lenders of the problem and try to work out alternative payment plans. If this is unsuccessful, help is available from nonprofit **credit counseling** services. A credit counselor reviews the debts and the consumer's ability to pay them, and then sets up a supervised payment plan of two to three years.

If this fails, the consumer may have to file for **bankruptcy**. Bankruptcy protects the consumer from his or her creditors. However, the consumer has to sell most of his or her assets to satisfy the creditors, and a record of the bankruptcy will appear on credit bureau files for up to ten years. Getting a mortgage or a car loan is nearly impossible during this period.

There are two forms of personal bankruptcy. **Chapter 13**, called the wage-earner plan, has a court trustee supervising the full or partial repayment of the consumer's debts, usually over three to five years. **Chapter 7**, called a straight bankruptcy, apportions most of the consumer's assets among his or her creditors but then wipes out the balance of most of the debts.

MAJOR PURCHASES

CARS, FURNITURE, AND APPLIANCES

Research and Shopping

Because big-ticket items like cars, furniture, and appliances have high purchase prices, careful consumers do research before they shop. Publications like *Consumer Reports* review and report on many products. The consumer can learn not only which brands or makes are preferred but the factors to look for when evaluating an item. With this information, comparison shopping becomes easier. During the shopping process consumers can make the final decision on what to buy and where to buy it.

Lease Versus Buy

Leasing a car has become very popular in recent years, primarily because of the relatively low payments and lack of up-front costs. In a typical lease, the consumer makes preset monthly payments over a specific period of time. At the end of the lease period, the consumer has the option of buying the car for a predetermined price. For consumers who trade cars every few years, use their cars for business, drive less than 10,000 miles per year, and don't have cash for a down payment, leasing may be advantageous. In the long run, leasing costs more than buying, so for consumers who plan to own their vehicles for five or more years, buying is preferable.

Warranties and Service Contracts

Major consumer goods that are bought new come with a **warranty** from the manufacturer that guarantees trouble-free use for a period of time. If the item malfunctions during the warranty period, the manufacturer will fix or replace it at no charge. Some products, like cars and major appliances, have accompanying **service contracts** that consumers can purchase at an additional charge, in effect prepaying for repairs that may not be necessary.

Lemon Laws and Consumer Redress

All fifty states have enacted **Lemon Laws** to extend consumers' protection in the event that a new vehicle turns out to be a "lemon." Although the details vary from state to state, in general these laws state that the car dealer/manufacturer must repair problems; if after a certain number of attempted repairs the problem persists, then the consumer gets a replacement car or a refund.

GENERAL OVERVIEW

	For problems with other products, complaining, usually done in writing, can sometimes net solutions. If negotiating with the retailer or manufacturer is fruitless, consumers can bring their complaints to small claims court . Also called the "people's court," this is a forum in which a consumer can pursue a dispute involving less than a certain dollar amount. In Massachusetts, for instance, the amount is \$2,000.
Housing	
Rent Versus Buy	
	Home ownership has many benefits: a sense of security and satisfac- tion, a nest egg when the mortgage is paid, deductibility of mortgage interest on federal income taxes, use as collateral, and possible appreciation over the years. On the other hand, renting is advanta- geous when circumstances are uncertain, as during a divorce, and when there is no money for a down payment on a house.
Financing	
	There are two basic types of mortgages: fixed-rate mortgages that have interest rates that do not change over the life of the loan, usually fifteen to thirty years; and variable- or adjustable-rate mortgages (ARMs) whose rates can rise or fall along with other interest rates. Most ARMs have fifteen- or thirty- year terms. The interest on an ARM usually cannot rise more than 2 percent in a given year or 6 percent over the life of the loan. The initial interest rate on an ARM is typically 2 percent lower than on a fixed-rate mortgage. Longer-term loans cost more in the long run, but the monthly payments are smaller and it is easier to qualify for them.

Financing Rules of Thumb

There are a couple of rules of thumb that are used in the real estate business to determine whether or not consumers can afford to buy a particular house. The first is that a consumer can afford to finance a house that costs up to 2.5 times gross income. The second is that the monthly debt payments cannot exceed 36 percent of gross monthly income.

Closing Costs

There are many costs associated with the **closing**, the transfer of title from home seller to buyer. These include the loan origination fee and the loan discount cost (points), a fee for credit reports, an appraisal charge (the evaluation of the house's market value), title insurance, transfer tax, and deed reporting fee. These costs can add up to several thousand dollars.

The Role of Professionals

Several professionals are typically involved in a real estate transaction:

- **Real estate agent**—Sells the house and earns a percentage of the sale price as commission; can be used by buyers also
- Lawyer—Helps with the purchase and sale contract and the closing
- Mortgage broker—Helps locate the best mortgage
- Home inspector—Identifies problems with the house
- Appraiser—Assesses market value for the lender

TAXES

The average American household pays about 40 percent of its income in taxes. The taxes include:

- Federal income tax—A federal tax on annual income, including wages and salary, self-employment income, interest, dividends, and capital gains
- **Social security**—A payment of a percentage of income to the social security fund; self-employed people pay the full amount, workers pay half and their employers pay the other half
- **State income tax**—An income tax levied by the state in which the consumer resides and the state in which he or she lives
- **Property tax**—A local tax paid on the assessed value of land or real property, such as a house; property taxes are a major source of revenue for localities
- Excise tax—A state or local tax on the market value of property such as cars and trucks
- Sales tax—A state and/or local tax on the purchase price of (usually) nonfood items
- Estate tax—A federal tax on the value of a deceased person's property over a certain amount
- Gift tax—A federal tax on gifts over a certain amount

PROGRESSIVE VERSUS REGRESSIVE TAXES

I ROORESSIVE VERSOS REO	
	Taxes can be classified as progressive or regressive, depending on their effect on those who pay them. With a progressive tax , the more a person earns, the more he or she pays. The federal income tax is the classic example: as income rises, so does the tax rate. With a regressive tax , the less a person earns, the more he or she pays <i>as</i> <i>a percent of income</i> . Sales tax is the classic example of a regressive tax.
Payroll Taxes	
	To help ensure that citizens pay their taxes, many taxes are withheld from employees' pay and are paid directly to the government(s) by the employer. Amounts are withheld for federal, state, and local (if any) income taxes; social security payments (FICA); and disability taxes. These amounts are deducted from gross pay. When income tax forms for the year are filed, the employee gets a refund if too much has been withheld and pays the balance if too little has been with- held.
Tax Planning	
	The federal tax laws are complex, and over the years many strategies have evolved for minimizing tax liability. These include keeping careful records to back up itemized deductions; shifting income to children, who are likely to be taxed at a lower rate; deferring taxes to later periods; contributing the maximum to a retirement savings plan; investing in tax-exempt securities; selling the most expensive stock, bond, or mutual fund shares first; and using a home equity loan rather than an installment loan for cars and education.
Tax Professionals	
	Two thirds of the nation's taxpayers use professional tax preparers to file their federal income tax return. In general, there are three basic types of preparers: (1) storefront preparers who are employees of large firms such as H&R Block and who usually deal with the most common tax forms; (2) certified public accountants, who have the expertise to deal with all tax matters, from planning to handling audits; and (3) enrolled agents, former Internal Revenue Service (IRS) employees or people who have passed a two-day exam given by the IRS.

THE INTERNAL REVENUE SERVICE

The IRS **audits**, or examines, over a million individual tax returns each year. About 80 percent of taxpayers wind up owing additional tax. In general, the higher the income, the more likely an audit is to take place. Deductions that are larger than the national norm can also trigger an audit. Geographic location can also affect the chances of being audited since IRS regions differ on their audit rate. Simple audits, often involving no more than an arithmetic or transcription error, are usually handled by mail. More complex audits take place at an IRS office.

INSURANCE

The purpose of **insurance** is to protect the insured person and his or her dependents against financial ruin in the event of an unforeseen hazard such as serious illness, accident, theft, fire, or death. The insured person pays periodic **premiums** to the insurance company, which pledges to reimburse claims according to the terms of the **insurance policy**. When purchasing insurance, the consumer needs to balance **risks** against **benefits**. Since the purpose of insurance is to protect against catastrophe, the consumer should only insure against losses that would cause severe financial hardship.

LIFE INSURANCE

A person who has dependents but whose assets would not adequately provide for them in case of his or her death needs life insurance. There are two major types of life insurance.

In **term life insurance**, the premiums go toward the guaranteed death benefit. It is a form of financial protection, such as auto insurance. As the insured person gets older, premiums increase, but until age 70, as long as the premiums are paid, the insurance remains in force. People cancel term life insurance when they have no more dependents or their assets have grown to the point that they can support any remaining dependents.

Cash value insurance is a hybrid financial product. It is life insurance combined with a savings fund. Part of the premium goes toward the death benefit and part goes into a tax-deferred investment account. The balance that builds up in this investment fund is the policy's **cash value**.

PROPERTY AND LIABILITY INSURANCE

Property insurance covers an insured person's losses due to damage or theft of his or her own property. **Liability insurance** protects the insured against claims for injury and property damage brought by others. The most common types of property and liability insurance policies are automobile insurance, homeowner's insurance, and umbrella liability insurance.

Automobile insurance comes with a variety of coverages. Liability protection covers the insured against claims brought by other drivers or property owners who allege that the insured person caused an accident. Collision coverage pays for repairs in the event that the car is damaged. Comprehensive coverage pays for damages from fire, storm, vandalism, or theft. Both collision and comprehensive coverages have **deductibles**, amounts the insured pays out of pocket before the insurance kicks in.

Homeowner's insurance protects the insured person from losses due to theft and damage from fire and other hazards. It also covers the value of the home. The amount of coverage needed is whatever would be enough to rebuild the house if it were leveled. This can be determined as the **replacement cost** (what rebuilding and refurnishing would cost now) or the cash-value cost (the present value of what was destroyed).

Umbrella liability insurance provides additional liability protection beyond that covered by auto and homeowner's policies. Such a policy covers claims against the insured person and members of his or her household arising from negligence on their part.

HEALTH INSURANCE

Health insurance pays part or most medical costs. In the United States, there are several types of health insurance.

Fee-for-service plans cover visits to any doctor the insured person chooses. For an annual premium, these plans pay about 80 percent of medical expenses after an annual per-person deductible is reached. Generally there is a cap on out-of-pocket yearly expenses.

Managed-care plans restrict the insured person's choice of doctors. With a **health maintenance organization (HMO)**, the insured person must choose from doctors on staff or from a list of network doctors. With a **preferred-provider plan**, the insured person can see a doctor that is not on the network list, but reimbursement will be less. In general, managed-care plans cover preventive care as well as health problems and they do not have a deduct-ible.

MEDICARE AND MEDICAID

Americans aged 65 or older have federal health coverage through **Medicare**. Although it covers both hospital stays and doctor visits, coverage is not adequate for most people. To make up the shortfall, many consumers buy a supplemental policy called Medigap insurance. Low-income people may be eligible for **Medicaid**, another federally subsidized health insurance program.

DISABILITY AND OTHER INSURANCE

Disability insurance is designed to replace income if a person becomes ill or disabled for a long period of time. In general, the policy should cover about 60 percent of gross income during the period of incapacitation. For the severely disabled, social security offers disability payments.

Other types of insurance include malpractice insurance, to protect professionals like doctors against liability claims; renter's insurance, to protect tenants against loss of property and liability claims; and long-term care insurance, to pay for nursing home stays.

INVESTMENTS

Investing is using money to make more money. The basic types of investments are cash investments, bonds, and stocks.

CASH INVESTMENTS

Investing in **liquid assets** means that the investment can easily be converted to cash. Types of liquid assets include:

- Checking account—A checking account is used to deposit cash in order to pay bills by writing checks or to obtain cash as needed.
- **Savings account**—A savings account pays a little interest on the deposit.
- **Certificate of deposit**—With a CD, the savings is left on deposit for a predetermined period, from one month to ten years, and penalties are exacted for early withdrawal.
- Money market funds/deposit accounts—This is an account invested in short-term government and corporate bonds.
- Most households should have enough liquid assets for an **emergency fund**; the total should be three to six months' living expenses.

Bonds	
	Bonds are a type of fixed-income investment . They represent money lent by investors to government agencies or corporations. The government or corporation pays the bondholder interest for the use of the money for a specified period of time. Bonds are traded, so their face value can fluctuate. Bonds generally provide a steady stream of income and pay more interest than a savings account. There are many types of bonds, including
	• U.S. Treasury bonds—Payment of face value and interest is guaranteed by the U.S. government, so these are very safe investments. There are a number of these with terms ranging from thirteen weeks to thirty years.
	• Municipal bonds —These bonds are issued by state and local governments. They are exempt from federal tax.
	• Corporate bonds —These are issued by businesses; their value depends on the creditworthiness of the issuer. Top- quality corporate bonds are known as investment-grade bonds; lesser-quality bonds from issuers with less credit quality are called junk bonds. Junk bonds typically pay a higher yield than investment-quality or U.S. Treasury bonds because they carry higher risk.
S тоскs	
	Stocks are equity , or ownership, investments; consumers who own shares of stock own part of the equity of a corporation. Over the long term, stocks generally outperform other types of investments. Over the short term, however, they are volatile.
Stock Exchanges	
	Stocks are traded in stock exchanges , such as the New York Stock Exchange (NYSE) and the American Stock Exchange. Stocks traded on the NYSE include the blue chip companies, the largest and best corporations, such as Exxon and Procter and Gamble. The thirty stocks that make up the Dow Jones Industrial Average and most of the stocks that make up the Standard & Poor's 500 stock index are traded on the NYSE. Stocks that are not listed on any of the stock exchanges are over-the-counter (OTC) stocks. Several thousand of these are part of the NASDAQ Market system, an electronic trading network.

Types of Stock	
	Corporations can issue two basic types of stock. Common stock is the type that most investors buy and sell. It may or may not pay a dividend. In contrast, preferred stock pays higher dividends. If the company goes out of business, owners of preferred stock are paid off before owners of common stock.
Stock Analysis	
	There are two basic types of stock analysis: fundamental analysis and technical analysis. Fundamental analysis is the approach used by most investors. It involves analyzing and assessing a company's management, performance, and prospects. The tools of fundamental analysis are a company's financial reports. There are several key ratios that are used in fundamental analysis, including the price-earnings (P/E) ratio . This is the price of a share of stock divided by the per-share earnings. In general, the lower a stock's P/E, the better the value it is. Technical analysis , on the other hand, involves studying historical trends of the price of the company's, industry's, or market's stocks.
Mutual Funds	
	Investors can buy individual bonds and shares of stock or they can invest in these by buying shares of mutual funds. A mutual fund is a portfolio of stocks, bonds, and money market assets managed by a professional money management firm. Different types of mutual funds trade in different assets or combinations of assets. For example, there are blue chip funds, income funds, and international funds. Unlike stocks, which are usually sold by a broker charging a commission, many mutual funds are sold directly to investors. Buying and selling may be free of commissions, as in a no-load fund , or it may entail paying fees, as in a load fund .
Other Types of Investments	
	Besides money market, bonds, and stocks, there are other types of

investments. **Real estate** includes land, buildings, rental properties, time-shares, real estate mutual funds, real estate investment trusts, and real estate partnerships. **Annuities** are tax-sheltered investments sponsored by an insurance company that pays earnings and a death benefit. Gold and other **precious metals** are regarded by some investors as the ultimate hedge against political and economic chaos. **Commodities** are items such as wheat and orange juice concentrate; investing in commodities involves predicting future price.

Asset Allocation

Diversifying investments reduces the risk that a poorly performing investment will drag down an entire portfolio. **Diversification** is accomplished by dividing the portfolio of investments among the three major asset types: stocks, bonds, and cash.

The percentage invested in each type of asset depends in part on the investor's appetite for risk and on life cycle considerations. In general, stocks are riskier than bonds and bonds are riskier than cash. An aggressive investor may have a portfolio of 80 percent stocks, 10 percent bonds, and 10 percent cash. A conservative investor might have 50 percent stocks, 20 percent bonds, and 30 percent cash. As people grow older, they tend to shift to more cautious allocations.

SOURCES OF INFORMATION

Information about investing is available from several sources. A company's annual report can be obtained from its shareholder relations office. The *Value Line Investment Survey* and *Standard & Poor's Stock Reports* offer data on thousands of companies. The business press covers developments in companies and markets. Finally, the Internet is a source of endless financial data of value to investors.

RETIREMENT Pensions

Some people have employer-sponsored retirement plans called **pensions**. Some pensions are **defined-benefit plans**, in which the employer does most of the funding and the payout is a fixed monthly amount. **Vesting**, or eligibility to receive benefits, generally occurs after a certain number of years of service. The amount received in such a pension depends on length of service, average salary, and the ability of the company to keep paying its pension commitments. Another type of pension is the **defined-contribution plan**, such as the **401(K)**, in which the employee does most of the funding and takes responsibility for investment decisions.

When a person retires, he or she often must decide whether to take the proceeds of a defined-benefit plan or a 401(K) as a lump sum or an annuity. With a **lump sum**, the retiree gets all the money at once and must manage it. With an **annuity**, the retiree gets a monthly payment for life. Deciding which to choose is complex and usually requires the help of professional financial planners.

PERSONAL FINANCE

Social Security Benefits

In addition to pensions, another source of retirement income is **social security** benefits. The amount of these monthly payments depends on a number of factors, including salary over the years, the age at which a person retires, and whether or not anyone else in the household is receiving benefits.

Personal Investments

A third source of retirement income is personal investments. Those designed specifically for retirement include **Individual Retirement Accounts (IRAs)** and **Keogh plans** for the self-employed. Contributions to retirement accounts are often tax deductible.

ESTATE PLANNING

Estate planning is the process of ensuring the smooth transfer of assets after death. One purpose of estate planning is to make sure each asset goes to the person for whom it is intended. To help accomplish this, a **will** is needed. A second purpose of estate planning is to minimize estate taxes, which can reduce the value of an estate considerably. Estate taxes affect those individuals whose estate is worth \$600,000 or more; the amount is set to gradually increase.

OWNERSHIP OF PROPERTY

The disposition of assets after death depends in part on their legal ownership.

- Fee simple—A piece of property is individually owned; if the owner is part of a couple, upon death the asset would have to go through **probate**, a lengthy legal process, to determine ownership.
- Joint ownership or joint tenancy with right of survivorship—Two people share the title to an asset. Upon the death of one of them, the other automatically becomes the sole owner. If an estate is valued under \$600,000, joint ownership is the easiest way to avoid probate (see below).
- **Tenancy in entirety**—A form of joint ownership recognized in about half of the states. It is available only to spouses and stipulates that in order to dispose of his or her share in the asset, the permission of the other spouse is required.
- **Tenancy in common**—Each tenant has a share in the property and can sell or give away the share at any time to whomever the tenant wishes.

• **Community property**—According to the laws of nine states, property acquired by either spouse during a marriage belongs equally to both, regardless of whose name is on it.

PROBATE

Probate is a legal process that proves the validity of a will and that ensures that the deceased's property is passed to the people who are supposed to get it. Probate can be long and complicated, especially if there is no will or a will is disputed, but many estates go through the process easily, especially if a spouse is the only beneficiary.

The three main ways to avoid probate are to (1) put property into joint names; (2) name a beneficiary for a particular piece of property like a bank account or IRA; or (3) put property in trust. **Trusts** are financial devices used to buy, own, transfer, or sell assets. Some types of trusts save on income taxes or estate taxes; others speed up the processing of an estate after the person dies. Depending on the trust, the person may or may not have to give up legal ownership of the assets.

GENERAL CONCEPTS AND PRINCIPLES

WHAT IS ACCOUNTING?

Accounting is the process of identifying, measuring, recording, and communicating the financial activities of an organization. Identifying financial activities involves observing them and selecting events that are evidence of economic activity and relevant to the organization. Measuring economic events, called **transactions**, involves assigning a monetary value to them. Recording, also called **bookkeeping**, provides a history of transactions. And communicating involves the preparation of financial reports to interested users.

People inside and outside the organization use its financial reports. Internal users require financial information to manage the organization and to prepare tax returns. External users have a financial interest in the organization; they may be investors, creditors, labor unions, government agencies, or financial analysts.

THE ACCOUNTING PROFESSION

Accountants work in three major areas: private accounting, public accounting, and government accounting. **Public accountants**, whether self-employed or members of large accounting firms, provide financial services to other organizations. They may audit a firm's finances, prepare tax documents, and provide management consulting. The best public accountants are **certified public accountants** (**CPAs**), who earn their licenses through education, experience, and examination. **Private accountants** work for business organizations, performing many financial activities, including preparing the payroll, tracking cash inflow and payments, recording purchases and inventory, and keeping records of property. The top accounting executive of a business is the controller. The **governmental accountant** performs many of the same functions as the private accountant, but for a government entity.

GENERALLY ACCEPTED ACCOUNTING PRINCIPLES

The accounting profession has developed a set of standards, rules, and procedures known as **generally accepted accounting prin-ciples (GAAP)**. These describe the basic methods to measure profit and value assets and liabilities. They also prescribe the information that should be disclosed in external financial statements. Their basic purpose is to ensure that financial information is reported consistently from business to business and to establish uniformity in accounting rules and methods.

One important GAAP is that of using cost—the value of something at the time it is bought—to record assets, not market value. Since market value fluctuates, it is not a reliable, objective measure of a held asset.

Two organizations have primary responsibility for these principles: the Financial Accounting Standards Board (FASB) and the Securities and Exchange Commission (SEC). The GAAP rule book is periodically updated as rules are modified or superseded. For reasons of practicality and efficiency, GAAP are generally in agreement with federal income tax accounting rules.

BASIC ASSUMPTIONS

Several assumptions underlie the generally accepted accounting principles. Two of the most important assumptions are the economic entity assumption and the monetary unit assumption.

- The economic entity assumption states that economic events can be associated with a specific unit of accountability. Thus the activities of the entity—which can range from a huge corporation to a church organization—are kept separate. Types of business entities include single proprietorships, partnerships, and corporations.
- The **monetary unit assumption** is that only transaction data that can be expressed as money amounts are recorded in the accounting records.

TYPES OF ACCOUNTS

An **account** is an individual accounting record of increases and decreases in a specific asset, liability, or owner's equity item. In its simplest form, an account has three parts: a title, a left or **debit** side, and a right or **credit** side. (This form is referred to as a **T account** because of its shape.) Entering an amount on the left side of an account is called debiting, and entering an amount on the right side of an account is called crediting. When the totals of the two sides of the account are compared, the account will have a debit balance if debits exceed credits and a credit balance if credits exceed debits.

GENERAL OVERVIEW

Things with value that are used in the operation of a business or other entity are known as assets . The key characteristic of an asset is that it has the capacity to provide future economic benefit to the business, which results in cash inflows. Assets may be tangible, such as trucks, computer systems, or raw materials, or they may be intangible, such as copyrights, patents, franchises, or trademarks. Asset accounts normally have debit balances.
Liabilities are the existing debts and obligations of the business. For example, many businesses buy raw materials and supplies on credit; these are accounts payable accounts. Other types of liability accounts include income tax payable, mortgage payable, and wages payable. Liability accounts normally have credit balances.
The claims of its owners on the assets of a business is owner's equity . There are several types of owner's equity accounts:
• Capital—The investments of owners
• Drawings—The owner's withdrawals for personal use
• Revenues —The increase in equity that results from the sale of products and services or from property rentals and money lending
• Expenses—The costs of assets and/or services used in the process of earning revenue
Owner's equity accounts normally have credit balances.

THE ACCOUNTING EQUATION

The assets of an economic entity are provided by the owners and the creditors. Thus, assets always equal the sum of creditor and owner claims on the business. This relationship among assets, liabilities, and owner's equity is expressed in the **accounting equation**:

Assets = Liabilities + Owner's Equity

The accounting equation provides the framework for recording and analyzing the transactions of a company. At any given time, the equation must be in balance.

TRANSACTION ANALYSIS

Companies make many transactions, both external and internal. Each of these transactions must be analyzed in terms of its effect on the accounting equation. The analysis indicates the specific items that are affected and the amount by which each changes.

Each transaction has two effects on the accounting equation because its equality must be maintained. For example, if an individual asset is decreased, the assets side of the equation decreases. To keep the equation in balance, there must be (1) an increase in another asset, (2) a decrease in a liability, or (3) a decrease in owner's equity. It is also possible that two or more items could be affected when an asset decreases, as long as the total changes to the accounting equation leave it in balance. Changes in individual liability or owner's equity accounts can be analyzed in a similar manner. Here are a few examples to illustrate the process.

Transaction 1. Investment by Owner

THE ACCOUNTING CYCLE

There are several steps in the **accounting cycle**, which begins with an analysis of transactions and ends with a post-closing trial balance.

DAILY ACTIVITIES

- 1. Analyze business transactions. Using source documents such as purchase invoices or salary rosters, decide which accounts are affected and the amount of the change, keeping the accounting equation in balance.
- **2. Record entries in the journal.** The whole transaction is first entered into the journal, a chronological record of transactions.
- **3.** Post entries to ledger accounts. Each transaction results in at least two entries to the accounts in the ledger, the entire group of accounts maintained by a company.

PERIODIC ACTIVITIES (MONTHLY, QUARTERLY, OR ANNUALLY)

- 4. **Prepare a trial balance.** A trial balance is a list of accounts and their balances at a given point in time. Accounts are listed in the order in which they appear in the ledger, debit balances in the left column and credit balances in the right column. The totals of the two columns must agree.
- 5. Journalize and post adjusting entries to the ledger accounts. Adjusting entries are made to ensure that revenues are recorded in the period during which they are earned and that expenses are recognized in the period in which they are incurred.
- 6. **Prepare an adjusted trial balance.** An updated trial balance is prepared. It shows the effects of all financial events during the period.
- 7. **Prepare financial statements.** The balance sheet, income statement, and owner's equity statement can all be prepared using data from the adjusted trial balance.

ANNUAL ACTIVITIES

- 8. Journalize and post closing entries. The balances in the temporary owner's equity accounts (revenue and expense accounts) are transferred to the permanent owner's equity account (capital). This is done because balances in temporary accounts are not carried forward into the next accounting period, but balances in permanent accounts are.
- **9. Prepare a post-closing trial balance.** The purpose of the post-closing trial balance is to prove the equality of the permanent account balances that are carried forward into the next accounting period.

ADJUSTING ENTRIES

A basic assumption of financial accounting is that the economic life of a business can be divided into artificial time periods. However, many transactions affect more than one time period. Thus, accountants must decide what portion of a transaction is relevant to a given time period.

There are two principles that are used to help determine the amount of revenue and expenses to be reported in a given accounting period. According to the **revenue recognition principle**, revenue is recognized during the period in which it is earned, which is not necessarily when payment is made. For example, if a consulting firm does a job for a client during the second quarter, the revenue expected from that job is allocated to the second quarter, even if the firm does not actually receive payment until the third quarter.

According to the **matching principle**, expenses follow revenue and are recognized during the period in which they contribute to the earning of revenue. So, for example, the expense of wages is allocated to the period during which the work takes place, not the period during which the wages are actually paid.

At the end of each accounting period, **adjusting entries** are made to ensure that these two principles are followed and that the resulting financial statements accurately reflect the assets, liabilities, and owner's equity of the business. Adjusting entries may be **deferrals**, or prepayments, or they may be **accruals**.

Accrued Revenues

Revenues that are earned but unrecorded at the end of the accounting period are accrued revenues. They may accrue because of the passing of time, as interest or rent. Or they may accrue as the result of services having been rendered, but neither billed nor collected, as commissions and fees. Before the adjusting entries are made, both assets and revenues are understated. The adjusting entries for accrued revenues involve an increase (debit) to an asset account and an increase (credit) to a revenue account.

Accrued Expenses

Expenses that are incurred but not recorded at the end of the accounting period are called accrued expenses or accrued liabilities. They result from the same causes as accrued expenses and typically involve interest, rent, taxes, and wages. Before the adjustments are made, both liabilities and expenses are understated. The adjusting entries for accrued expenses involve an increase (debit) to an expense account and an increase (credit) to a liability account.

MERCHANDISING TRANSACTIONS

In a merchandising company, most revenues come from the sale of merchandise and are referred to as **sales revenue** or sales. The accounting system also recognizes sales returns, transactions that occur when customers return merchandise, and sales allowances, or deductions from the selling price.

Expenses include the **cost of goods sold** and **operating expenses**. The cost of goods sold is the total cost (to the company) of the goods it sells during an accounting period. This can be determined when each sale occurs if the company is using a perpetual inventory system, or it can be determined at the end of an accounting period if the company uses a periodic inventory system (see page 292).

Sales revenue minus cost of goods sold yields the **gross profit** (gross margin) on sales. After the gross profit has been calculated, the **net income** is calculated by subtracting operating expenses from gross profit.

INTERNAL CONTROL AND CASH

Internal control is an organization's system and procedures for safeguarding its assets from employee theft, robbery, and unauthorized use. A second purpose of internal control is to improve the accuracy and reliability of its accounting system.

INTERNAL CONTROL PRINCIPLES

- 1. Assignment of responsibility. Control is most effective when only one person is responsible for a carrying out a task, authorizing a transaction, or approving a transaction. If an error or fraud occurs, responsibility can easily be determined.
- 2. Separation of functions. When duties are segregated, the work of one employee provides a reliable basis for evaluating the work of another. For example, one person has physical custody of an asset and another keeps the records on the asset.

- **3.** Thorough documentation. Documents provide evidence that transactions and other events have occurred. By having individuals sign off on documents, responsibility for transactions can be traced. Prenumbered documents help prevent a transaction from being recorded twice or not at all.
- 4. Physical, mechanical, and electronic controls. Physical controls include safes, locked warehouses, and fencing; mechanical and electronic controls include cash registers, gasoline pumps, time clocks, sensors, and error-detection software.
- **5. Independent internal verification.** An employee who is independent of the people responsible for the information reviews and checks its accuracy on a periodic or surprise basis.

INTERNAL CONTROL OF CASH

Applications of internal control principles to **cash receipts** include the following: (1) Only designated employees are permitted to handle cash receipts. (2) The tasks of receiving cash, recording receipts, and holding cash are assigned to different people. (3) Documentation includes cash register tapes, remittances, and deposit slips. (4) Safes, bank vaults, and cash registers are used. (5) Daily cash counts are made by cashier supervisors, and comparisons of receipts and deposits are made by the treasurer.

Applications of internal control principles to **cash disbursements** include the following: (1) Only specified individuals are permitted to sign checks. (2) Approving an item for payment and paying for the item are done by two different departments or individuals. (3) Prenumbered checks are used, and each check is supported by an approved invoice or other document. (4) Blank checks are stored in a safe, and a checkwriter is used to imprint the amount of each check in permanent ink. (5) Each check is compared with the approved invoice before it is issued, and bank balances are reconciled monthly.

CURRENT ASSETS

Current assets are resources that are expected to be cashed in, sold, or consumed in the business within a year. Current assets include cash, marketable securities held as short-term investments, receivables, inventory, and prepaid expenses.

MARKETABLE SECURITIES

Short-term or temporary investments include short-term paper (certificates of deposit, money market certificates, treasury bills, and high quality commercial paper), marketable equity securities (stocks), and marketable debt securities (bonds). Investments are characterized as marketable when they can be sold easily for cash. To be classified as a short-term investment, management must intend to sell within the next year or operating cycle.

In accounting for marketable short-term securities, entries are made when the security is bought, when interest or dividend income is earned, and when it is sold. The loss or gain on the sale is recorded.

During the time that marketable equity securities are held, they may gain or lose market value. On the balance sheet, the value of the securities is reported as the **lower of cost or market value**. Because of this, losses in the value of owned stock are recognized, but gains are not.

RECEIVABLES

Receivables are amounts due in cash from individuals and other companies. There are several types:

- Accounts receivable are the most important. These are amounts owed by customers on account. They arise in the normal course of business through the sale of goods or services, and they are expected to be collected within thirty to sixty days.
- Notes receivable are claims of formal instruments of credit and are expected to be paid, with interest, in sixty to ninety days or more.
- Other receivables include interest receivable, loans to company employees, and income tax refunds.

GENERAL OVERVIEW

ACCOUNTS RECEIVABLE

When merchandise is sold on credit, entries are made to the sales revenue and accounts receivable accounts. For financial reporting purposes, accounts receivable are valued at their cash (net) realizable value using the **allowance method**. In order to determine cash (net) realizable value, an estimate must be made of the amount of **uncollectible accounts receivable**. The estimate is usually based on a **percentage of sales** or a **percentage of receivables**. In the percentage of sales basis, management uses past experience and future credit policy to estimate the percentage. To estimate the percentage used in the percentage of receivables method, an **aging schedule** is prepared. Customer accounts are classified according to the length of time they have been unpaid. Then, bad debt percentages based on past history are applied to the totals in each time category to come up with total uncollectibles.

Under the **direct write-off method**, bad debt losses are not estimated and an allowance account is not used. When it is clear that an account is uncollectible, the loss is charged to bad debt expense. In this method, accounts receivable is reported in its gross amount, and the bad debt expense may not be recorded in the same period as the revenue. Thus the write-off method is not acceptable for financial reporting purposes, but it is used for tax purposes.

NOTES RECEIVABLE

A promissory note is a written promise to pay a specified amount of money on demand or at a particular time. The basic accounting issues are the same as accounts receivable: recognizing the notes receivable, setting a value on them, and disposing of them.

INVENTORIES

For merchandising and manufacturing businesses, inventories are often the most significant current asset. The amount of inventory has a large effect in determining the gross profit of a particular period.

In a merchandising operation, inventory consists of many items owned by the company and that are ready for sale. Only one inventory classification, **merchandise inventory**, is needed in this type of company. In a manufacturing company, inventories consist of items ready for sale, called **finished goods**; items still in production, called **work in process**; and items waiting to be used in production, called **raw materials**.

Periodic Inventory System

Inventory quantities are determined by taking a physical inventory or by using a computerized inventory system that tracks items. Items in transit are included in the inventory of the company that has legal title to them according to the bill of sale. After total quantities for each item are found, they are multiplied by unit costs to arrive at the total valuation.

Costing is actually more complicated because the units of a given item may have been purchased at different costs. Some companies use specific identification to match units purchased at each unit cost. Other companies use one of the assumed cost flow methods, based on an evaluation of its effects on the balance sheet, income statement, or income taxes:

- First-in, first-out (FIFO) method—Under the FIFO method, the costs of the earliest goods purchased are the first to be recognized as the cost of goods sold. FIFO often parallels what actually happens, because it is good business practice to sell the oldest units first.
- Last-in, first-out (LIFO) method—Under the LIFO method, the costs of the latest units purchased are the first to be allocated to the cost of goods sold.
- Average cost method—Under the average cost method, the allocation to cost of goods sold is based on a weighted average unit cost.

Perpetual Inventory System

In a perpetual system, there is a continuous record of the quantity and cost of inventory on hand. Perpetual systems are fully computerized. When something is purchased for inventory, its unit and cost data are entered into the computer system. When it is sold, an electronic point of sale terminal updates the perpetual inventory in real time.

PLANT ASSETS

Plant assets, also called fixed assets or property, plant, and equipment, are resources used in the operation of the business and are not available for sale to customers. These assets are expected to last a number of years, over which their value declines, except for land.

They are often divided into four categories: land, land improvements (driveways, sprinkler systems, etc.), buildings, and equipment.

Plant assets are valued at cost, which includes all the expenditures necessary to buy the asset and make it ready for use. Thus the cost of a piece of equipment may include its purchase price, freight, and installation. **Depreciation** is the process of allocating this cost to expense over the asset's useful life, which is an application of the matching principle. There are four depreciation methods:

- **Straight-line method**—The amount of depreciation is the same each period over the life of the asset (an asset valued at \$10,000 that is expected to last four years has a depreciation expense of \$2,500 per year.)
- Units of activity method—In this method, the cost of the asset is divided by the estimated units of production of its service life. The depreciation cost per unit is then multiplied by the number of units during the period to arrive at depreciation expense.
- **Declining balance method**—This is an accelerated depreciation method in which the annual depreciation expense declines over the life of the asset because book value, rather than cost, is used.
- **Sum-of-the-years'-digits method**—This is another accelerated depreciation method. The depreciation rate is based on a fraction, in which the numerator is the years of remaining life and the denominator the sum of the individual years of total life.

Ordinary repairs to assets are charged as revenue expenditures. Additions and improvements are capital expenditures.

CURRENT AND LONG-TERM LIABILITIES

Current liabilities are obligations that are expected to be paid within a year with current assets or by creating other current liabilities. Current liabilities include payroll; accounts payable; and other short-term debts such as notes payable, bank loans payable, taxes payable, and current maturities of long-term obligations. **Long-term liabilities** are obligations that are expected to be paid after one year or from sources other than current assets and current liabilities. Long-term liabilities include mortgages payable, bonds payable, and obligations under employee pension plans.

CURRENT LIABILITIES

For many companies, **payroll** represents the most significant current liability. Payroll includes both **salaries** (the monthly or annual sums paid to managerial, administrative, and sales personnel) and **wages** (the hourly or piecework rate paid to store clerks, factory workers, and manual laborers). Payroll accounting involves paying employees, but it also means maintaining payroll records for each employee, filing and paying payroll taxes, and complying with federal and state regulations regarding compensation. Payroll activities can be divided into four functions: hiring employees, timekeeping, preparing the payroll, and paying the payroll.

Notes payable within a year are classified as current liabilities. When the note is issued and cash is received, the cash account is debited and the notes payable account is credited. During the periods that interest expense accrues, adjusting entries are needed to recognize interest expense and interest payable. When the face value and interest on the note are repaid, the notes payable, interest expense, and interest payable accounts are debited and the cash account is credited.

Sales and the corresponding **sales tax** are rung up separately on the cash register. When the sales account is credited, the sales tax payable account is also credited, and the cash account is debited for the total.

When a company has a long-term debt, part of which is payable in the current year, the amount payable in the current year is reported as a current liability and the balance as a long-term liability. **Current maturities of long-term debt** are often listed on the balance sheet as *long-term debt due within one year*.

LONG-TERM LIABILITIES

To raise large amounts of money, corporations often issue **bonds**. Secured bonds have specific assets pledged as collateral, and unsecured bonds, or debenture bonds, are issued based on the reputation of the borrower. Corporate bonds are traded on securities markets and are purchased by many investors. The present value of a bond is dependent on three factors: the expected dollar amount to be received, the length of time until it is received, and the investor's required rate of return. The process of finding the present value is called **discounting**.

When a corporation issues bonds, the accounting entry debits the cash account and credits the bonds payable account for the face value of the bonds. Over the life of the bonds, entries are required for payment of interest. The bond interest account is debited, and the cash account is credited. At the end of each period, an adjusting entry is required to recognize the interest expense incurred during the period. The bond interest expense is debited, and the bond interest payable is credited. When the final payment of face value and interest is made, bonds payable and bond interest payable are debited and cash is credited.

Long-term notes payable are similar to short-term notes payable except that the term of the note is longer than one year. Mortgage notes payable is a common type of long-term note.

A **lease** allows a renter long-term use of a property for a specified time in return for cash payments. An **operating lease** is for the temporary use of property by the lessee with ownership remaining with the lessor. A **capital lease** is one in which most of the benefits and risks of ownership are transferred to the lessor. The present value of the cash payments for the lease are capitalized and recorded as an asset.

CAPITAL STOCK, RETAINED EARNINGS, AND DIVIDENDS

The ownership of a corporation is divided among those who own transferable units called shares of **capital stock**. In exchange for capital stock, stockholders invest cash and other assets, which are referred to as the corporation's paid-in, or contributed, capital. In contrast, **retained earnings** is the net income that the corporation keeps. It is often called earned capital.

A **cash dividend** is a distribution of cash to stockholders according to the number of shares of stock they own. When a company's board of directors authorizes a cash dividend, an entry is made to debit to retain earnings and credit dividends payable, a current liability account. On the payment date, dividends payable is debited and cash is credited. Dividends may also be paid in the form of stock.

FINANCIAL STATEMENTS

At the end of each accounting period, three financial statements are prepared based on a summary of the accounting data: (1) income statement, (2) owner's equity statement, and (3) balance sheet. The statements are prepared in sequence, as information from the income statement is needed for the owner's equity statement, and information from the owner's equity statement is needed for the balance sheet.

INCOME STATEMENT

An **income statement** shows the revenues and expenses and resulting net income or net loss for the period of time. Its primary focus is on reporting the success or profitability of the company over a specified period of time. The income statement is sometimes referred to as the operating statement because it summarizes the results of operations. Here is Kayla Bell's income statement for the month of September.

OWNER'S EQUITY STATEMENT

The owner's equity statement shows changes in owner's equity for the period of time. It presents the beginning balance in the capital account, additions (here, September's net income), and subtractions.

BALANCE SHEET

The **balance sheet** shows the assets, liabilities, and owner's equity of the business at a specific date. Assets are listed first, followed by liabilities and owner's equity. Essentially, the balance sheet is a statement of the business's accounting equation at a specific moment in time. It is sometimes called the statement of financial position.

ANALYZING FINANCIAL STATEMENTS

The financial statements of a company allow stakeholders to evaluate the liquidity, profitability, and solvency of a company and to compare the company to its prior performance, to other companies, and to industry averages.

There are several basic tools of financial statement analysis. Horizontal analysis, also called trend analysis, is the comparison of data over a period of time to see what the amount and percentage of increase or decrease has been. For example, horizontal analysis can be used to determine whether or not sales increased, decreased, or remained stagnant over a five-year period. Vertical analysis, also called common size analysis, expresses items in a financial statement in terms of percentages of a base amount. For example, cost of goods sold can be expressed as a percentage of net sales. This makes the comparison of companies of differing sizes possible. Ratio analysis expresses mathematical relationships between two amounts as a percentage, a rate, or a proportion. Liquidity ratios measure the short-term ability of a company to pay its current liabilities. Profitability ratios measure the income or operating success of a company over a period of time. Solvency ratios measure a company's ability to survive. There are many of these ratios, but the best known are as follows: the current ratio, which is current assets divided by current liabilities; the **profitability ratio**, which is net income divided by net sales; earnings per share, which is net income divided by the weighted average of common shares outstanding; and the priceearnings ratio, which is the market price per share of stock divided by earnings per share.

The cost principle says that cost, not market value, is the basis for accounting records.

GENERAL OVERVIEW

THE SUPERVISOR'S ROLES AND RESPONSIBILITIES

Achieving the goals of an organization requires that the organization's resources be managed. **Managers** deploy human, information, and physical resources to meet the objectives of the organization. In most organizations, a major distinction between managers and employees is that managers direct the work that employees perform.

However, all managers are not alike. At the top of an organization are the **executives**, managers responsible for establishing the broad objectives, plans, and policies of the organization. Executives are in charge of the **middle managers**, who plan and carry out programs that help achieve the larger objectives set by the executives. In turn, middle managers direct the work of other managers and supervisors who report to them.

WHAT IS A SUPERVISOR?

Under the guidance of a middle manager, a **supervisor** plans, directs, and controls the work done by a group of employees. The actual tasks performed by supervisors may vary considerably, because supervisors are found in all types of organizations, such as retail, manufacturing, services, and government offices. However, the common thread that binds all supervisors is that they are expected to work with and through employees to achieve the goals of their work units. Rather than doing the hands-on work themselves, they are expected to direct and motivate their workers to perform the work.

Skills Needed by Supervisors

To be a successful supervisor, a person needs skills in three areas:

- 1. Technical skills—These are the skills required to perform the jobs done by the hands-on workers. They are extremely important because a supervisor needs to know how to perform the tasks that he or she is training others to do. Technical skills are also required when monitoring the work of others. For example, a supervisor in charge of a group of airline mechanics must be able to maintain and repair airplanes.
- 2. Human relations skills—The ability to get along with others—both individuals and groupsùis essential for a supervisor. Much supervisory work involves motivating, communicating, and negotiating, both with workers and with management.

3. Administrative skills—A supervisor must be able to plan and control the work of a group of people as well as his or her own work. To do this, he or she must understand the organization and its systems and must use or devise systems to manage the work of the group.

The technical skills of supervisors are so various that they are not taught in courses on supervision. Instead, supervision courses focus on the human relations and administrative skills common to all supervisors.

The Many Roles of a Supervisor

Supervisors have a pivotal position in organizations because they provide the interface between management and workers. As such, they play many roles in their daily interactions. They lead, negotiate, facilitate, manage, and communicate in many ways.

- As employees—Supervisors report to middle managers, carry out the objectives of their managers, and are responsible for representing their work groups to management.
- As bosses—In turn, they manage the work of their employees, providing guidance, training, monitoring of workflow, and work conditions. They help head off problems and solve them as they arise.
- As peers—In the course of working in an organization, supervisors draw on the skills and expertise of staff specialists to help them achieve the goals of their work units. In addition, they cooperate with other supervisors in the organization, fostering teamwork across work units.
- As labor relations specialists—Many supervisors oversee a unionized work force, and they are responsible for balancing the objectives of the organization as well as the welfare of its employees.

PROBLEM SOLVING AND DECISION MAKING

Problem solving and decision making are major components of a supervisor's job. **Problems** are disruptive occurrences or unsettled matters that must be solved if the organization is to function properly. Some problems have already arisen or are occurring in the present, such as a cost overrun. And other problems are expected to happen in the future, but they can be forestalled or minimized through good planning now.

GENERAL OVERVIEW

Supervisors solve problems by thoroughly reviewing relevant information to find the causes of problems and then by applying their knowledge and skills to devise potential solutions. At each step of the way, **decision making** is involved. For example, what information is relevant to solving the problem, and what information is irrelevant? Which solution is best? Whenever there is a choice of more than one way to proceed, a decision is required.

VALUES AND ETHICS

The **values** that people bring to their work vary. Some people value work in and of itself; others value their paycheck and little else. Some value their individuality; others value group harmony. A supervisor should understand his or her own values, the organization's values, and individual employees' values in order to develop an understanding of human behavior and organizational culture.

Ethics involves the proper behavior expected of an individual or a profession. Ethics usually involves issues of right and wrong. Supervisors should behave and treat employees ethically.

RESPONSIBILITY AND **A**UTHORITY

Supervisors have many **responsibilities**—the tasks and outcomes they are held accountable for, whether they perform them personally or delegate them to others. For example, controlling costs and meeting deadlines are supervisory responsibilities. In order to carry out their responsibilities, supervisors must have **authority**, that is, the power to make decisions and take action. Ideally, a supervisor has the authority necessary to carry out his or her responsibilities.

MANAGEMENT FUNCTIONS

Like other managers, supervisors carry out their responsibilities by using the basic management functions. These are five broad processes: planning, organizing, staffing, directing, and controlling.

PLANNING

Planning is the process of establishing guidelines for achieving objectives. The outcome of the planning process is a **plan**, or a road map for achieving goals.

Types of Plans—There are several types of plans in organizations.

- **Long-range plans** are usually prepared by higher management. These plans generally focus from one to five years into the future.
- **Short-range plans** are usually the responsibility of supervisors. Short-range plans may involve operations that last a day, a month, a quarter, or a year.
- **Standing plans** involve activities that go on all the time without much change. Standing plans cover matters such as employee discipline, general employment practices, and purchasing procedures.
- **Single-use plans** are drawn up for unique projects and tasks. Designing a new computer game or preparing a departmental budget are examples of activities that require single-use plans.

The Planning Process

The first step in the planning process is to set **objectives**—targets toward which the work unit is expected to move. Some of a supervisor's objectives are set by upper management. Other objectives may be set by the supervisor. Objectives may be very broad, such as making a higher profit each year, or they may be very specific, such as producing 20,000 widgets per week. Whether they are broad or specific, they should be stated as explicitly as possible, explaining both the outcome and the time frame. For example, an objective may be to complete 95 percent of all jobs within budget (the outcome) during the next year (the time frame).

Once objectives are set, then plans can be developed to achieve them. A plan outlines how the objective will be achieved. A plan may include **schedules**, which tell what tasks must be done, who will do them, and when they must be started and finished; and **procedures**, which explain the methods that will be used in step-by-step detail.

GENERAL OVERVIEW

Because planning involves looking into the future and making decisions based on what is known today, plans are often based on incomplete information. Conditions may change in the future, so good plans are flexible, allowing for alternate courses of action.

Part of planning involves scheduling the time of employees. In general, a department should not be scheduled to 100 percent of capacity because that leaves no time for the unexpected, which always occurs. On the other hand, underscheduling has its pitfalls, too. It leaves people stretching tasks to fill the time available. One way to avoid this situation is to have secondary back-up projects to do when regular assignments have been completed.

Time Management and Delegation

How does a supervisor plan his or her own time? In general, a supervisor has two types of time: time under his or her control, and time not under his or her control. The time not under the supervisor's control—for example, a meeting with the boss or an emergency with a customer—cannot be planned. The remaining time can be planned, usually by using **time management** techniques such as setting priorities, using a desk calendar, and preparing a daily "to do" list.

One advantage supervisors have in accomplishing all their work is the ability to **delegate** tasks. In general, supervisors benefit when they delegate work that is below their capabilities, leaving themselves time to focus on the big jobs involving management skills. However, delegation is a skill that must be learned. Many supervisors, especially those new to the job, are uncomfortable with delegating tasks to subordinates, feeling that they themselves could do the job better. Unfortunately, this approach leaves supervisors with an overwhelming workload.

ORGANIZING

Organizing is a natural outgrowth of planning. At its most fundamental, **organizing** involves a division of labor. For instance, there are thousands of tasks that need to be done in order to accomplish an organization's objectives. These tasks can be divided up among various people, each of whom will have a job to do. People with related jobs, such as production jobs or marketing jobs, can be grouped together into departments. Establishing work relationships among the departments allows all the people in the organization to function effectively.

Types of Organizational Structures

There are several ways that organizations can be set up.

- Functional organization—In a functional organization, each group of people performing related activities reports to a functional manager. For example, in a retail organization all the people involved in stocking storerooms, shelves, and displays are in a single department reporting to a single manager. This is the simplest type of organization.
- Line and staff organization—A line and staff organization is a functional organization with additional departments, called staff departments, that give advice and support to the departments directly involved in producing the goods or services, the line departments. For example, in a hotel chain, the line departments may be those involved in operating a particular hotel, and the staff departments may be those providing advertising, computer systems, and legal services.
- **Product or divisional organization**—The product or divisional organization is a variation of the line and staff organization in which each major product line has its own suborganization or division. This is the typical organization for automobile companies such as General Motors, which has Saturn, Chevrolet, and other divisions.
- Matrix organization—The matrix structure is suited for organizations that are structured around projects, task-force work, or other one-of-a-kind programs. In this type of structure, a project manager calls together a team of specialists from various parts of the organization to work together on a project. When the project is complete, the people go back to their home units until reassigned. The matrix structure is often used in research and development firms, consulting organizations, and engineering companies.
- Centralized versus decentralized organization—In a centralized organization, authority tends to be concentrated at the top. There are many levels of management, facilities tend to be in one location, and functions such as computer systems are provided from a single internal source. In contrast, a decentralized organization consists of smaller, more autonomous units centered on product lines, geographic location, or marketing targets. In decentralized organizations, much authority rests with people at lower levels of the organization, such as supervisors.

SPAN OF CONTROL

The number of workers a supervisor must work with is referred to as **span of control**. There is no ideal span of control. If workers perform jobs that are relatively similar and that do not involve many differing tasks, then a supervisor can supervise more workers—up to fifty or so. On the other hand, if the workers perform complex jobs with diverse tasks, the supervisor's span of control is less—perhaps half a dozen people. The key to span of control is the amount of communicating the supervisor must do with each employee. The more interaction that is required, the fewer employees the supervisor can effectively supervise.

Chain of Command

In an organization, just as in the military, there is a chain of command. In general, this means that responsibility, authority, orders, and information start at the top and then proceed downward from one management level to the next without skipping levels or crossing over to another chain of command. Information and requests going upward would follow the same path.

In general, it makes sense to follow the chain of command in a particular organization in order to get things done. However, in emergencies or special situations that may not be possible. In some organizations it is difficult to follow the chain of command because it has not been clearly defined. For example, two people may have overlapping job responsibilities yet report to two different supervisors. Or one person is asked to report to two people. In line and staff and matrix organizations, the chain of command can become blurred when people from different departments collaborate on special projects. In those situations, the chain of command is often worked out through trial and error and experience.

Staffing

Supervisors usually have more people reporting directly to them than do upper-level managers. In addition, they work directly with their staffs to get the work done, whereas middle managers tend to work more with information than with people. Thus, effective staffing is crucial to a supervisor's success on the job.

There are several aspects to staffing. The **staffing process** begins with the organization's structure—the kinds of jobs and workers needed to meet the organization's objectives. The supervisor has little responsibility for this aspect of staffing because it is beyond the scope of his or her work unit. Within the work unit, however, the supervisor is responsible for forecasting how many and what type of employees are needed to accomplish the unit's goals and recruiting, interviewing, and selecting potential candidates, bearing in mind the legal considerations that affect the employment process. Once workers are on staff, the supervisor must orient and train them.

Forecasting Needs

To determine the number of workers needed to accomplish the work unit's goals, the supervisor takes into account typical workloads, schedules, vacations, and absenteeism. In some large organizations, information such as time studies or labor standards is available to help supervisors make more accurate estimates. This information is not necessary, however.

The basic procedure is to figure out what the work unit is expected to produce for the next period. Then the supervisor calculates how many and what type of workers are required to do the work during the time period. This can be done by checking times for previous similar jobs or by breaking down each job into activities and making time estimates for each activity. If the jobs are dependent on machine speed, the estimate is based on that. Allowances are then made for vacations and other absences.

Recruiting, Interviewing, and Selecting

The supervisor's role in recruiting, interviewing, and selecting varies. In a small organization, the supervisor may do everything with the help of a receptionist or secretary. In a large organization, the human resources department may take over the recruitment function and do the preliminary interviews. The selection of a candidate is usually the supervisor's responsibility, although his or her manager may also play a role.

The purpose of **recruitment** is to develop a large pool of applicants, increasing the chance that a suitable person can be found. Word-of-mouth, newspaper classified ads, Internet postings, and government agencies are all ways in which potential workers are found. The application form, brief preliminary interview, and in some cases, performance test, physical exam, and references weed out unqualified people from the pool of applicants. Applicants who pass these steps are then interviewed by the supervisor. The purpose of this **interview** is to determine whether the applicant is a good match for the job, both in terms of technical skills and in terms of personal characteristics. To do this, the supervisor gives information about the job, the organization, and the expectations he or she has and elicits information about the candidate's experiences and plans. The subject matter of the interview is limited by law, as described below.

When **selecting** a job candidate, supervisors try to pick the best-qualified person for the job at hand. They sift through all the information, looking for a good match in terms of skills, values, and personality.

LEGAL CONSIDERATIONS IN THE EMPLOYMENT PROCESS

According to equal employment opportunity laws, potential employees cannot be asked about their race, color, religion, national origin, sex, age, and marital status. Questions about other matters, such as disabilities and physical capabilities, are limited to seeking information directly relevant to the candidate's ability to perform the job for which he or she is being interviewed. Questions about education and experience are generally unrestricted. The important point is that all questions must be relevant to the job in question. In legal terms, questions must be about **bona fide occupational qualifications**.

Tests administered in the employment screening process must also meet several legal standards. Personality, intelligence, or career interest tests must be statistically valid and reliable. Tests of general aptitude are often open to legal challenge by applicants. In general, tests must be directly related to the job's content and must not discriminate unfairly against the person taking them.

ORIENTING AND **T**RAINING

Orienting new employees to the organization and work unit is done by the human resources department and the supervisor in large organizations and by the supervisor alone in small organizations. Topics include pay information, hours, lunch periods, time reporting systems, benefits, calling in sick or late, and safety rules. In addition, the supervisor gives the employee a tour and introduces him or her to coworkers.

	Training workers is the supervisor's responsibility. On-the-job training involves four steps: (1) preparing a worker to learn by explaining the job's larger context and why it is important; (2) demonstrating and explaining the job one step at a time; (3) letting the worker perform each step under supervision; and (4) gradually withdrawing in order to let the employee work on his or her own. In addition to on-the-job training, there are other training methods, including lectures, vestibule training (similar to on-the-job training but done away from the workstation), apprenticeship training, and computer-assisted instruction.
Directing	Directing the work of a group of employees involves several human relations skills and activities. These include leadership, motivation, performance appraisal, working with a diverse work force, maintain- ing discipline, counseling employees, and developing employees.
LEADING	In order to lead, a supervisor must have the ability to get workers to do what he or she wants them to do. Leadership involves the ability to persuade people, to influence their actions through the power and authority of the supervisory position as well as through one's personal power and authority, and to create an atmosphere of rapport in which people are willing to cooperate. There are several styles of leadership:
	 Autocratic leadership—The supervisor is the boss; he or she makes the decisions and gives orders. Democratic leadership—The supervisor consults with employees before making decisions that promotes involvement and teamwork. Participative leadership—The supervisor is a dispenser of information, exercising little control and depending on the employees' good sense to do things properly. This approach works only with mature, experienced workers. Results-centered leadership—The supervisor emphasizes the job to be done and minimizes the personalities involved. Situational leadership—The supervisor chooses a leadership style based on rapport with workers and their personalities, the nature of the situation, and the amount of real authority that he or she possesses. For example, in an emergency, the autocratic leadership style would be appropriate to get quick, effective action.

MOTIVATING

Motivation is the process that makes a person behave in a certain way. According to **Abraham H. Maslow's hierarchy of needs**, an individual may be motivated by the need for survival, security, companionship, respect, and self-actualization (achievement, power, growth, and a sense of personal worth). A good supervisor can help an individual realize these needs in the context of work, promoting job satisfaction and ensuring productivity.

A good deal of motivation comes from the work itself. When jobs are designed with people in mind, job satisfaction and performance improve. Factors that tend to improve workers' motivation include doing a whole job rather than parts of it; having regular contact with users or customers; using a variety of tasks and skills; directing one's own work; getting feedback from work results rather than from others; and having an opportunity for self-development.

APPRAISING PERFORMANCE

Supervisors observe and evaluate their workers' performance informally on a daily basis and usually conduct formal **performance appraisals** once or twice a year, meeting with each worker. In many organizations, the outcome of formal performance appraisals directly influences the employment status of workers, affecting terminations, transfers, demotions, promotions, and raises, although in some organizations seniority or union rules prevail over performance appraisals. Equally important, performance appraisals provide supervisors with a means to improve workers' job performance.

Organizations that conduct formal appraisals usually have very specific guidelines that the supervisor must follow. The format of the appraisal, the job descriptions, and the standards to which employees will be held are all described in detail. There are several basic formats:

- **Behavioral format**—In this format, performance is evaluated in terms of a range of behaviors expected in given job-related situations. Its weakness is that it focuses on behavior rather than results. Still, it is generally considered an effective form of appraisal.
- **Trait format**—This type of appraisal focuses on personality traits such as initiative; its weakness is that it is very subjective.

• **Results-oriented format**—When employees have stated and agreed-upon goals, performance appraisals focus on evaluating whether these goals have been attained. This type of appraisal is not appropriate for line workers whose activities are closely controlled by their supervisors; however, it may be used to evaluate the supervisor's performance.

Like the employment interview, the performance appraisal is subject to legal considerations. Legal issues include equal pay for equal work; discrimination on the basis of age, sex, religion, color, or national origin; accommodation of the disabled and veterans; and equal employment opportunity. To head off legal challenges, supervisors must (1) be sure the appraisal is based on what the job actually requires, (2) be objective in their judgments, (3) base the appraisal on documented facts, and (4) avoid saying anything discriminatory, whether positive or negative.

WORKING WITH DIVERSE EMPLOYEES

Today's workforce consists of men, women, the young, the old, the disabled, and people of various races and ethnic backgrounds. Although there are laws intended to protect individuals against discrimination in employment, and many organizations set up human resources systems to minimize problems, supervisors must interact on a daily basis with people of all types. Human relations and communication skills are essential to ensure the smooth working of groups of diverse people. Supervisors need to strike a balance between supervising everyone according to the same basic principles and allowing for the individuality of each worker.

In addition to dealing fairly with people of diverse backgrounds, supervisors must also cope with troubled employees. Many employees bring personal problems, such as emotional disturbances and substance abuse, to work. Others react to personal difficulties with a high rate of absenteeism. The personal problems of an employee are not the concern of the supervisor unless his or her performance on the job is adversely affected. The challenge for the supervisor is to differentiate between an employee whose troubles are temporary and minor and one whose problems are deep seated and serious. Those in the latter category are beyond the type of help a supervisor can offer; they need professional intervention.

COUNSELING EMPLOYEES

A supervisor may be able to offer limited help in the form of counseling to an employee whose personal difficulties are interfering with job performance. There are three major signs indicating that an employee needs counseling: (1) normal behavior taken to extremes; (2) a high level of anxiety; or (3) inability to cope, resulting in a breakdown.

The focus of employee counseling is problem solving: helping the employee release the internal pressures that are interfering with job performance. During a counseling session, which should take place in private, the supervisor listens and facilitates the discussion. Supervisors should not control the direction of the session, offer diagnoses, opinions, or moral judgments, and criticize and argue. The supervisor should talk only about job performance problems, solutions, and avenues of help.

Counseling rarely has immediate results, so supervisors must be patient. However, if no results are seen after two counseling sessions, the supervisor should report the case, in confidence, to the organization's health professionals.

MAINTAINING DISCIPLINE

Most employees have a good measure of self-discipline. They are willing to behave according to reasonable rules and standards on the job. A supervisor can foster this innate self-discipline by creating a positive motivational climate for employees and creating a cohesive group of workers who will exert considerable peer pressure on possible dissenters.

Despite a positive approach to discipline, from time to time supervisors will encounter people who do not behave acceptably. They may break rules concerning work schedules, safety standards, punctuality, workmanship, and treatment of coworkers, or they may behave in an insubordinate manner, refusing to carry out reasonable work-related instructions. If the behavior is caused by personal problems, it is dealt with first through counseling, as discussed above. If the performance problem persists or is the behavior of a chronic rule-breaker, then disciplinary action is necessary.

Effective discipline requires that disciplinary rules are clearly understood by everyone at the outset. When a rule is broken, disciplinary action should be taken as soon as possible and not delayed. Supervisors must be impartial, consistent, and fair in disciplining employees. And after an employee is disciplined, the supervisor must follow up to ensure that the problem has been solved. Many organizations follow a system of progressive discipline in which the penalties are appropriate to the violation or to the accumulation of violations. Steps in such a system may include informal talks, oral warnings, written warnings, disciplinary layoff, demotion, and termination. At each step the supervisor tries to help the employee improve his or her performance.

DEVELOPING EMPLOYEES

Supervisors are responsible for training and developing their employees. To do this effectively, they keep records for each worker indicating what tasks the worker performs effectively, what tasks the worker needs to be trained to do, and how and when the worker will be trained.

In addition to training employees to do the work expected of them, supervisors can develop the skills of employees who seem to have the potential to take on more responsibility, whether in the context of the existing job or through transfer or promotion. Often this is done by delegating supervisory tasks to the employee or by nominating them for extra training or education to improve their qualifications and prospects for promotion.

CONTROLLING

The purpose of an organization's **control process** is to ensure that plans are being carried out and objectives are being reached. From the supervisor's point of view, this means ensuring that the work unit is attaining production goals and meeting quality standards.

The supervisor's role in the control process is twofold. In one role, the supervisor observes the activities of his or her work unit to see whether tasks are being performed properly, work conditions are appropriate, and results are being achieved as expected. In the supervisor's second role, he or she focuses on problem solving and decision making. He or she identifies the source of the problem, comes up with solutions, and decides which solution to implement.

Steps in the Control Process

There are four steps in the control process.

- 1. Establish performance standards. Establishing standards is actually part of the planning process. Standards of quantity, quality, and time are established during planning as objectives. Also established at that time are tolerances, amounts by which a standard may fall short.
- 2. Collect information in order to measure performance. Many of an organization's systems produce control data, such as time cards or production tallies. In addition, the supervisor collects information through observation.
- **3.** Compare actual performance to the performance standards. The supervisor compares the control data to the standards, and if they are within the tolerance limits, the supervisor takes no further action. If there is a gap between the actual performance and the performance standard, then the supervisor must take action.
- 4. Take corrective action. The supervisor first finds the cause of the gap in performance and then takes steps to remove or minimize the cause, bringing performance back up to standard. It is also possible, if the cause cannot be dealt with, that the plan or standard may need to be changed.

Budgetary Controls

A **budget** is a plan for the expenses incurred in the operation of a work unit during a specific period of time. Some work units have flexible budgets that account for variations in expenses based on expected variations in output. A supervisor may or may not develop the work unit's budget, but he or she is responsible for meeting it. Thus a work unit budget is a major control document for a supervisor.

If there is a deviation from the budget, the supervisor is expected to determine the cause of the deviation and take corrective action. However, since budgets are estimates of future revenues and costs, they are sometimes inaccurate. Changes in economic conditions, costs of materials, or costs of supplies can make a budget inaccurate. Thus, a supervisor should monitor expense costs on a regular basis (weekly, monthly, or quarterly) so that deviations can be controlled or the budget revised.

OTHER TOPICS OF CONCERN TO SUPERVISORS

LEGAL ISSUES

The law plays a role in several areas that affect a supervisor's work. These include, but are by no means limited to, equal employment opportunity laws and occupational health and safety regulations.

Equal Employment Opportunity (EEO) Laws

These laws are an outgrowth of the civil rights movement, and they cover many aspects of employment. Among other things, the laws require equal pay for equal work; prohibit job discrimination in all employment practices on the basis of race, color, sex, religion, or national origin; institute affirmative action programs to redress past discrimination; prohibit discrimination against disabled workers and workers over 40 years of age unless bona fide occupational qualification can be demonstrated; prohibit discrimination against Vietnam veterans by federal contractors; and forbid sexual harassment.

Occupational Safety and Health Act (OSHA)

With the establishment of the Occupational Safety and Health Administration in 1971, the federal government assumed a large role in regulating the health and safety of workers. The standards set by the government provide minimum specifications for exits, environmental controls, noise, radiation, hazardous materials, sanitation, fire protection, and electrical installations, to name just a few items. Organizations are expected to train employees in safety procedures, both general procedures such as fire drills and procedures specific to the industry such as welding. In addition, OSHA requires extensive recordkeeping about accidents. A great deal of responsibility for the implementation of OSHA regulations falls on supervisors.

UNIONS

In a nonunion environment, supervisors must work within the law and the policies of their companies. When supervisors work with employees who are members of a **labor union**, they must also take into account the impact of the labor contract on policies, practices, and procedures. Supervisors are considered the legal representatives of their companies. Their employers are responsible for any actions supervisors take when dealing with employees and unions. The basic labor-management law is the National Labor Relations Act (Wagner Act) as amended by the Taft-Hartley Act. These laws guarantee employees the right to act in a group, if they wish, to bargain for wages, working conditions, and hours. They also prohibit certain unfair practices on the part of management and impose controls on the activities of unions.

If employees are represented by a union, they negotiate with management over the terms of their labor contract, a process called **collective bargaining**. Although supervisors are rarely involved in collective bargaining, their actions over the preceding period influence the terms of the contract. In addition, supervisors are responsible for abiding by the terms of the contract once it has been agreed upon.

INCREASING PRODUCTIVITY

Productivity is a measure of the output created by a set of inputs. In other words, it is a measure of efficiency. It is usually expressed as a ratio: productivity equals output value divided by input costs.

Supervisors can help improve productivity by improving technical factors. They can simplify product or service design, maintain equipment properly, mechanize and computerize operations, improve work area layouts, and improve the condition of materials and supplies. They can also improve productivity by focusing on human factors. Well-trained, highly motivated workers are far more productive than poorly trained, unmotivated workers.

QUALITY CONCERNS

Quality is a measure of the degree to which a product, service, or process conforms to the standards that have been set for it. Although quality is a shared responsibility involving design, materials, purchasing, manufacturing or operations, and inspection, the supervisor is in a unique position to influence the quality of the work produced under his or her guidance. In some organizations there is a formal inspection and quality control function; in others that responsibility falls to the supervisor. Various techniques are used to improve quality, including:

• **Statistical quality control**—This is a technical method that uses frequency-distribution charts, quality control charts, and sampling tables to monitor quality levels. It is often administered by a separate quality control department.

- Zero Defects—In this system, responsibility for quality rests with employees. Everyone in the organization is taught to care about accuracy, completeness, attention to detail, and good work habits. In this system, workers aim for consistently high quality output by eliminating errors in planning and implementation.
- **Quality Circles**—As in Zero Defects, Quality Circles accept high quality as a starting point. People directly involved in a particular procedure, system, operating unit, or product will meet (usually voluntarily) to examine and suggest solutions to common problems of quality.

Another aspect of quality that a supervisor influences is **quality of work life**. This is the idea that work must be psychologically and spiritually rewarding in addition to being monetarily rewarding. Supervisors can improve the quality of work life for employees by being flexible, accepting individual differences in motivation, encouraging feedback, and facilitating work rather than giving orders.

STRESS MANAGEMENT

By its nature, the job of a supervisor is stressful. Poor time management, problems with interpersonal relationships, poor working conditions, uncertainty about responsibilities, inadequate resources, and conflicting demands contribute to the normal stress that supervisors are subject to.

The main goal of stress management is to eliminate or minimize the causes of stress. For a supervisor, this may mean delegating some work and being assertive about problems as well as negotiating solutions with superiors, peers, and subordinates. Another way to reduce stress is more personal: supervisors can take a break, get more exercise, pursue an enjoyable activity or hobby, and, in general, look outward for some perspective.



PRINCIPLES OF SUPERVISION

TEST INFORMATION

This test was developed to enable schools to award credit to students for knowledge equivalent to that which is learned by students taking the course. The school may choose to award college credit to the student based on the achievement of a passing score. The passing score for each examination is determined by the school based on recommendations from the American Council on Education (ACE). This minimum creditawarding score is equal to the mean score of students in the norming sample who received a grade of C in the course. Some schools set their own standards for awarding credit and may require a higher score than the ACE recommendation. Students should obtain this information from the institution where they expect to receive credit.
