OR 2 simple reasons + development/detail e.g. names of species – daffodils/ orchids; details of protected cultivation –heating, hydroponics, etc; details of field cultivation - seasonal, manual, high labour costs, more risk OR overall statement identifying pattern – Difference between input costs/revenue; changes in buying patterns e.g. wealthier/technology e.g. central heating, gm/selling venues e.g. supermarkets, service stations | (3)  |
