Controlled Assessment – Portfolio

- 60% weighting
- Only **ONE** body of work is required
- Candidates are given approximately 45 hours (15 -18 school weeks as a guide) to complete their portfolio –
 a requirement common to all Awarding Bodies
- · Centre-set starting points, briefs, scenarios or stimuli (can be candidate led)
- Guidance on appropriate homework available from OCR

OCR-set Task

- 40% weighting
- Only **ONE** body of work is required
- Candidates have 10 hours of supervised, controlled time to produce evidence for the OCR-set Task unit
- Timetabled to suit the centre; no specified examination window
- OCR-set starting points, brief scenarios and stimuli issued in an early release question paper, which can be given out from 1st January onwards
- Preparatory period determined by the centre no set time limit

General Information

- All OCR GCSE Art and Design specifications are unitised
- Updated endorsement descriptors reflect the new requirements, current technology, processes, techniques and materials
- Candidates' work is assessed and standardised internally, before external moderation by an OCR moderator
- One assessment opportunity per year, as part of the June series
- Assessment marks must be with OCR by 15th May



Benefits of the Changes

- Endorsements: More options available, including:
 - Applied client focused briefs and a vocational approach
 - Critical and Contextual Studies a mix of written and practical responses
- Flexibility: Centres have more freedom to structure their delivery programme to suit their needs
