Source A: Disabled worker wins case for wrongful dismissal against Abercrombie & Fitch

Riam Dean, a 22-year-old law student, accused Abercrombie & Fitch of “hiding” her in a stockroom because her artificial arm didn’t fit with the company’s “look policy”. Today she won her case for wrongful dismissal against the US retail giant.

The employment tribunal heard that Riam was paid £6.50 an hour by Abercrombie & Fitch. She was removed from the shop floor when management at its London store became aware of her disability. She claimed that she had been discriminated against because of her disability.

She was awarded £7,800 compensation for injury to her feelings, £1,077 for loss of earnings, and £136 damages.

Source C: Success for Sarah's Law



The *News of the World* has announced a massive victory in its 'Sarah's Law' campaign to protect children from paedophiles. As a result of this campaign a paedophile alert scheme is set to be extended across the country. All parents will have the right to ask police if anyone with access to their children has a conviction for child sex offences and domestic violence. Police could also pass on information about complaints of abuse even if they have not been proved.



The Home Secretary said that the development of this scheme is a major step forward in our ability to protect children. However, a Liberal Democrat spokesperson urged caution. "We need far more information about this scheme before it is rolled out across the country", he said. "The concern is that this will do nothing for the safety of children and could even lead to an increase in sex offenders."

Source D: The Prime Minister unveils fund to tackle 'climate emergency'

The Prime Minister unveiled a £13 billion global fund to respond to the world's 'climate emergency'.

He announced the spending pledge to halt deforestation, build flood defences and boost renewable energy supplies in the developing world. The pledge is supported by the USA and the European Union.

"The collective power of the Commonwealth must tackle the injustice of climate change. We face a climate emergency because we cannot wait until 2013 to begin taking action," he said.

The new fund will help countries such as Bangladesh to build coastal flood defences. It will reward countries that take action to reduce future carbon emissions by building up renewable supplies.
