Barber's Picture Palace

Paul Johnson remembers the cinema of his childhood in the 1930s in the Potteries. The Potteries is the name given to the small English towns around Stoke-on-Trent in Staffordshire.

Mr Barber was involved in many activities in our town, but the cinema came closest to his heart. In the 1920s, when purpose-built cinemas were rare, Mr Barber had bought an old army lorry, converted it into a mobile film van and toured the Potteries. This proved highly successful. With the money he earned he created Barber's Picture Palace, which he adapted from an old theatre. It had a lot of red velvet, and brass rails separated the different sections. The entrance hall had a curved staircase leading up to the posher seats on the first floor. It was decorated with palm trees in brass pots. Mr Barber was particularly proud of his Ladies and Gents lavatories, 'sumptuously tiled from head to foot' as he put it, in locally made tiles.

Mr Barber, as I remember him, was short and stocky with grizzly hair, pink face and bushy moustache. His eyes twinkled, he had a merry step and he often wore bow ties with his bowler hat. He liked to be in charge. On the Saturday afternoon showing of a special children's programme, it was he who decided who would be let in and who would not.

'Boys,' he thundered, standing in the middle of the entrance. 'Boys! I'll have no fighting or scuffling or horseplay. Form a neat queue with your pennies ready. That's right. No spitting! Who's that low boy that spat? Right – no room for you, you rascal. Turn him away! And look here – who said *you* could come in? Go back home and wash your dirty face! I'll admit no unwashed boys to my palace. D'you hear?'

Boys were hauled out of the queue and thrown out for various reasons, not only dirt.

'I've seen you before, young man, and I don't like your tricks. Turn him away! And you'll not enter, either. Get out of it!'

If he saw a well-dressed little girl, he would show her upstairs, even though she had only a penny. This favouritism favoured me on more than one occasion.

'There's a nice clean tidy boy! Good afternoon, sir, it's a pleasure to entertain you. Send him upstairs!'

In a good mood Mr Barber would take the tray from the ice-cream girl and distribute its contents free. In a bad mood he would address the audience.

'Now look here. I've heard that they call this palace the Flea Pit! Not in my hearing they don't. This is not a flea pit! This glorious palace is scrubbed out, hoovered and dusted every week. Ask Mrs Snape and her team of cleaning ladies! If ever there are fleas in this place, who is it brought them in? You did! They don't grow here. Fleas! I'll flea you!'

Mr Barber is long gone and almost forgotten, I suppose. His palace is a bingo hall or was when I last heard of it. Even in his own day – I remember it well – a new cinema was opened, the Ritz, with a proper sloping floor especially designed for cinema showing. My mother, who would never set foot in Barber's Palace – 'nothing but smoke and fleas in there' she said – was willing to take me to the Ritz. But the Palace had more flavour. You never knew what would happen when Mr Barber was around.
