This mark scheme includes any amendments made at the standardisation meeting attended by all examiners and is the scheme which was used by them in this examination. The standardisation meeting ensures that the mark scheme covers the candidates' responses to questions and that every examiner understands and applies it in the same correct way. As preparation for the standardisation meeting each examiner analyses a number of candidates' scripts: alternative answers not already covered by the mark scheme are discussed at the meeting and legislated for. If, after this meeting, examiners encounter unusual answers which have not been discussed at the meeting they are required to refer these to the Principal Examiner.

It must be stressed that a mark scheme is a working document, in many cases further developed and expanded on the basis of candidates' reactions to a particular paper. Assumptions about future mark schemes on the basis of one year's document should be avoided; whilst the guiding principles of assessment remain constant, details will change, depending on the content of a particular examination paper.

### 1 Using information from <u>Source 5</u>, explain <u>three</u> points about fears over our privacy in the future.

(4 marks)

Examples of indicative content – any other valid points will be credited.

#### Level 0 (0 marks)

No valid response or relevant information.

#### Level 1 (1 – 2 marks)

Simple undeveloped points (identification only) such as:

- recording millions of journeys is not good
- storing information for years is unfair
- constant surveillance is bad.

#### Level 2 (3 – 4 marks)

Some development of points such as:

- recording millions of journeys is unnecessary
- you should be able to play games without being watched
- we have a right to protest it is not a crime
- technology is being used against us.
- NB Full marks (4) should be reserved for candidates who explain three points with clear communication and development.

# 2 Source 1 reveals George Orwell's fears about a society in which we are all watched all of the time.

Using information from Source 2, Source 3 and Source 4, explain how far you think Orwell's fears have come true.

(6 marks)

Examples of indicative content – any other valid points will be credited.

#### Level 0 (0 marks)

No valid response or relevant information.

#### Level 1 (1 – 2 marks)

Simple undeveloped points such as:

- 4.2 million CCTV cameras one for every 14 people (Source 2)
- spying on pupils no place to hide (Source 4).

#### Level 2 (3 – 4 marks)

Some development of points such as:

- 28 cameras within a 200 yard radius of Orwell's flat means he would have been watched most of the time (Source 2)
- images might help police but not everything recorded is a criminal act (Source 3)
- surveillance that is open to abuse (Source 4).

#### Level 3 (5 – 6 marks)

Cross-referencing, developed points and conclusions such as:

- privacy issues are considered in more depth e.g. civil rights
- help vs. damage re. instant feedback
- waste of public money why record millions of innocent people in order to catch a few.

NB Full marks (6) should be reserved for candidates who express clear conclusions and have shown awareness of different views (either from the sources or own knowledge).

Examples of indicative content – any other valid points will be credited.

#### Level 0 (0 marks)

No valid response or relevant information.

#### Level 1 (1 – 2 marks)

Simple undeveloped points such as:

- the Police like to know what we are doing
- it cuts crime.

#### Level 2 (3 – 4 marks)

Some development of points such as:

- the Police can use information to solve crimes
- surveillance saves time so Police officers can be used elsewhere
- the government might want the Police to watch certain people.

#### Level 3 (5 – 6 marks)

Cross referencing, developed points and conclusions such as:

- increased surveillance could mean better use of Police time but has important privacy issues attached
- the state could make use of surveillance to undermine civil liberties.

#### Level 4 (7 – 10 marks)

Clear analysis based on sources and research with well-developed conclusions such as:

- it is not easy to predict the kind of world that we will inhabit in the future and surveillance helps to control the way society develops
- there are very real dangers in allowing personal data to be used by the state references to any of numerous data losses / leaks.
- NB 9 to 10 marks should be reserved only for candidates who make full use of sources and some evidence of additional research/knowledge.

#### Level 0 (0 marks)

No valid response or relevant information.

#### Level 1 (1 – 4 marks)

Simple undeveloped points such as:

- Too many cameras are bad
- People don't like being watched
- It is 1984.

#### Level 2 (5 – 8 marks)

Some development of points such as:

- We should have privacy but there are too many cameras watching us
- It is against our rights to be filmed without our permission
- Why is information kept for so long?

#### Level 3 (9 – 12 marks)

Cross-referencing, developed points and conclusions such as:

- CCTV is good because it protects you but it can also be bad because it can film people who are not committing crimes
- There is too much surveillance in our society ANPR CCTV Internet & phone records
- Orwell got it right about being watched all the time (with examples as above).

#### Level 4 (13 – 16 marks)

Clear analysis based on sources and research with well developed conclusions such as:

- Big Brother is happening where I live because ...
- I do not think that we should go any further with the surveillance society that we have because ...
- Soon all our journeys will be followed, for example...
- More surveillance is a good thing because it stops crimes from happening, for example...

#### Level 5 (17 – 20 marks)

Clear and concise analysis and significant research such as:

- There is no simple answer to this problem but I think that ...
- We should have a balance between security and privacy ...
- In addition to the Sources I have found evidence that ...
- NB 19 20 marks should be reserved only for candidates who analyse / evaluate the evidence and display significant additional research with some personal judgement.
