As these responses have not been through full moderation and do not replicate student work, they have not been graded and are instead, banded "medium" or "high" to give an indication of the level of each response.

3aii) Is your non UK location an MEDC or an LEDC? On what evidence is your answer based? (5)	
Candidate style answer	Examiner's commentary
My non UK location is Manzini in Swaziland. It is part of an LEDC. Most of the people are poor and a lot of them are farmers. The life expectancy is low and AIDS is a big problem.	Medium level answer. The candidate has identified a suitable non UK location and correctly stated that it is an LEDC, supporting this by using a number of correct basic statements.
	The answer could be improved by including greater detail/statistics about the poverty, the employment structure and the life expectancy, or other measures of quality of life.
