





	Q: Study Source A. What dangers faced patients during and after operations at the beginning of the nineteenth century? Use the source and your knowledge to explain your answer. Level 4 (6–7 marks) Candidates show sound understanding of the source and knowledge and understanding of medicine at the beginning of the nineteenth century in order to produce a response evaluating in detail the multiple dangers faced by patients during and after operations at the beginning of the nineteenth century.	7	This is an example of a top level response that may be used as guidance, demonstrating evidence of all three AOs. One danger facing patients during and after operations at the beginning of the nineteenth century was pain. It looks like the operation is really painful — the patient in Source A is being held down and he is screaming. This is because they had no anaesthetics and so the patient had to put up with terrible pain. Some people died of the pain. Another danger was infection. There was no understanding of germs and thus no antiseptics. Operating tools were not kept sterile as shown in the picture where they are lined up on a wooden work bench. Everyone in the picture is wearing normal clothes, not gowns and masks. So if the patient survived the operation they may well have died afterwards of infection.

There are ways in which I agree with this interpretation. Some progress had been made in surgery by the 1870s. In Paré's time, in the sixteenth century, people who had surgery faced a lot of pain and a great danger of infection because of methods such as cauterisation. This was where boiling oil was used to treat and seal wounds on the battlefield. Paré developed an antiseptic ointment made from eggs and oil of roses which helped to prevent infection. However, this new method was not commonly used until much later. But Lister, in Source B, was trying to find a way of stopping infection completely. His carbolic spray did work and did cut down the death rate during and after operations so there was progress. However the source also shows that there was a lot of opposition to the spray from doctors and nurses because it was very unpleasant for them to use. The fact that the source was written by a doctor who worked with Lister means that he did have first-hand experience of how difficult the spray was to use. This increases the reliability of this source as evidence that improvement since Paré was not so great. However this doctor, like many other doctors at the time, clearly was unsympathetic towards the spray and therefore we cannot necessarily trust his judgement of it. Surgery had improved in other areas by the 1870s because anaesthetics had been developed. James Simpson had discovered chloroform in the mid-nineteenth century. This made it possible for patients to have painless operations. On the other hand, one of the big problems in surgery was the loss of blood and this had not been solved by the 1870s. Although blood transfusions were carried out, doctors did not understand about blood groups and so these transfusions were usually unsuccessful. This prevented complicated operations from being carried out successfully. To sum up, there are some ways in which I agree with the interpretation becau

For example, when Fleming went on holiday and left plates of germ cultures behind, he returned to find that spores had entered his laboratory and mould had grown on the germ cultures. This mould had the ability to kill the staphylococcus germs and was later used to produce penicillin which saved the lives of millions of people. Another example is Pasteur. Pasteur discovered his vaccine for chicken cholera because he left one of his team, Charles Chamberland, to inoculate some chickens with some germs. But Chamberland forgot and then left the laboratory for the summer. When Chamberland came back he finally inoculated the chickens, expecting them to die, but they didn't, even when injected with fresh germs. Pasteur realised that the old germs must have protected the chickens, just like in Jenner's vaccine.

The Nazis published this poster because they wanted girls to join the League of German Maidens which was the girls' wing of the Hitler Youth. This organisation intended to indoctrinate young girls into Nazi ways. By the end of the 1930s, 82% of young people belonged to this type of organisation. They were made to do lots of physical education like route-marching and swimming so that they were fit. This was important because in the 1920s the birth rate in Germany had fallen and Hitler wanted it increased so that he could build a strong army. It was therefore important for girls to be healthy and strong to have lots of children. They were also given training in how to be good mothers and wives which was the role the Nazis saw for women. They were also indoctrinated in Nazi views about race to ensure that they only married Aryan men to produce racially pure babies for the Nazi state. The recruitment poster shows a healthy, happy, Aryan girl in her uniform which would encourage other young girls to believe that joining this Nazi organisation led to happiness. This was crucial to Hitler because as explained above, women were essential for his plans. The League was where he could indoctrinate them into his ideas. The source has no date but if it was published during the war, it would have even more importance because that was when the girls worked as nurses or as searchlight operators – all helping the war effort.

The Treaty of Versailles was unpopular in Germany for a number of reasons. The Germans hated the treaty because its terms were dictated by France, Britain and the USA. Germany was not allowed to take part in the talks and if she had not agreed to the terms then Germany would have been invaded by the Allied Powers. Another important reason was that Germany, along with her allies, was forced to accept responsibility for the First World War, this was known as the 'War Guilt Clause'. This was one of the main reasons why it was so unpopular. The treaty also made Germany pay reparations of £6.6 billion. This was almost impossible to pay for a war-torn nation, especially for one that had lost 15% of its economic resources, as well as being required to give up some of her lucrative territories including large areas of Northern France, in the treaty. It would lead to high taxes for generations in Germany.

They produce a response that		There is plenty of evidence that support for the Nazi regime went down during the war years. When the leaders of the Hitler Youth went off to war this left less experienced people in charge and the focus became totally military. This made it less popular and some young people stopped going, showing a lack of support for the regime. A lot of the opposition came from young people who were unhappy with Nazi policies. The Edelweiss Pirates opposed the regime. They beat up Hitler Youth patrols and sheltered army deserters. Another group called the White Rose group led by Hans and Sophie Scholl sent out leaflets attacking Nazi policies towards the Jews. Swing Youth opposed the Nazis by listening to jazz music which the Nazis hated because they associated it with Black Americans and thought it was decadent. There was even a decrease of support in the army and in 1944 there was the bomb plot when von Stauffenberg tried to kill Hitler. However, it is difficult to say how much support for the Nazis declined. Many people did not dare to oppose the regime which was still sending out propaganda about how well the war was going and still using intimidation and violence to keep people in order. Many Germans were loyal to their country and did what they could to help. This might be collecting money and clothes for the war effort, volunteering to fight on the front. In 1941, Germans gave 1.5 million furs and 67 million woollen garments to help clothe the German army in Russia. So it is clear that a lot of people still supported the regime. Overall, the opposition was small and I would have to conclude that most Germans stayed loyal to their country even if not to the Nazis.
