#### **Case Two**

The jurors say that Margaret killed her daughters Agnes, aged two, with a stick as she lay in her cradle, and Matilda, aged four, who was made to sit in the fire. After the crimes she showed her neighbours what she had done. On this evidence the jury says that she was insane at the time of the murders. She is returned to prison until the King's will is known.

#### SOURCE A

There were reports of many worrying events on the eve of the Jesuits' arrival. A woman named Alice Perin, at the age of 80 years, gave birth to a creature with a head like a helmet, a face like a man, a mouth like a mouse, a human body, eight legs, and a tail half a yard long. In May a pack of hounds was clearly seen, hunting in the clouds over Wiltshire. Lord Cecil, Elizabeth, and most of the government took serious notice and the events caused great anxiety for the government's safety.

From a book about Edmund Campion, written in 1935. Edmund Campion was a Jesuit priest.

# **SOURCE B**

I have come out of Germany, being sent by my superiors, and brought myself into this country for the glory of God and to save people's souls.

I never had in mind, and am strictly forbidden by his Holiness the Pope that sent me, to deal in any matters of the Queen's government. These are matters which have nothing to do with my mission and from which I do gladly restrain my thoughts.

Edmund Campion, a Jesuit, describes his purpose in coming to England in 1580.

## **SOURCE C**

Elizabeth began to be more angry against Puritans. Within a few days John Stubbs the author of a book, William Page, who dispersed the copies and Singleton, the printer, were arrested. Sentence was given that their right hands should be cut off. I remember that when Stubbs had his hand cut off, he put his hat on with his left hand, and said in a loud voice, 'God Save the Queen'.

From a book published soon after Elizabeth's death. It describes events that took place in 1583.
