Important update on OCR GCSE History C - British Social and Economic History (1936)

As you currently deliver the OCR GCSE History C specification I would like to make you aware of an important update.

After careful consideration and consultation with centres and historical associations we have made the decision to withdraw the current OCR GCSE History C specification following the June 2010 examinations. We have taken these steps to ensure that the content remains fresh, up to date, and engaging for students. We have therefore reviewed the whole specification, updating and transferring the more popular content to our other History specifications, for first teaching from September 2009.

These changes will broaden your teaching options, giving you a greater choice in what you teach to your History classes.

In order to make these changes as easy for you as we can, we have mapped the content of the History C specification to our reinvigorated and updated History A and History B specifications. This should help you to choose the specification which is most suited to your students' needs.

The last examination session for History C will be in June 2010. This will not affect the two-year GCSE course which you will start teaching from September 2008 for examination in June 2010. If you teach the course in one year, you will still be able to start teaching in September 2009 for examination in June 2010. It's important to note that it will not be possible to carry forward coursework marks for the History C specification beyond June 2010, nor will candidates be able to resit any component in June 2011.
