

- (d) "Children with disabilities experience more prejudice than other children."



- (d) "It is wrong to marry someone against your parents' wishes."



Do you agree? Give reasons for your answer, showing that you have thought about more than one point of view. Refer to religious arguments in your answer. (5 marks)
