(b)	To deal with any injuries and accidents (L1). To assess the nature of the injury and/or medical emergency to see if treatment is needed (L2). It is essential for large organisations with lots of visitors, such as a cinema, to have at least one appointed first aider on duty at all times. The appointed first aider is on call if anyone is injured or has a medical emergency. The first aider takes responsibility for checking the contents of the first aid box and for replacing any missing items. They will have undertaken a certified first aid course and are responsible for arranging training for others. The appointed first aider will make the decision to call an ambulance or for the help of other professionals.
