1. Explain the importance of price elasticity of demand and cross-elasticity of (a) [10 marks] demand for business decision-making. Studies have shown that the demand for tobacco tends to be highly price inelastic. (b) Evaluate the view that governments can best reduce smoking by substantially increasing taxes on cigarettes. [15 marks] 2. Explain why a country may wish to reduce its unemployment rate. [10 marks] (a) (b) Evaluate the likely effects on the economy of relying on demand-side policies to reduce the unemployment rate. [15 marks] 3. (a) There has been an increasing trend in different parts of the world for countries to engage in economic integration through the formation of trading blocs.
