1. Explain why an increase in incomes over time may lead to an increase in demand for (a) some goods but a decrease in demand for other goods. [10] (b) The income elasticity of demand for primary commodities tends to be relatively low, while the income elasticity of demand for manufactured goods and services tends to be higher. Examine the likely effects of this for individual producers and for the economy as a whole. [15] 2. Explain why demerit goods are an example of market failure. [10] (b) Evaluate the effectiveness of using indirect taxation to correct market failure. [15]
