# **General Marking Instructions**

# **Subject Details:** Physics HL Paper 3 Markscheme

#### **Mark Allocation**

Candidates are required to answer questions from **TWO** of the Options  $[2 \times 30 \text{ marks}]$ . Maximum total = [60 marks].

- 1. A markscheme often has more marking points than the total allows. This is intentional. Do **not** award more than the maximum marks allowed for part of a question.
- **2.** Each marking point has a separate line and the end is signified by means of a semicolon (;).
- **3.** An alternative answer or wording is indicated in the markscheme by a slash (/) either wording can be accepted.
- **4.** Words in brackets ( ) in the markscheme are not necessary to gain the mark.
- **5.** Words that are <u>underlined</u> are essential for the mark.
- **6.** The order of marking points does not have to be as in the markscheme, unless stated otherwise.
- 7. If the candidate's answer has the same "meaning" or can be clearly interpreted as being of equivalent significance, detail and validity as that in the markscheme then award the mark. Where this point is considered to be particularly relevant in a question it is emphasized by writing *OWTTE* (or words to that effect).
- **8.** Effective communication is more important than grammatical accuracy.
- 9. Occasionally, a part of a question may require an answer that is required for subsequent marking points. If an error is made in the first marking point then it should be penalized. However, if the incorrect answer is used correctly in subsequent marking points then follow through marks should be awarded.
- **10.** Only consider units at the end of a calculation. Unless directed otherwise in the mark scheme, unit errors should only be penalized once in the paper.
- 11. Significant digits should only be considered in the final answer. Deduct 1 mark in the paper for an error of 2 or more digits unless directed otherwise in the markscheme.

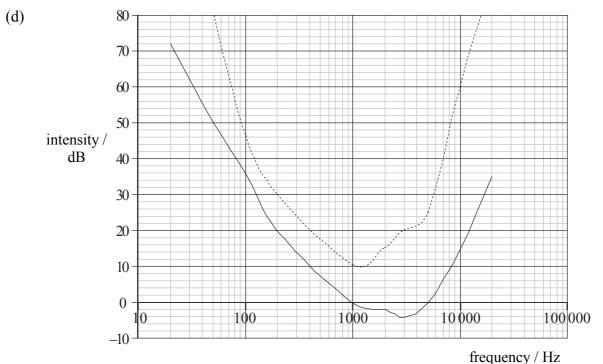

- **D2.** (a) (minimum) intensity (in W m<sup>-2</sup>) that can just be detected by the ear; [1]

  - (c)  $20 = 10 \lg \left(\frac{I}{I_0}\right);$   $\left(\frac{I}{I_0}\right) = 100;$ [2]



increased intensity at all frequencies; frequency range is reduced; overall shift as shown / larger difference in intensity for higher frequencies;

- (b) A-scan: one dimensional;
  - B-scan: two dimensional;
    Both needed to receive the mark.

- (c) advantage: good resolution / produces sharp image;

energy change =  $400 \times 700 \,\text{J}$  so possible;

Do not accept numbers only.

- (b) energy required to keep body organs running / basal metabolism; inefficiency of muscles; inefficiency of digestion / any further detail regarding BMR/muscles;
- **D5.** (a) the time it takes for half the sample to be eliminated from the body (by natural processes); [1]
  - (b)  $\frac{1}{T_{\text{eff}}} = \frac{1}{8} + \frac{1}{21}$  to give  $T_{\text{eff}} = 5.8$  days;  $\lambda_{\text{eff}} = \frac{0.69}{5.8} = 0.12$ ;

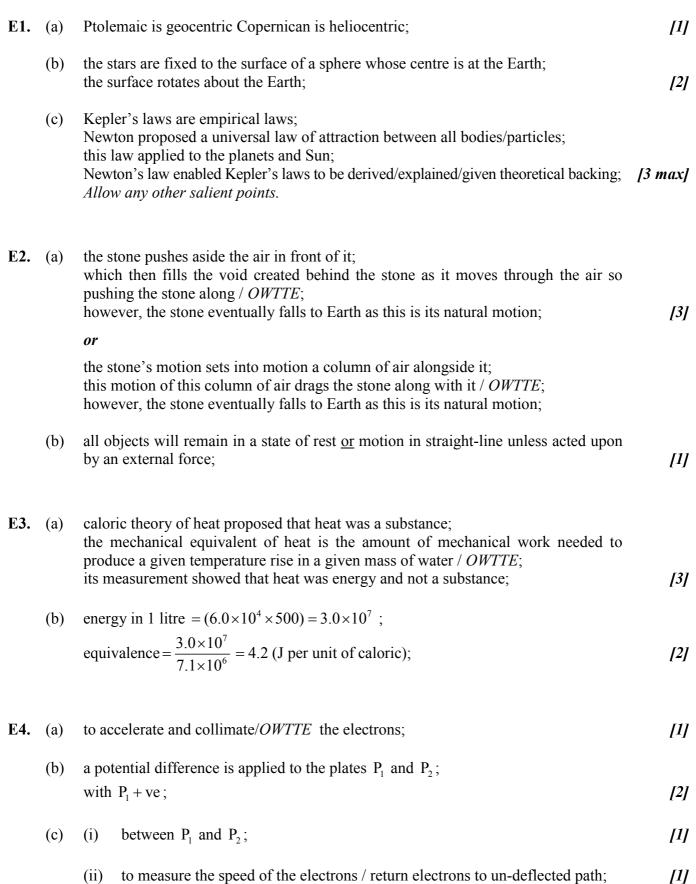
ratio of activities =  $e^{-\lambda t}$ ; substitute to get 0.24;

(c) the short radioactive half-life means that there is less risk of overall damage / ease of production / small sample size / *OWTTE*;

## Option E — The History and Development of Physics

- E5. (a) the angular momentum of the electron is an integral number of  $\frac{h}{2\pi}$ ;

  Accept use of h only.
  - (b) (i) *n* takes a fixed integer (and this defines the series) / *OWTTE*; integer values of *m* for *m*>*n* give the wavelengths of the lines in the series defined by *n* / *OWTTE*;
    - (ii) m and n (are integers that) specify the allowed values of angular momentum; and hence the allowed energy levels / OWTTE; determine the energy of the emitted/absorbed photon / OWTTE; [2 max]
       Allow up to [4 max] for answers that combine (b)(i) and (b)(ii).
  - (c) (i) as m increases, the lines become closer together / OWTTE; [1]
    - (ii) therefore  $R_{\rm H} = \frac{n^2}{\lambda}$ ;  $n = \sqrt{R_{\rm H}\lambda} = \sqrt{1.097 \times 10^7 \times 3.645 \times 10^{-7}} = 2$ ; [2]
  - (d) the minimum wavelength (in the spectrum) is determined by the ionization energy; the ionization energy is greater for helium so the minimum wavelength is shorter; [2]

difference between energy levels is greater; therefore similar transitions give rise to shorter wavelength;

### Option F — Astrophysics

**F1.** (a) *stellar cluster*: a group of stars (with gas and dust) held together by gravity/ forming a globular/open arrangement;

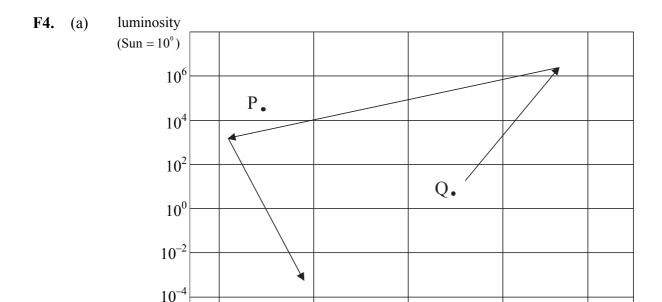
galaxy: a large-scale collection/large number of stars/star clusters, gas, and dust:

- (b)  $10^{-6}$ ; [1] Accept interval within  $10^{-5}$  and  $10^{-7}$ .
- **F2.** (a) apparent brightness: power incident per square metre of surface of Earth; apparent magnitude: a measure of how bright a star appears (to the eye) viewed from Earth; [2]
  - (b) measure the blackbody spectrum (of the star) / analysis of intensity-wavelength graph; to find the wavelength at which the emitted energy is a \[ \int \text{Accept statements in terms maximum;} \] \[ \text{of peak wavelength.} \]

use Wien's displacement law or  $\lambda_{\text{max}} = \frac{2.90 \times 10^{-3}}{T}$  to find temperature; [3]

- (c) (i)  $4.93 \times 10^5 \text{ AU} = 2.39 \text{ pc } or \text{ distance less than } 100 \text{ pc}$ ; (which is easily) measured by (stellar) parallax; [2]
  - (ii) lower temperature than the Sun and further away from the Sun; therefore <u>less bright</u> so apparent magnitude is greater; [2]
  - (iii)  $L = 4\pi d^2 b$ ;  $d = (4.93 \times 10^5 \times 1.50 \times 10^{11}) = 7.40 \times 10^{16} \text{ m}$ ;  $L = 4 \times 3.14 \times 7.40^2 \times 10^{32} \times 1.97 \times 10^{-12}$ ;  $= 1.35 \times 10^{23} \text{ W}$  [3] Carefully verify the correct use of numerical values to reach the answer.
- (d)  $A = \frac{L}{\sigma T^4}$ ;  $= \left(\frac{1.35 \times 10^{23}}{5.67 \times 10^{-8} \times (4.00 \times 10^3)^4}\right) = 9.30 \times 10^{15} \text{ m}^2;$ [2]
- **F3.** (a) that it is uniform / stars are uniformly distributed; *Accept also homogenous or isotropic.* [1]
  - (b) in every direction that one looked one would see a star; hence the sky should never be dark; [2] Accept reasoning based on intensity  $\propto r^{-2}$  but number  $\propto r^2$ .

  - (b) the universe is expanding; due to Doppler shift (observed) light is red shifted; Do not accept "galaxies are moving away from us". [2]
  - (c) the further away the greater the recessional speed of the galaxies / OWTTE; [1]

(ii) the closer to Earth the greater the degree of warping of spacetime / OWTTE; [1]

the ray is not transmitted / no light is transmitted but is totally reflected at the boundary / is totally internally reflected;

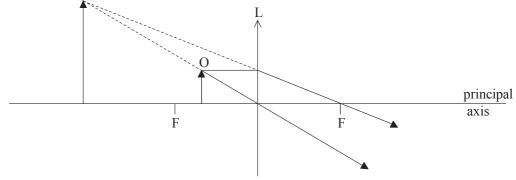
