(ii)	Zone drawn around <b>P/Q</b> ; Label clear zone; Zone around <b>P</b> larger than <b>Q</b> ; Measurement recorded; No zone around <b>R</b> ;	[max 4]	Check Supervisor's Report. If Report indicates otherwise – both equal accept.
(iii)	<i>Explanation:</i> – <b>R</b> no clear zone but <b>P</b> and <b>Q</b> do; Therefore enzyme must break down starch;  <b>P</b> must have more (concentrated) enzyme (as wider clear area); <b>Q</b> has less enzyme in the water to breakdown starch; to produce clear areas ; no enzyme – no breakdown of starch/water does not contain enzyme /AW;	[max 3]	Accept 'iodine changed since starch not broken down'.
