MARK SCHEME FOR the November 2002 question papers

0500 FIRST LANGUAGE ENGLISH

0500/1	Paper 1 (Reading and Writing), maximum raw mark 60
0500/2	Paper 2 (Reading and Writing), maximum raw mark 60
0500/3	Paper 3 (Continuous Writing), maximum raw mark 40

These mark schemes are published as an aid to teachers and students, to indicate the requirements of the examination. They show the basis on which Examiners were initially instructed to award marks. They do not indicate the details of the discussions that took place at an Examiners' meeting before marking began. Any substantial changes to the mark scheme that arose from these discussions will be recorded in the published *Report on the Examination*.

Dry bark/weather/conditions = 1

- Scuttling suggests **quickly/rapidly** = 1
- Reference to rustling noise = 1
- Mice suggests **all directions/everywhere** = 1
- Tentacles suggests **long/waving about**, hence hard to stop and likely to do more damage = 2 for a good explanation, 1 for a glimmer. [4 maximum]

Q9

Either something like **(over)confident/authoritative**: he sounds as if he knows what he is doing.

Arrogant/stubborn: the way he behaves to Paudeni

Rash/headstrong: starts fire without thought for consequences

Award 1 mark for any two of the above words and a further mark for an acceptable explanation of the word. If any other word is given award 2 marks if it is well justified, 1 mark if it is partly justified and 0 if the justification is unacceptable.

The following points are acceptable:

1. Fires spread **quickly/out of control**.
2. Dangers to people nearby.
3. Danger to houses/villages/property.
4. Destruction of trees/animals/.
5. (Threat to) ecology/environment/habitat.

Marks for written expression

G/1 Very weak expression OR virtually all copied. Hard to follow where original. Probably long.

F/2 Rambling and occasionally muddled; lifting is obtrusive, but can be followed. Possibly quite long.

E/3 Descriptive/discursive style, frequently unfocused. Lifting apparent but not serious (though suggesting some lack of understanding in places). May be a little long.

D/4 Occasional concision, tending to lose focus here and there (but evidence that the passage has been understood). Occasional lifting. Length not excessive.

C/5 Some features of a summary style (not consistent), reasonable focus on question and very rare lifting. Length not excessive.

Question 12

Write an information sheet encouraging tourists to visit Stockholm.

Give up to 10 marks for content (based on the passage) and 10 marks for a good, clear, informative and persuasive style and for the accuracy of the language.

Credit ability to:

- (a) use material in a different context (ie not in Bryson's style).**
- (b) Restructure material according to the headings**

Content/reading

G:1/2 Virtually no links with passage. Makes some attempt to write an information sheet. Much outside the scope of the original. Some failure to understand.

F: 3/4 A straightforward attempt to give accurate information about Stockholm, but using the material thinly and not always accurately.

E:5/6 Begins to use material from the passage appropriately and with a little success. Makes a simple attempt at the introduction.

D:7/8 Some competence in the use of the passage and the provision of an introduction. Not yet consistent, but adapts the material in the passage to the needs of an information sheet.

C:9/10 Uses plenty of material accurately and provides an interesting information sheet. Avoids presenting the material with the humour/cynicism (etc) of the original, but consistently adapts it to purpose.

Written expression

G:1/2 Semi-coherent, major errors, including failure to use normal grammar; uses simple English and handles it poorly.

F:3/4 Many minor errors but simple English is mostly clear. Style may be inappropriate with some lack of clarity in, for example, longer sentences.

E:5/6 Has minor errors although meaning is not in doubt. Some sense of appropriate style but generally simply expressed.

D:7/8 Some minor errors, but clearly expressed with a little fluency. Adopts some features of an appropriate style and writes differently from original. Suitable for publication with some tidying up.

C:9/10 Generally accurate and well worded. Has a good style for an information sheet/may affect a media style.

NB Answers which do not use the 4 paragraph format should be awarded a maximum of 8 marks for content.

Answers which fail to cover all 4 elements of the task should be awarded a maximum of 6 marks for content.

The ability to adopt an exhortatory tone is likely to be a distinguishing feature of answers which achieve the higher bands for content.
