8.	Your client, a British company, wishes to file a trade mark application in Peru. A notarised and legalised Power of Attorney is required. Explain what has to be done to the Power of Attorney in order for it to be acceptable to the Peruvian Trademarks Office.
9.	Section 3 of the Trade Marks Act 1994 sets out the absolute grounds on which a trade mark application may be refused. List five of these grounds.
10.	a) On which form is an application for registration of a U.K. design made?
	b) What is the official fee for a design application in the U.K. (which is not a lace or textile design)?
	c) What is the official fee for a lace or textile design application?
	d) What is the maximum number of different views included in a single Registered Community Design application that OHIM will grant protection for?
	e) What is the maximum period of protection available for a Registered Community Design?
11.	What are the key stages of the UK Opposition procedure up to the filing of a counterstatement? In your answer, identify those deadlines, if any, that can or cannot be extended, and any forms that need to be filed. Include in your answer any "cooling off" provisions that may exist.
