Mr. Kevin Dancey, Chief Executive Officer, CICA emphasized that the signing of MoU heralds a phase of new relationship between the members of the two countries. It will enable the respective member at either end, to take the membership of the other Institute. The membership of the local accounting body would provide larger professional avenues to members at respective end and would lead to a win-win situation for the members of both the accounting bodies.

The MoU entails coming together of the two Accounting bodies working in tandem with each other to provide a synergy. This agreement would facilitate mobility of members across the borders and further strengthen the ties between India and Canada.
