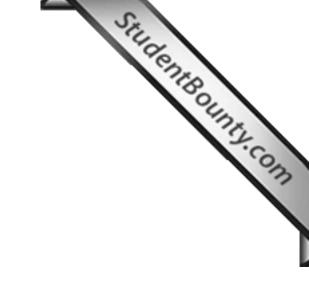

Scenario 1

StudentBounts.com Jack drives his car to the local park to exercise his dog. Whilst walking across the park he sees a small leather bag on the ground. He picks up the bag, opens the zip and inside the bag finds a leather hat. As it is a very cold day he puts the hat on and continues on his walk. Had he examined the bag closely he would have seen a name, address and phone number on the bag's label.

On his way back to the car park he takes off the leather hat and places it on a nearby bench. Next to the car park is a pedestrian bridge which crosses over a river. Jack knows that the river is deep and very fast flowing. Whilst reversing his car out of his parking bay he hits the steps to the pedestrian bridge. As a result of the collision the steps to the pedestrian bridge are knocked out of place and some of them are broken. Jack gets out of his car, pushes the steps back into place, but the steps are now unsecured and dangerous.

Shortly after Jack leaves the car park, Salma arrives in her car. She parks her car and walks towards the pedestrian bridge. She climbs the first few steps, the steps suddenly move and topple over and Salma falls into the river. Salma cannot swim, is swept away by the river and drowns.

Scenario 2

StudentBounty.com Ray, a short-tempered man, attends his football club's supporters' celebrate their recent promotion. The party is being hosted by the Support Club chairman, Jim. Ray has never liked Jim, particularly after Jim started date Ray's former girlfriend. Ray is also irritated at the sight of his colleagues laughing at Jim's jokes and telling Jim what a good party it is. To soothe his irritation, Ray spends the time in a corner watching a replay of the final game of the season, drinking a large amount of alcohol. At the end of the party people begin leaving. Jim tells Ray the party is finishing and it is time for him to leave but Jim does not wait for Ray to finish his drink. A heated argument breaks out between them. In anger, Ray picks up a beer mug and throws it at Jim. Jim sees the beer mug coming and moves out of the way to avoid it. The beer mug hits the wall and cracks as a result. Fortunately no one is injured as everyone, apart from Ray and Jim, has already left the premises.

The following morning Ray is called to Jim's office where he is told that as a result of his behaviour the night before, his membership of the Supporters' Club has been terminated and he is banned from the building. Ray tells Jim that he cannot terminate his membership. Jim replies, "I am the chairman, I can do what I like. Mind you, I understand how you feel, first losing your girlfriend and now being banned from the club." On hearing this last remark, Ray jumps to his feet and walks up and down the office trying to control his anger. Ray then stops and reaches across the desk, grabbing Jim by the shirt. With his other hand he punches Jim a number of times in the face, knocking him out. While Jim is unconscious on the floor Ray repeatedly kicks him in the head. Jim is taken to hospital and is in need of a blood transfusion. When Jim is resuscitated, he refuses to have a blood transfusion on the basis of his religious beliefs. Jim subsequently dies.

Scenario 3

Keely is determined to spoil the party. On the day of the party Keely goes to the village hall and sprays graffiti all over the doors and windows with soluble paint.

The party in the village hall starts and Keely duly arrives and says 'hello' to Gemma. After Keely has been at the party for about 20 minutes she sees a purse lying on the floor. Making sure no one is looking she picks up the purse and opens it. There is a £20 note inside but nothing else. The purse contains no form of identification, but she thinks it belongs to someone with whom she works and who is also at the party. She takes the £20 out of the purse puts it in her pocket and then throws the purse into a waste bin.

During the evening Keely notices that all the birthday presents that are brought for Gemma are being stored in the cloakroom. When she thinks no one is watching she enters the cloakroom with the intention of taking some of Gemma's presents. She searches through the presents to find one she can put in her pocket. When she finds one and is about to put it into her pocket Gemma's mother enters the room and asks her what she is doing. Keely tells her that she is just leaving a present for Gemma and puts the present that she has just picked up, on the pile of presents. Gemma's mother believes that Keely has brought the present.

Keely leaves the cloakroom taking, what she believes to be her coat, which in fact is a much more expensive coat than hers.
