

#### The deceased

Sonia died on 5 May 2011, born on 7 January 1949 she was aged 62. She lived at 33 The Lane, Oundle, MK44 5TY. Sonia was a widow, and had no children. Both her parents died some years ago.

#### Family

### Family

Victor has never married. He does however have one child, a son called David Treble who lives at 588 Long Road, Chiswick, W4 5GH. David is 43, married to Katherine and has one child, Rebecca, who is six months old.

Victor also has a brother, Morris, who lives nearby at 33 Chadwick Place, Bedford MK14 7TT with his wife. Morris has three grown up children, namely:

Harvey Treble (aged 39) of 8 Duck Lane, St Neots, PE19 5HH

Alice Hartland (aged 34) of Flat 7, Oswald House, Bedford, MK45 6TY

Thomas Treble (aged 29) of The Old Vicarage, Old Warden, MK23 4FP

### Financial
