

Scenario 1

StudentBounts.com Tim, a Kempston United football supporter, attends one of their away games at Bromham Rovers. Before the game he decides to have a few beers in a bar near the football ground.

He knew that the bar would be full of Bromham Rovers supporters and that there might be trouble if he was wearing his own club scarf. Tim goes to the Bromham Rovers Supports Club shop and picks up a Bromham Rovers scarf puts it round his neck and walks out of the shop without paying; he intends to put it back on the shelf after he has been to the bar.

In the bar Tim has a few beers. He sees a stand at the end of the bar displaying pre-packed sandwiches for sale. He walks over to the stand and is about to take a pack and put them in his pocket when he hears the barman shout at him, "they are all the same price mate". Tim walks away without the sandwich.

Before leaving the bar Tim goes to the toilet where he looks round to make sure nobody else is about and then takes a pen out of his pocket and writes on the wall in the toilet 'Kempston United rule OK'.

He leaves the bar and walks to the football ground and as he is passing the Bromham Rovers Supporters Club shop, he throws the scarf into the shop.

Scenario 2

Theo is a builder by trade. He is currently doing some repairs to Sha house.

StudentBounty.com One day whilst having a drink in a bar, after work, he is approached by Doug. Theo has known Doug for a long time and has in the past done some building work for him. He is aware that Doug has a criminal record for violence. Doug says that he knows Theo is working at Shantala's house and wants Theo to do something for him. Doug wants Theo to scratch the side of her car and to let some of the air out of one of the tyres of her car, so that it makes the car difficult to steer. He says the reason he wants this done is because Shantala has just divorced his brother Edward and it has cost Edward a lot of money and made him very unhappy.

Doug tells Theo that he looks after people who help him, but those who do not help him often have 'accidents' and get seriously hurt.

The next day, while Theo is working at Shantala's house, Theo lets some air out of one of the front tyres of Shantala's car. He also picks up a screwdriver and scrapes it down the side of the passenger door. This leaves a deep scratch on the paint. The screwdriver is in fact Shantala's, but Theo puts it in his pocket without thinking about it.

Later that day, Shantala drives to the shops and crashes into a tree due to the car steering sharply to the left. This was caused by the lack of air in one of the tyres. Luckily Shantala is unharmed but is a little shaken up by the accident.

On his way home Theo realises he has Shantala's screwdriver, takes it out of his pocket and throws it away on to waste ground.

Scenario 3

StudentBounty.com Adam owns a grocery shop that is licensed to sell alcohol. Bert is only I old and so is not legally allowed to buy alcohol. One day, Bert enters Ac shop and says he wants to buy a bottle of vodka. Adam says that he will not him the vodka unless he can prove he is over 18, as required by law. Bert tells him that he has left his proof of age at home but that he will give Adam an extra ± 10 for the bottle to save him having to go home and get his proof of age. Adam agrees and sells him the bottle of vodka and puts it in one of Adam's carrier bags, for him to take away.

Bert then phones his girlfriend Cathy and asks her over to his house to have some of the vodka. When she arrives, he pours Cathy a small glass of vodka and then guickly drinks the rest of the bottle and eventually falls into a chair in a drunken state. Cathy tries to wake him but he does not respond. She starts to dial for an ambulance but does not make the call as she thinks she might get into trouble for drinking alcohol under age. Cathy then returns to her own house.

During the night Bert dies from alcohol poisoning.

In the morning Bert is found by his father, David, who sees the empty bottle and the carrier bag from Adam's shop and realises what has happened.

After Bert's body has been taken away and the police and paramedics have left, David goes to Adam's shop, filled with rage. On entering the shop he sees Adam's wife Ethel and in an uncontrollable rage picks up a tin of baked beans and hurls it at her from a short distance away, aiming for her head. The tin hits Ethel with such force that it breaks her skull and she dies immediately.
