Attending Timothy James Brickhill of 42a Sunnyside, East Kempston, Bedford, MK42 7AB. Mr Brickhill was born on 3 June 1965 and is employed as a librarian by East Kempston County Council.

Mr Brickhill stated that he has separated from his wife, Gabriella Marie DuBois (born on 5 July 1980), and wishes to commence divorce proceedings against her.

Mr Brickhill explained that the parties met eighteen months ago through an internet dating agency. At the time, Gabriella lived in Bordeaux, France and their relationship initially blossomed through contact using a social networking website. A few weeks after their initial meeting over the internet, in June 2010, Gabriella arranged to visit Mr Brickhill in East Kempston. The weekend was such a success that Gabriella did not return to Bordeaux and moved in straightaway with Mr Brickhill. Three months later, Gabriella became pregnant and their daughter Jennifer was born on 15 July 2011. Mr Brickhill thought that marriage before the birth of his child was the 'right thing to do' and the parties married on 5 May 2011, in a small ceremony witnessed by his mother and a work colleague. Gabriella's family did not attend the wedding. Indeed, Gabriella had always been rather secretive about her family explaining that she had not seen her father since childhood and that she had a poor relationship with her mother. Gabriella is in regular contact with her sister, Claudette who lives in London, mainly by email. Mr Brickhill also has Claudette's home address.

When Jennifer was three months old, Gabriella started a job as a hotel receptionist working three days a week, so Jennifer was cared for by a nursery. Since Gabriella's left, Mr Brickhill has been able to negotiate a part-time position with the Council and looks after his daughter two days a week.

The relationship with Gabriella has been difficult for some time. During the marriage she insisted on smoking cigarettes in the house, despite Mr Brickhill urging her not to do so as he is asthmatic. On one occasion she purposefully put weed killer on his collection of rare plants which he had cultivated since he was a young boy. Gabriella complained that the plants received more attention than her! Mr Brickhill has found that Gabriella also had an on-line gambling account and has spent £2,000 in the last month, which has been charged to Mr Brickhill's credit card account.

Two weeks ago, Gabriella told Mr Brickhill that she was unhappy with the relationship and had formed a relationship with another person. Gabriella explained that she was returning to live in France and that she would return 'sometime in the future' to collect Jennifer. Gabriella did not give a forwarding address.

Please could you attend the above mentioned client today with regard to her application for ancillary relief. I would like you to draft the court documents ready for issue with the court. I am sure the client will have a lot of questions to ask you during the meeting about her case.

A summary of her circumstances is as follows:

Georgia Anne Johnson of 46 Manor Drive, East Kempston is married to Marcus Peter Johnson of the same address. They have one daughter, Edith, who is aged 14 years.

Georgia is a part-time interior designer and is 55 years old. Her husband is an architect and is 56 years old. The parties have been married for 25 years and Mr Johnson has issued divorce proceedings on the basis of her unreasonable behaviour. The parties continue to live in the matrimonial home, albeit separately and apart. It is agreed that when financial matters have been resolved, Edith will live with her mother.

Their financial history is as follows:

- 2. The matrimonial home (4 bedrooms) is valued at £400,000. The mortgage outstanding is £145,000 and the interest payments are £600 pm.
