Mr Wilberforce feels that Mr Bah is not coping at home on his own, despite Mrs Unwin's best efforts to look after him (she is apparently 71 and not in good health herself).

Mr Bah is 86, with a number of physical health problems most of which require medication. He is also concerned that Mr Bah is a little confused and does not seem able to deal with the forms and paperwork Mr Wilberforce needs to complete in order to organise the move to the residential care home. He asks whether we have an enduring power of attorney or lasting power of attorney for Mr Bah which gives someone else the power to deal with his money for him. He described him as "a little confused. Able to hold a conversation but tends to get muddled easily".

My Will

Thank you for sending to me my new will to sign. I think I have followed your instructions on how to sign more or less!

I asked Simon and his wife June to act as my witnesses. As two of my oldest friends I couldn't think of anyone better. I made sure both Simon and June watched me sign the will and I then watched while they both signed.
