

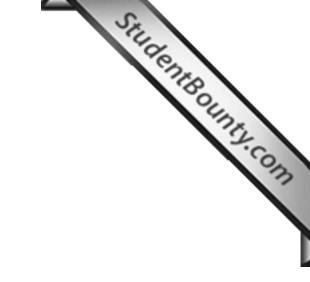

#### Scenario 1

StudentBounty.com Zoe and Alessandro met 15 years ago and began living together shortly afterwards. Their daughter, Giuliana, was born when they had been together for two years and is now 13 years old. The couple married eight years ago when Giuliana was five years old. Last year, Zoe and Alessandro divorced and, shortly after the divorce, Zoe gave birth to their second child, a son, Bruno, who is now eight months old.

Since the divorce, Giuliana has lived with Alessandro and Bruno lives with Zoe. The couple disagree about the children in many ways. The children do not see each other very much, as Guiliana does not have much contact with her mother. Although Giuliana is happy living with her father, when she spends time with her mother and brother, she returns to her father very upset because she misses them. As a result, Alessandro feels Giuliana should no longer see her mother, so that Giuliana can get on with her life.

Alessandro does wish to see Bruno. He also wishes for the children to spend more time together with him. Alessandro has told Zoe that, for this reason, he will apply to the court for Bruno to live with him and Giuliana, as he believes that the children should live together as brother and sister. Alessandro tells Zoe that Giuliana wants to live with her brother.

When Zoe asks Alessandro if Giuliana has said she wants to continue to live with him, he refuses to answer her. Zoe does not wish to upset Giuliana further by asking her directly.

Zoe would like both of the children to live with her, or to spend equal time between her and Alessandro as their homes are near to each other.

## Scenario 2

StudentBounty.com Cristina (aged 25) and Felix (aged 30) married four years ago. They have lived in many countries as Felix is a professional footballer. A year ago, Ch and Felix came to the UK, where Felix signed a contract with Kempston Unit Football Club. They had hoped to settle permanently in the UK and start a family but they do not have any children yet. The couple have not yet purchased their own property but instead rent a large house owned by the football club, which includes the provision of extensive security.

As a trained nurse, Cristina has personally nursed Felix through several football injuries and he has recovered well. Because the couple often travel and are the subject of intense publicity Cristina is unable to work as a nurse. Instead she has written several books on the treatment of sporting injuries, making a good career for herself and becoming guite wealthy in her own right.

Felix is the club's star player and since the couple have moved to Kempston they have been constantly followed by press photographers. Cristina has found the intrusion into their lives oppressive and has felt that she must face this alone as Felix is always training. When she raises the issue with Felix, he tells her it is part of his job and a small price to pay for such a large salary and the lifestyle they enjoy. He refuses to talk about it with her any further and becomes quite angry with her if she tries to discuss it. Cristina feels increasingly isolated and, worse still, the newspapers have recently printed a series of articles in which young women claim to have had sexual relationships with her husband.

Cristina has decided to divorce Felix and she seeks your advice.

Harmony is expecting Reuben's baby which is due to be born at any time now. Harmony has not been able to tell Reuben about the baby because of his refusal to contact her. Harmony plans to raise their child alone and she hopes that Reuben will never find out because she feels he would be unreliable and this would not be in their child's best interests. She tells you she is worried that Reuben will find out about their child and take action to try and see the baby.
