DOCUMENT 1

Case scenario – Hannah Morgan

SHIIdent BOUNTS, COM Hannah Morgan was arrested whilst spending a day with friends at Kempston Races, a popular event held every year in Kempston.

The investigating officer explained how the police station had received a phone call from Kempston Race Course at around 3.30pm. Complaints had been made by people, who had been attending the corporate hospitality section, saying money had been stolen out of their handbags and jackets that were left at the tables.

When the police arrived at the racecourse they spoke to a number of witnesses, including Frank Jones. It seems that Frank Jones and other witnesses had identified Hannah Morgan as the person who had allegedly stolen the money. The police questioned Hannah and arrested her on suspicion of theft after searching her and finding £2,000 in her handbag.

On 2 June I spent the day at the races with my company in the corporate hospitality section. Around lunch time we were all seated to be served our meal and a few drinks. There were about 30 tables of 10-12 people in the section and my table was on the opposite side of the room to where bets were placed. My colleague Neil and I had been enjoying ourselves, especially as we were sat next to a table full of women drinking lots of champagne. I had been watching one woman in particular (who I now know to be Hannah Morgan) who caught my eye as she wore a bright blue dress and high heels and I found her attractive. I thought I would have a few more glasses of champagne and was then going to ask her for her telephone number.

However, as the day progressed and people started to leave the tables to use the toilets or place bets on the horses, I noticed that Hannah never seemed to leave that side of the room to place any bets. I saw how her friends would go off to place bets on the horses and how she would always stay at the table drinking champagne. I could hear her tell her friends that she's not really into gambling. However, on a couple of occasions when her friends went to place their bets at the other side of the room, I watched Hannah walking round her own table where some of her friends had left their handbags. I also noticed her walking around other tables at that side of the room looking through the tickets and racing papers that had been left on those tables. I remember someone from another table coming back from placing his bets and asking her if he could help her. Hannah replied that she was looking for a spare racing newspaper so she could look at the betting odds for the next race as she had lost her newspaper.

Later on I overhead someone who had been sitting near me, complaining that money was missing from his wallet which he had left in his jacket at the table. When I heard this I realised that Hannah's behaviour had been suspicious and mentioned what I had seen to the hospitality manager. He said that complaints had been made about money going missing and that I should stay until the police arrived. The police came and I explained what I had witnessed. I was

Attending Hannah who confirmed as follows:

Hannah was at Kempston Races on 2 June with some of her friends. They were in the corporate hospitality section as one of her friends, Letitia, who owns her own beauty salon, decided to take some of her staff and invited Hannah along as a guest.

Letitia and most of her staff were betting on the horses. Hannah said she did not gamble and stayed at the table every time her friends went off to have a bet.

She was questioned by a police officer about missing money and initially denied any knowledge of it. After questioning Hannah for 10 minutes or so the police officer then said he had witnesses who had seen her acting suspiciously. The police officer then got his handcuffs out and grabbed her arms so she pulled away and her heel buckled as she stepped backwards.

The police officer then grabbed her right arm and twisted it so far back she fell to the ground, hitting her shoulder on the table as she fell. The police officer then put his knee on her back to handcuff her. She said she was in agony and kept telling him that she had taken the money and it was in her handbag.

She told him that if he stopped hurting her she would go down to the police station and admit to the theft of the money. He took her to the police van. In the back of the van he asked her to take off her shoes and tights because he thought she had hidden some of the money in the top of her tights. She did as she was told and no other money was found.

When she got to the police station she was told that the police wanted to take fingerprints but she was not happy about this.
