Attending in the cells of Kempston Magistrates' Court Robert Bird of 17 Manor Road West, Kempston born on 1 May 1969.

Robert Bird confirmed as follows:

Robert explained that he is married to June Bird and they have two children, Steven and Tracey, who are twins aged 13 years old. Robert is a self-employed builder. The past 18 months have been a financial struggle as a result of the downturn in the economy and the housing market. Financial pressures had put a strain on Robert's relationship with his wife and recently there have been more and more arguments.

Robert admitted that, as a result of spiralling financial worries and boredom, he had become increasingly dependent on alcohol.

However, last week Robert managed to get a week's work and with the money he earned he gave June enough to buy herself and the twins some new clothes. He decided that he would treat himself to a ticket to go and see the local football match between Kempston Rovers and Bromham Wanderers. Before leaving the house he drank half a bottle of whisky and went to the supporters' club where he had several beers.

The football game was very exciting but Bromham Wanderers scored the winning goal in the last minute, which upset Robert. As he left the ground he saw one of the Bromham Wanderers supporters who he knew to be Charley Slain, whom he suspected of having an affair with his wife, June.

Without thinking what he was doing he ran across the road and punched Charley in the face, causing his nose to split and blood pour from it. He also kicked Charley in the groin and ran off.

Robert then went to a bar and had a few more drinks. He was worried that Charley would report him to the police who would then come to his house and cause distress to June and the twins. Robert decided to go to the local police station and tell them what had happened.

SHIIDENIBOUNES.COM At the police station Robert was seen by PC J Parker who interviewed Robert was arrested and charged with ABH contrary to s47 Offences Against Person Act 1861.

After he was charged Robert refused to give his fingerprints until he had consulted a solicitor.

The police refused bail because they were concerned that Robert might try and find Charley and cause further injuries.

Robert regrets what he has done, realises he has been totally irresponsible and is genuinely sorry for his actions. He is further concerned that if the matter proceeds to a hearing the newspapers will report it. He is worried that if he is found guilty this could affect his ability to obtain work in the future.

I advised that I would get a copy of the custody record and taped interview to make a transcription for our purposes.

I was instructed to apply for bail at today's hearing.

Attending Abdul Hussain who was arrested over the weekend for criminal damage to the shop front window of Kempston West Newsagents.

Abdul Hussain asserts that the facts of the case are as follows:

He had been walking home after visiting a friend when for no reason two youths ran past him and pushed him against the glass window, which cracked. Abdul does admit that he knows the owner of the newsagents shop and that he owes him some money for an outstanding paper bill.

The police suggested to Abdul that he had caused the damage deliberately because he resented having to pay the paper bill.

He pointed out that there is CCTV installed in the area. The CCTV camera footage would clearly show that he was pushed and it was not a deliberate act of vandalism. Abdul was arrested shortly after the alarm bell at the newsagents had gone off and was taken to the police station for questioning.

He represented himself and made complete denials in interview. He was charged with criminal damage and granted police bail. Abdul's first court hearing is on 25 January which we agreed to attend and represent him.

It was explained to Abdul that we would need to apply for copies of the taped interview and a copy of the custody record to check that his rights had not been contravened. Additionally, we would apply for copies of the witness statements. We would also need to consider the question of the CCTV tapes and request copies from the prosecution.

Angharad Jones was arrested on suspicion of burglary from a private residence. The investigating officer explained that there had been a number of burglaries in the area where Angharad Jones had been stopped by officers. When Angharad saw the police car coming towards her she apparently started running in the opposite direction and was seen to throw an item over a garden fence. The front gardens of several nearby houses were searched and a wallet had been retrieved.

Upon attending Angharad in the police cells she confirmed as follows:

That she was born on the 23 January 1988, she is not married and has no children. She has a part-time job working in a bar and is living in a one bedroom rented flat at 23, Highfield Way, Kempston. Angharad admitted to being in the area and said she was visiting an old school friend. She denies running away from the police and says she was running for her bus. She categorically denies throwing away the wallet or having it in her possession at any time.

Angharad made full denials as described above. Her response to the burglary was put to her under caution and she confirmed her response, as detailed above.

Angharad was charged with burglary and police bail was refused.
