Question 1

Student Bounty Com Explain why you should not proceed with Simon's new will on the basis of the instructions contained in the letter from Katie.

(4 marks)

Given David's concerns about Simon's ability to understand his financial affairs, Mr Hooper has asked Simon's doctor, Dr Varkar, for her opinion on Simon's testamentary capacity.

To help Dr Varkar understand what is required when assessing Simon's capacity draft an explanatory note setting out the common law and statutory law relating to testamentary capacity.

(10 marks)

Having received a favourable report from Dr Varkar, Mr Hooper attended Simon on his own. Simon confirmed his instructions were indeed as set out in Katie's letter and asked Mr Hooper to proceed as soon as possible. Mr Hooper has asked you to help.

Draft the three clauses providing the gifts to David, David's children and Simon's cleaner Maud to be included in the will.

You do **not** need to draft the entire will.

(d) Now that Simon has approved his will, Mr Hooper would like you to attend him at his home to execute it, taking with you Laura (Mr Hooper's secretary) as your second witness.

To make sure you are prepared for this important meeting Mr Hooper suggests you prepare a checklist covering the way in which the will needs to be signed. Draft the checklist.
