

Violet and John had two children:

Cora Travers, who is 40, and lives at 101 High Road, Chiswick, London W4 3RG. She is unmarried and has no children. She is a head teacher at a large secondary school in Chiswick.

Family and personal circumstances

Dominik (who is 91) lives at 89 Stafford Terrace, Bedford MK40 7HH which is a house he owns. He lived there with his wife, Herta, until her death in 2001 when Dominik's sister, Elisa, moved in to look after him. Elisa is 79.

At that point Dominik was starting to lose his sight due to a degenerative condition. He is now completely blind. Although he is unable to see to read, he can still sign his name legibly. Dominik is reasonably fit for his age and in good health, although he admits to becoming a little forgetful at times.

Dominik and his wife had two children:

Freja, who is 63, lives in Kent with her husband, Gerrald. She has no children. She visits her father and aunt as often as she can.

Gregor, who is 59, lives in America. He has little contact with his father who does not even know whether he is married or has children.

Finances

Dominik's estate is worth around £650,000 and is made up of the value of 89 Stafford Terrace (which is worth around £195,000) and substantial savings with the Bedford Building Society.

He has not made any lifetime gifts in the last seven years. However, he is considering doing so now as he feels he has little need for his money and would prefer to see his daughter and a few of his favourite charities benefit.

Instructions

Dominik would like a new will along the following lines:

- Kempstons to be his executors.
- He wishes to be buried in the local cemetery alongside his wife, following a simple service at St Andrew's Church in Bedford.
- He would like to leave his collection of old cigarette cards to his daughter's husband, Gerrald.
- He would like to leave legacies of £5,000 to each of the National Association for Blind Children (registered charity number 46146) and Talking Books for All (registered charity number 545866).
- The remainder of his estate he wishes to leave to Elisa and Freja but is unsure in what proportions. We discussed this at some length and he will let me know in due course by telephone.
