Question 1

StudentBounty.com Giorgio runs a delivery business and has twenty vans. As Giorgio knows nothing about vehicle maintenance, he employs a full-time mechanic, Harry, who is responsible for the servicing and maintenance of the vans.

Recently Ivor, one of the delivery drivers employed by Giorgio, was driving one of the vans, when Janet carelessly pulled out into his path in her car. When Ivor tried to stop, the brakes on his van failed. He collided with Janet's car and was seriously injured. Ivor was not wearing a seatbelt at the time of the accident. A vehicle engineer's report showed that the brakes had never been serviced.

When Harry heard about the brake failure he suffered a nervous breakdown and can no longer work as a mechanic. Harry asserts that he had been overworked for a long period. He alleges that he had complained to Giorgio on a number of occasions that there were too many vans for him to maintain but Giorgio ignored his comments. Harry maintains that the stress has made him ill but he has tried to carry on until his nervous breakdown.

Advise Ivor and Harry of their possible claims in tort.

Question 2

StudentBounty.com Jenny owns Wilcombe Manor, a magnificent eighteenth century house village of Wilcombe, which is in an area designated by statute as being outstanding natural beauty. Victor, the owner of a field adjoining Wilcombe Manor, decided to hold car boot sales in the field on a Sunday twice a month. The sales have been a great success, Jenny, however, is furious. She claims that the peace of Sunday has been ruined by the noise and activity. She is no longer able to host lavish Sunday lunch parties as her dining room looks straight onto the field with the result that the visitors to the car boot sale could stare at her and her friends as they sit at the table.

The villagers of Wilcombe are also upset. The volume of traffic generated by the car boot sale means that the one street in the village is blocked for most of Sunday. A number of visitors' cars park on the grass verges outside the villagers' houses. One resident, Dennis, has frequently been unable to visit his grandchildren in the neighbouring village because of the cars parked in front of his drive.

One of the residents of Wilcombe, Moira, has decided, nevertheless, to take advantage of the success of the car boot sales. She has set up a Sausage and Burger Bar in a caravan, which is permanently parked just outside the entrance to the field. There is a cottage next to the entrance which has been rented by Nat so that his wife, Olive, could finish her latest novel in the peace and quiet of Wilcombe. Both Nat and Olive have complained about the noise and particularly the smell of frying onions from the burger bar.

Moira stores large drums of cooking oil outside the caravan, and one August day while she was out shopping, the sun's heat caused one of these large drums to burst. The oil trickled into a stream in Victor's field which flows into a lake in the grounds of Wilcombe Manor. The lake was badly affected by the oil. A greenish scum covered the surface. Jenny had recently stocked the lake with fish and they all died.

Discuss the possible claims that might be brought against Victor in a) nuisance.

Susie boarded up the window and swept up most of the glass. She arranged for a local glazier to repair the window the following afternoon. Unfortunately, Susie did not sweep up all the glass and the following lunchtime, Nick, a 12-year-old schoolbov, came to the shop at 13.00 in order to buy some sweets. He ignored the sign Susie had put on the door of her shop saying that no children were allowed into the shop between the hours of 12.00 and 14.00 on school days. Nick cut himself, very badly, on a large piece of glass that Susie had failed to remove.

Advise Ursula and Nick of any claims they may bring under the Occupiers' Liability Acts 1957 and 1984 and the potential defences that may be available.
