# **SECTION B** (Answer at least one question from this section)

# Question 1

SHIIDENT BOUNTY COM Alice Porter entered a formal civil partnership with her long term partner, Tracey Goldburn, five years ago. Alice, at the request of Tracey, gave up work when they entered into the civil partnership. Alice has a 13 year old daughter, Claire, and a 10 year old son, Peter, from her previous marriage.

The family home was purchased in the sole name of Tracey shortly before they entered into their civil partnership.

Tracey lost her job about six months ago and has been unable to find work since, which has led to Tracey drinking excessive amounts of alcohol on a daily basis, causing her to become irritable and aggressive. On other occasions she becomes withdrawn and completely ignores Alice and the children. She regularly shouts at the children for making a mess and tells them they are nothing to do with her. She is particularly critical of Alice in terms of her cooking and completing general household chores.

Three weeks ago when Alice took the children to the park, Tracey, who had been drinking, followed Alice there. She shouted verbal abuse at Alice and the children, and then grabbed Alice by her hair and dragged her home. The children were extremely upset and have been emotionally withdrawn since the incident. The verbal abuse and threats of violence have continued.

Alice could no longer cope with Tracey's behaviour and yesterday left the family home with the children. Whilst Alice was trying to leave the house, Tracey punched Alice in the face. The children were screaming. Peter tried to prevent the incident but was also punched by Tracey. Tracey told Alice "you can run but you cannot hide, I will find you."

Alice is currently staying in a womens' refuge with the children. Alice does not want to return to live at the family home. She wants to end her civil partnership to Tracey as soon as possible, and she wants protection from further abuse.

Advise Alice whether she can end her civil partnership to Tracey and gain protection from violence for herself and the children.

## **Question 2**

Amir, aged 31 years and Shakira, aged 20 years, met in 2011, having introduced by their respective parents at their homes in Manchester. parents insisted that they were suitable for each other, and a wedding warranged for July 2012. Despite being unhappy Shakira believed that she could not disobey her parents wishes and so went ahead with the wedding.

Amir and Shakira were married in July 2012 in Manchester, and moved into a local property. On the wedding night Shakira told Amir that it was a marriage in name only and refused to have sexual intercourse with him. Since that time Amir has made numerous attempts to make the relationship work, including trying to have a sexual relationship, but his efforts have been rejected by Shakira.

In August 2012, whilst driving home from work, Shakira was involved in a serious road traffic accident which left her with 70% burns all over her body, and severe facial disfigurement.

Amir, and his family have cared for Shakira since the accident, and Shakira has grown fond of Amir and wishes their marriage to work. Despite her horrific injuries, she is recovering well, and wishes to have a sexual relationship with Amir.

Amir, having been shocked by the extent of the accident and caring for his wife during recent months, is repulsed when he even looks at Shakira, and the thought of a sexual relationship with her horrifies him.

Amir now wishes to end his marriage to Shakira, as soon as possible, but does not want the stigma of a divorce.

Shakira has recently been told that Amir already has a wife, who he married four years ago when he lived in London.

### Explain:

(a) How the marriage can be ended without the stigma of divorce and any obstacles they may face.

(b) What the position would be if Amir was already married.

## **Question 3**

Peter and Maria have lived together as cohabitees for 7 years in the family

They have a child together, Sarah, who is 2 years of age. At the time that Sar was conceived the relationship had problems. This led to Maria having a brief sexual relationship with a work colleague, which Peter knew about.

Since having Sarah, the relationship has changed and Peter spends more and more time away from home, preferring to spend time with work colleagues. Maria juggles her time between working and childcare, with help from her parents.

Last week Peter announced that he no longer wanted a relationship with Maria, and that he wanted her to move out of the house as soon as possible. Maria now lives with her parents. Peter has stated that he will maintain Sarah. Peter wants regular contact with Sarah.

Maria is extremely upset by the breakdown of the relationship, and the manner in which she has been forced out of her home.

Maria told Peter he had no rights in respect of Sarah because he is not the father.

### Advise Peter:

(a) What action he can take to establish parentage and the potential difficulties he may face.

(b) If he is the father, how he can ensure he is involved in the important decisions affecting Sarah's upbringing.

## **Question 4**

James and Carl, aged 45 years and 40 years respectively, had lived toge 1 year before entering into their civil partnership on 15<sup>th</sup> June 2010. In Carl divorced his wife with whom he has two children, Elizabeth and Adam now aged 11 and 10 years respectively.

When they became civil partners, it was agreed that Carl would give up his career as a Vet to stay at home, tend to the house, gardens and domestic chores, and prepare for the adoption of children. Shortly after the civil partnership Carl's ex wife was killed in a car accident and the children went to live with him and James. James welcomed the idea of having a family. Carl now cares for the children on a day to day basis. Carl is financially dependent on James. James treats the children as his own, and maintains them financially. James continues to work as a Consultant Surgeon, earning in excess of £200,000 per annum. They have a lavish lifestyle.

Recently James and Carl have been arguing. James feels that Carl enjoys the fruits of his high income, but undertakes fewer and fewer household chores, employing other people to do the work whilst he socialises with friends. Carl resents this saying he works extremely hard keeping a nice home and caring for the children. James misses the single lifestyle.

James has started to spend more time at work and has fallen in love with a colleague Andrew. James has told Carl that he must find a job and support himself and the children or claim state benefits, as he will no longer support Carl and the children. James said he never wanted the children anyway.

Carl is devastated and thinks this is a phase James is going through and that in time their relationship will be fine. Carl is prepared to wait and see what happens, but is worried in the intervening period that he has no financial support.

Advise Carl of the likelihood of gaining immediate financial support for himself and the children from James, and the considerations that will be taken into account.
