#### **Grading of the Qualification**

- a. Learners must achieve a Pass grade in all technical skills and underpinning knowledge units to achieve the ITEC Level 2 Award in Apply Skin Tanning Techniques (see assessment table above)
- b. Internal task assessment and assignments are graded Pass or Refer
- c. If a Learner is unsuccessful in any area, they will be re-assessed only in the unit(s) where they were referred. The remainder of the Learner's results will stay in the ITEC system until all aspects of each unit have been allocated a Pass grade

### **Opportunities for Progression**

Once Learners have achieved the ITEC Level 2 Award in Apply Skin Tanning Techniques they may progress on to other ITEC or equivalent qualifications at Level 2 and 3, for example:
