In the beginning of the meeting, the Chairman, J&K State Board of School Education welcomed the Members for the first time after his taking over as the Chairman. The Secretary (BOSE) informed the members that since the meeting is taking place after a gap of 1½ years, therefore, a heavy agenda of about 553 Items is to be taken into consideration. After this brief introduction agenda for the meeting was taken up

**Item No.1** Confirmation of the minutes of the Recognition/Affiliation Committee Meeting held on 12.05.2007 and 13.05.2007 in the office chambers of the Chairman, Board of School Education, Rehari Colony, Jammu, may please be confirmed from S. No.01 to 138.

**Resolved** that the minutes be confirmed.

**Item No. 2 to 553** For Recognition/Affiliation/Up-gradation and Extension of High and Higher Secondary Schools both Government and Private.

Out of the deliberations during the meeting, it was **resolved** that following policy be adopted while considering the cases for grant of Recognition/Affiliation:

That the Schools as has been categorized on the basis of student strength and available infrastructure and facilities as per SRO-259 into the following four categories and grant Recognition/Affiliation for the period mentioned against each

| S.No. | Category | Period of Affiliation/Recognition |

| 1.    | 'A'      | 05 Years                          |
| 2.    | 'B'      | 04 Years                          |
| 3.    | 'C'      | 03 Years                          |
| 4.    | 'D'      | 02 Years                          |

The Recognition/Affiliation shall be granted with the following conditions:-

1. Periodical prescribed fee is to be deposited within ten days from issuance of this letter, in case same has not been deposited in the Board chest till date.
2. Deficiencies as has been pointed out by the Inspection Teams are to be removed within six months from the date of issuance of Recognition/Affiliation letter. A certificate to this effect be submitted by the Principal of the concerned Schools duly counter signed by the Chairman of the Society/Trust/Management.
3. Conditions as laid down under SRO-259 are to be met by the School within one year from the date of issuance of Recognition/Affiliation letter and certificate should also be submitted to the effect that all the conditions set in SRO-259 have been complied by the School.
4. The School should keep its premises as well as records available at any time for surprise inspection by the Board/School Education Department officials/Team.
5. In case above conditions are not met within stipulated time period, Board shall be at liberty to impose a fine up to the tune of Rs.50,000/- (Rupees Fifty



thousand) only or cancel the Recognition/Affiliation of the institution immediately or both.

It was further decided that the Recognition/Affiliation granted shall remain provisional till such time the SRO-259 is not followed in toto.

It was also resolved that all the Government Schools requiring Recognition/Affiliation/Up-gradation/Extension shall be granted permanent affiliation/recognition subject to the following conditions:-

- A) That all the deficiencies pointed out by the Inspection Teams be completed at the earliest by the Education Department.
- B) The prescribed Recognition/Affiliation fee shall be paid by the School concerned from time to time.
- C) The School shall be periodically inspected by the Board officials for maintaining the standards as laid down in various SROs issued by the Govt. and the guidelines framed by the BOSE. Any violation to these shall be reported to the Director and Secretary, School Education Department for necessary action.

It was further resolved that in case of Government Schools, no school be Upgraded/Recognized/Affiliated till a proper Govt. Order is issued.

As was pointed out that the deficiency reported by the Inspection teams is not known to the institutions till the time they get Affiliation/Recognition letter from the Board Office. A good time is lapsed in between. Henceforth, it was resolved that a transparent system be made and the Inspection Proforma duly framed on the basis of SROs/Guidelines issued by the Government/BOSE be signed by the Inspecting Teams as well as by the Principal/Chairman of the concerned institution as the case may be and a photocopy of the same be handed over to the institution concerned then and there only.

It was further resolved that Affiliation/Recognition be computerized and efforts be made for the online grant of Affiliation/Recognition.

It was further resolved that the institutions in whose favour provisional Recognition/Affiliation was granted for the Academic Session 2007-08 and 2008-09 due to procedural delays in conducting the Affiliation/Recognition meeting be regularized. The Recognition/Affiliation now granted in their favour shall start from the Academic Session 2009-10 onwards.

The Secretary (BOSE) informed that the Agenda has been divided into three parts viz.

- i) Main Agenda having 203 items;
- ii) Supplementary Agenda having 106 items;



- iii) 244 items Inspection reports received but not included in the Agenda and is being place as table item with the permission of the Chair.

After deliberations, it was decided to constitute a Sub Committee to look into the cases one by one and submit its report to the Chairman through Secretary (BOSE) for final decision. The Sub Committee, as such, has submitted its report on the basis of which following item-wise decisions has been made:

Resolved that newly upgraded High and Higher Secondary Schools be granted affiliation/recognition subject to the following conditions:-

- i) Deficiencies as pointed out by the Inspection Teams be removed within one year.
- ii) Fee, if not deposited shall be deposited in Board chest within 10 days from the issue of Recognition/Affiliation letter from the Board Office.


