T4 2010 – QUESTION

StudentBounty.com John Miller, a new client of your firm, and the owner of Priory Farm near Bridgwater in Somerset has recently written to you as follows:

"I refer to our telephone conversation last Thursday advising that I wish to register the following three marks -

PRIORY FARM FOODS (word mark)

for "butter, cheese, milk, cream, dairy products, strawberries (cooked and dried), yoghurt, honey, Christmas puddings, strawberries (fresh); and retail services connected with the sale of butter, cheese, milk, cream, dairy products, strawberries, yoghurt, honey and Christmas puddings";

IT JUST TASTE BUTTER! (word mark)

for "butter and dairy products"; and



for "butter, cheese, milk, strawberries (cooked and dried), yoghurt, honey, Christmas puddings. strawberries (fresh)".

As mentioned in our conversation, Priory Farm dates back to the 1920s and butter, cheese, milk, and cream have been produced and sold continuously from the farm by my family using the trade mark PRIORY FARM FOODS since at least 1950. It is only since the late 1980s that yoghurt, honey and strawberries have been produced and sold from the farm. The complete range of goods bearing the trade mark PRIORY FARM FOODS shown above has only been sold nationally through a supermarket chain since May 2006.

I only commenced using the slogan IT JUST TASTE BUTTER! for butter and dairy products in April 2009.

The Cow Device was adopted in May 2008 and has appeared on all products alongside the words PRIORY FARM FOODS since this date. However, I believe the Cow Device was designed by an agency in London in June 1991.

None of the marks have previously been used for Christmas puddings and we intend to start selling these in 2 weeks time.

Please carry out searches and let me have your advice as soon as possible."

You have carried out searches against the following marks, the results of which attached:

1. PRIORY FARM FOODS

StudentBounty.com Class 29 - Butter, cheese, milk, cream, dairy products, strawberries (cooked and dried), yoghurt;

Class 30 – Honey, Christmas puddings;

Class 31 - Strawberries (fresh); and

Class 35 - Retail services connected with the sale of butter, cheese, milk, cream, dairy products, strawberries, yoghurt, honey and Christmas puddings.

2. IT JUST TASTE BUTTER!

Class 29 – Butter and dairy products.

3. Cow Device (as shown above)

Class 29 – Butter, cheese, milk, strawberries (cooked and dried), yoghurt; Class 30 – Honey, Christmas puddings; and Class 31 - Strawberries (fresh).

Advise your client on the freedom to use and register the three trade marks for the goods specified in the client's letter, indicating any further information you require and the steps which may be taken to overcome potential difficulties.

A search of the Internet has revealed that Farmfoods Limited was incorporated in Scotland in 1954 and that the company's website states that "Farmfoods are frozen food specialists" and "Farmfoods originated in Aberdeen in 1955 and has around 300 shops throughout Great Britain".
