# **QUESTION 1 – TRANSLATION FROM TURKISH INTO ENGLISH**

This part of the paper is marked out of twenty-five.

- 20 negative marks, subject to usual deductions for errors and omissions
- 1 mark off for serious error or omission
- ½ mark off for minor error or omission
- up to 2 marks off for a phrase or part of a sentence which distorts the meaning of the message in the sentence
- up to 4 marks for spelling
- 5 positive marks for elegance/fluidity of expression

### **QUESTION 2 – TRANSLATION FROM ENGLISH INTO TURKISH**

This part of the paper is marked out of thirty.

Marks should be distributed in the following way:

correct decoding 7 7 correct encoding linguistic accuracy 8 cohesion/fluidity

# QUESTION 3 – SENTENCES TESTING GRAMMATICAL KNOWLEDGE

This part of the paper is normally marked out of fifteen.

There are normally five or six sentences which carry equal marks.

Deduct ½ mark for each minor error.

This part of the paper is marked out of thirty.

Marks should be distributed in the following way:

# **TURKISH 7646, CHIEF EXAMINER'S REPORT**

# Paper 1

### **General Comments**

There was no real change in the pattern of entry compared to last year's examination, in fact the number of candidates for both years was the same.

Similarly, there was no change in the quality/knowledge of this year's candidates in comparison to last year's. However, I was concerned about the quality of some of the candidates' handwriting.

The level of difficulty of this year's examination was very similar to last year's.

In general, most candidates performed a lot better on questions 2, 3 and 4 than they did on question 1, which was a translation from Turkish into English.

Many candidates also performed particularly well on the essay question.

## **Conclusions**

For future examinations I would advise candidates to read questions thoroughly and to follow instructions closely. I would also recommend that they improve the quality of their handwriting and check their grammar, especially when translating, to ensure that sentences make sense in the target language rather than translating literally from their native language.
