**Section A**

**1 Describe what is meant by Sociology?**

Sociology is the study of groups within society. Society/groups is made up of individuals and sociology looks at the way that our individual behaviours are influenced by the society that we live in.

Psychology is the study of the individual. Psychology is interested in how someone develops their sense of self – their picture of who they are. It looks at the way in which each human being develops their own special identity throughout their life.

**3 Give two reasons why knowledge of sociology is important for a care worker.**

As care workers, it is useful to know about the ways in which individuals are influenced, because it can help us understand:

- why we speak, act and behave in certain ways
- why we make certain choices and decisions
- why some people are more likely to experience problems in their life
- how we might challenge things that we think are unfair.

Candidates may be likely to discuss socialisation, behaviours and attitudes and any appropriate reference to this should be accepted.

To achieve full marks, candidates should give an example such as: taller, heavier, stronger, developing body hair, developing muscle, menstruation, voice changing.

**7 Mrs McCulloch is an older adult who is leaving her home and moving into residential care. Explain two emotional changes that this might lead to.**

- Loss of independence – eg because she is depending on other people.
- Fear and anxiety – new environment, new people, unfamiliar surroundings, worried that her family won't visit etc.
- Sense of security/insecurity – in a safe supportive environment, doesn't know how she will fit in, excitement at her new venture.

## Section B

Read the following case study and answer the questions that follow.

**Limetree House is a secure unit for young adults who have challenging behaviours. Myleene, the senior care worker on duty has been giving out medication to the residents. The emergency buzzer is sounded. She goes off to investigate, leaving some tablets lying on the dining room table. In her hurry to get to the emergency she trips over the corner of a rug and falls down the stairs.**

- 1 Give a definition of the term *hazard* and give one example from the case study.**

A hazard is something that could potentially cause harm or injury.

Examples from case study could be:

- Medication lying on the table.
- Rug.

- 2 Give a definition of the term *risk* and give one example from the case study.**

Risk can be defined as: the likelihood of potential harm from a particular hazard.

Examples

- A resident swallows the tablets.
- Senior care worker is injured as a result of her fall.

**As a result of the fall a first aider has been called to attend to Myleene. She is lying at the bottom of the stairs and although she is breathing she is unconscious.**

- 3 What four actions should the first aider take?**

- Make sure the area is safe.
- Assess the situation.
- Call for help.
- Do not move casualty in case there are any other injuries.
- Deal with onlookers.
- Remain calm.
- Check for any other injuries.

**6 State three responsibilities that an employer has in relation to Health and Safety.**

Answers could include:

- Report certain diseases, conditions and injuries.

- To have fire evacuation procedures.
- For control and maintenance of all equipment.
- Provide procedures for safe handling of hazardous chemicals.
- Provide safety equipment.
- Provide safe preparation of food and drink.
- Investigate any accident on the premises.
- Record and notify certain accidents and injuries.
- Consult the workforce regarding Health and Safety.
- To ensure visitors and others are safe and understand safety and evacuation procedures.
- Any other point included in Health and Safety Legislation.

## Section C

Read the following case study and answer the questions that follow.

Ross was released from prison two months ago. Upon his release he was ordered by the court to live in a resettlement unit. He is extremely unhappy about this as he had hoped to share a flat with his friend. He has been treated for substance misuse in the past and has recently discovered he is HIV positive.

Ross has managed to get a job in a shop. As the employees are leaving at night the manager stops Ross and checks his bag and pockets before he goes home.

- 1 From the case study give one example of a need and one example of a want.

**Need** – treatment for his HIV status/needs to be accepted/trusted.

**Want** – to share a flat with his friend/he wants the manager not to check his bag and pockets every night.

- 2 Give one example of an emotional need and one example of a cognitive need, which Ross has since leaving prison.

Emotional need

- He needs to feel supported.
- He needs to be able to express himself.
- He needs to be valued and respected.
- He needs a sense of belonging.

Cognitive need

- He needs to learn about HIV.
- Skills to live more independently.
- He needs to develop and sustain the skills to allow him to keep his job/employment.

Or any other appropriate answer.

- 3 Describe what is meant by the term *stereotyping*?

- Stereotypes are labels, which are applied to all members of a group.
- It is assumed that, because of some characteristic, the person is “just the same as all the others”.

- 4 State one example of discrimination from the case study and explain one possible effect this might have on Ross.

Example: He is being treated unfairly because of his offending, having his bag checked, having to live in the resettlement unit.

Effect: Lower self esteem  
Lower self worth  
Withdrawal  
Frustration and anger
