### PLEASE USE A SEPARATE ANSWER BOOK FOR EACH QUESTION

- 1. 'The political power of Dib's *L'Incendie* stems from its refusal to promote any simple political message.' Discuss.
- 2. 'The only way to read Dib's *Qui se souvient de la mer* is as an exercise in frustrating readers' expectations.' Discuss.
- 3. In what sense, if any, should Kateb Yacine's *Nedjma* be read as an allegory for Algeria's quest for a national identity?
- 4. Discuss the representation of French-Algerian relations in Kateb Yacine's Le Polygone étoilé.
- 5. In the preface to Le Blanc de l'Algérie, Djebar asserts: 'Je ne polémique pas'. Discuss the possible motives for such an assertion in this context and the extent to which the text bears out this assertion.
- 6. At the start of *La Femme sans sépulture*, Djebar makes two distinct claims: that the text is based on 'une approche documentaire'; and that in writing it, 'J'ai usé à volonté de ma liberté romanesque'. To what extent does it appear, according to your reading of the text, that these claims are compatible with one another?

- 11. Discuss the relations between literature, history and memory in TWO or MORE texts studied on this course.
- 12. 'Algerian novels repeatedly show that the idea of a single Algerian identity is inevitably simplistic.' Discuss this statement with reference to TWO or MORE texts studied on this course.
