
# HEBRC012: Northwest Semitic Inscriptions

Answer ALL five questions. All questions carry equal marks.

In each question, if there is a text, **transliterate** the text into SQUARE script, and then **translate** the text into clear English. When an idiomatic translation does not accurately reflect the text, place a more literal translation in square brackets following your idiomatic translation, thus: ... [lit. ...]. In addition to the transliteration and translation, be sure to answer all the supplementary parts of each question.

- 1b: To when is this text dated, and on what grounds (3 marks)?
- 1c: With which Biblical episode does this suggested date correspond? Discuss specific Biblical passages with which this text is possibly connected (3 marks).
- 1d: Discuss the form of the 3.m.s. possessive pronominal suffix, as attested in this inscription. How could it have developed into the form most commonly attested in the Hebrew Bible (3 marks)?

2b: From when is this inscription thought to date, and on what grounds is this date established (3 marks)?


2c: On the basis of this date, what is the historical context for the inscription? Discuss specific Biblical passages with which this text is possibly connected (3 marks).

- how the Northwest Semitic languages compare with other Semitic languages
- any alternative definitions for these languages (20 marks)
