INTRODUCTION TO INFORMATION TECHNOLOGY (MARKS 100) Module B (3 hours)

Section 'A' – 70 Marks (2 Hours)

- Q.1 Information Systems are divided into several classes based on the functions they are expected to perform. Each class serves different needs and types of users. Identify and briefly explain at least two classes of information system applications. (10)
- Q.2 Pakers Dairies (PD) is a large producer of standardized UHT milk with countrywide distribution chain. During the board meeting one of the directors was highly critical of the type of information being produced by the Management Information System (MIS) and the frequent delays in generating the reports.

As the head of the Strategic Planning Department of the company you are required to advise the MIS Manager on the following issues:

(a) Why does the senior management require information? Does the information provided by MIS suffice the senior management's needs or another type of information system will be required to fulfill their information requirements?

(b) What type of information is required by the middle management? How often do they need it?

- (c) What type of information is required by the junior management? Why do they need it?
- Q.3 List down eight basic tasks of an operating system. (08)
- Q.4 (a) Distinguish and differentiate between "Open Loop Systems" and "Closed Loop Systems". Give appropriate diagrams and examples. (10)
 - (b) What is meant by double loop feed back? How is it different from single loop feedback? (05)

- Q.5 Terminal is a device for entering data in a data communication system. What are the three types of terminals? Briefly explain the difference between the three. (06)
- Q.6 Registers are the special memory units. They are used to retain the information temporarily. List down the objectives of using registers. Discuss at least four registers commonly available in computers. (06)
- Q.7 Programming languages can be divided into two main categories, low level languages and high level languages. Identify the main differences between the two categories and give two examples of each. (10)
- Q.8 The Bookworm's Corner is a well known chain of bookstores. Its management is planning to expand the business by venturing into e-business. The management has decided to allow the use of credit card facility to its customers and is considering various techniques to safeguard against unauthorized use of this facility. You are required to describe the following techniques that may be used for the purpose:
 - (a) Encryption (03)
 - (b) Secure Electronic Transactions Protocol (03)

Section 'B' – 30 Marks (1 Hour)

- Q.9 A loan of Rs. 50,000 is repayable in 5 equal monthly instalments of Rs. 11,550 each. Mark-up rate per month is 5 %. Every instalment consists of two portions:
 - (i) mark-up portion, calculated on the principal outstanding at the beginning of the month; and
 - (ii) principal portion, calculated as difference of the instalment amount and the mark-up amount.

Principal outstanding after every instalment is calculated by subtracting the principal portion of the instalment from the principal outstanding at the beginning of the month.
